**HONORING IRENE FLEBBE, FORMER NATURALIST II AT TRAILSIDE MUSEUM OF
NATURAL HISTORY FOR 32 YEARS OF SERVICE**

WHEREAS, Irene Flebbe retired from public service to the Forest Preserves of Cook County (the “Forest Preserves”) on December 30, 2025, after a distinguished career as a naturalist and in nonformal environmental educator role, including thirty-two (32) years of service to the Forest Preserves of Cook County; and

WHEREAS, Mrs. Flebbe graduated from Northeastern Illinois University in 1993 with a bachelor’s degree in environmental studies and began her Forest Preserves career as a seasonal employee in December 1995 before moving into full-time naturalist roles; and

WHEREAS, for the past nineteen (19) years and nine (9) months, Mrs. Flebbe served as Naturalist II of the Trailside Museum of Natural History, the oldest nature education facility of the Forest Preserves of Cook County, succeeding previous Museum leadership and contributing to the Museum’s mission of connecting the public with local flora and fauna through education and engagement; and

WHEREAS, during her tenure as a naturalist, Mrs. Flebbe played a leading role in delivering and expanding public nature programs, guided hikes, and community events that brought nature education to visitors of all ages, from school groups to lifelong learners and surrounding suburban communities; and Mrs. Flebbe helped maintain the Museum’s historic Victorian mansion and interpretive exhibits that reflect more than ninety (90) years of the Forest Preserves’ commitment to environmental education; and

WHEREAS, under Mrs. Flebbe’s leadership and naturalist expertise, the Trailside Museum continued to offer hallmark community programming, including seasonal celebrations like the *Migrating Monarchs* event and volunteer restoration workdays that fostered stewardship of native habitats within the Forest Preserves; and

WHEREAS, Mrs. Flebbe consistently represented the Forest Preserves as a public voice for nature education, sharing her expertise with local partners and in community outreach about trails, nature resources, and environmental appreciation throughout Cook County and beyond; and

WHEREAS, the Trailside Museum of Natural History, established in 1931 as the first natural history museum of its kind in the Midwest and housed in a historic Victorian Italianate mansion, remains a beloved educational and cultural resource in River Forest thanks in great part to Mrs. Flebbe’s stewardship and long-tenured service;

WHEREAS, Jean M. Franczyk has led the Chicago Botanic Garden since 2016, with a keen awareness that individuals turn to the natural world for restoration and respite; and

WHEREAS, a native Chicagoan, Jean Franczyk spent her childhood gardening alongside her mother, planting an early seed for her interest in the natural world; and

WHEREAS, Jean Franczyk earned her bachelor's degree in journalism from the University of Illinois at Urbana-Champaign, followed by her master's degree in public policy from the University of Chicago Harris School of Public Policy; and

WHEREAS, Jean Franczyk worked as a part of the Mayor Richard M. Daley administration as well as the Chicago Board of Education as chief of staff; and

WHEREAS, Jean Franczyk joined the Garden after living in London for 11 years, where she was deputy director of the Science Museum with the United Kingdom's Science Museum Group (SMG); and

WHEREAS, Jean Franczyk holds a firm belief that connecting with nature leads to a happier, healthier life; and

WHEREAS, Jean Franczyk goes to the natural world for renewal and reflection, and believes that the Garden provides visitors a place to decompress and explore; and

WHEREAS, Jean Franczyk was key in the passage of the Forest Preserve District's 2022 referendum, noting how transformative the additional dollars would be for the health and wellness of the region; and

WHEREAS, Jean Franczyk remained dedicated to ensuring the Chicago Botanic Garden is a space of scientific exploration by expanding plant science conservation work; and

WHEREAS, during Jean Franczyk's tenure, the Chicago Botanic Garden celebrated their 50th anniversary "Flourish: The Garden at 50" where visitors were invited to connect with nature through interactive experiences within the Garden; and

WHEREAS, Jean Franczyk illuminated the Garden with the inception of *Lightscape*, an enchanting 1.3-mile trail of lights, sound, and imagination during the holiday season; and

WHEREAS, Jean Franczyk oversaw the completion of major projects that are now cornerstones of the Chicago Botanic Garden campus, including the Regenstein Learning Campus, the Welcome Plaza, and the Stone Family Picnic Glade; and

WHEREAS, Windy City Harvest, Chicago Botanic Garden's urban agricultural program, blossomed with Jean Franczyk's stewardship; and

WHEREAS, under Jean Franczyk's expert guidance, the Chicago Botanic Garden solidified its world-class reputation as one of the world's largest and most popular botanic gardens, hosting 1.2 million visits a year and fostering an atmosphere of belonging for all visitors.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby honor and celebrate Jean Franczyk upon her retirement for her decade of exceptional leadership and dedication to the Chicago Botanic Garden and its patrons; and

PROPOSED RESOLUTION

HONORING WOMEN IN THE FIELD OF CONSERVATION DURING WOMEN'S HISTORY MONTH

WHEREAS, National Women's History Month is a month-long celebration from March 1st through March 31st meant to honor and highlight the contributions of women throughout United States' past, present, and future; and

WHEREAS, women have made invaluable contributions to the fields of conservation, environmental justice, and science, propelling sustainability forward by leading their communities in advocacy for clean air, water, and land, protecting the natural habitats of animals, plants, and biodiverse ecosystems, and maintaining their historical status as stewards and environmental educators; and

WHEREAS, the Forest Preserves of Cook County has honored and celebrated Women's History Month through informational nature walks and newsletters which detail prominent women in conservation throughout history; and

WHEREAS, activist Hazel M Johnson, often referred to as the "Mother of Environmental Justice" from Altgeld Gardens on the far South Side of Chicago, founded People for Community Recovery in the 1970's to educate residents on how to fight against harmful toxic waste, and advocated for cleaner air and water for low-income communities of color on a global scale; and

WHEREAS, activist Marian Byrnes, after learning the natural prairie located behind her home in Jeffrey Manor, Chicago, was set to become a bus garage, led her community to save the land, and later advocated for the conservation of Lake Calumet, fighting against environmentally hazardous industrialization along the lakefront; and

WHEREAS, activist Kimberly Wasserman, director of Little Village Environmental Justice Organization, successfully led local residents in the closure of two power plants in Little Village, Chicago, in 2012, which caused disproportionately high rates of respiratory illnesses, and continues to advocate for the creation of green spaces in urban areas; and

WHEREAS, the Forest Preserves of Cook County counts on the support of various women restorationists, maintenance workers, educators and policy experts who work and volunteer for the Preserves. These women continue to champion the protection of natural resources and native species, and maintain the land for generations to come in a uniquely placed metropolitan area; and

WHEREAS, the Forest Preserves of Cook County acknowledges that we are on the lands of the Council of Three Fires-the Ojibwe, Odawa and Potawatomi-as well as the Miami, Peoria, Ho-Chunk, Menominee, Sauk and Meskwaki peoples, and the women of these communities have been and continue to be pillars of sustainability and stewardship; and

WHEREAS, there are countless other women in Cook County and beyond who have championed the fight towards a more sustainable environment for the health, safety, and enrichment of their families, communities, and natural lands all around us.

NOW, THEREFORE, BE IT RESOLVED, that Toni Preckwinkle, President of the Cook County Board, and the Board of Commissioners of the Forest Preserves of Cook County, honor National Women's History Month by celebrating the women of Cook County who have been leaders of environmental change, conservation, and sustainability...end

PROPOSED RESOLUTION

APPROVING EXTENSION OF THE TERM OF A COLLECTIVE BARGAINING AGREEMENT NEGOTIATED BETWEEN THE FOREST PRESERVES OF COOK COUNTY AND THE ILLINOIS FRATERNAL ORDER OF POLICE LABOR COUNCIL (SERGEANT UNIT)

WHEREAS, the Illinois Public Labor Relations Act (5 ILCS 315/1 et seq.) has established regulations regarding collective bargaining with a union; and

WHEREAS, a Collective Bargaining Agreement between the Forest Preserves of Cook County (the “Forest Preserves”) and the Illinois Fraternal Order of Police Labor Council (Sergeant Unit) is currently in effect for a term of January 1, 2021 through December 31, 2025 covering Sergeants in the Law Enforcement Department of the Forest Preserves (Board Item No. 24-0310); and

WHEREAS, the Forest Preserves and the Illinois Fraternal Order of Police Labor Council (Sergeant Unit) have negotiated an extension to the Collective Bargaining Agreement between the Forest Preserves of Cook County and the Illinois Fraternal Order of Police Labor Council (Sergeant Unit) through December 31, 2027.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby approves, with respect to such above-referenced Collective Bargaining Agreement, the proposed time extension, a one-time lump sum payment, salary adjustments and general wage increases, and procedural changes as follows:

- (a) Extension of the Collective Bargaining Agreement by and between the Forest Preserves of Cook County and the Illinois Fraternal Order of Police Labor Council (Sergeant Unit) for the period of January 1, 2026 to December 31, 2027;
- (b) Effective upon board approval of the extension, a one-time lump sum payment of \$2,500.00 will be paid on the payroll date closest to forty-five (45) days after board approval, to bargaining unit members in the classification of Sergeant in active status on December 31, 2025;

- (c) Effective the first full pay period on or after January 1, 2026, the pay rates for the classification of Sergeant shall be increased by 2%;
- (d) Effective the first full pay period on or after July 1, 2026, the pay rates for the classification of Sergeant shall be increased by 2%;
- (e) Effective the first full pay period on or after January 1, 2027, the pay rates for the classification of Sergeant shall be increased by 4%;
- (f) Procedural updates to the vacation bidding, shift bidding and notice provisions in accordance with the attached Tentative Agreement.

BE IT FURTHER RESOLVED, that the Illinois Fraternal Order of Police Labor Council (Sergeant Unit) members who retired from the Forest Preserves on or after January 1, 2026 are eligible for retroactive pay from January 1, 2026 for hours worked in the Sergeant position included in the extended Collective Bargaining Agreement, as negotiated between the Forest Preserves and Illinois Fraternal Order of Police Labor Council (Sergeant Unit).

BE IT FURTHER RESOLVED, that the Forest Preserves' Interim Director of Human Resources, Chief Financial Officer, and Comptroller are hereby authorized to implement the salary adjustments and general wage increases as negotiated and otherwise outlined above.

BE IT FURTHER RESOLVED, that the Forest Preserves' Comptroller is hereby directed to make all payments consistent with this resolution.

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”), as Licensors to grant a license to ComEd, Grantee, to locate, operate and maintain 1,806 feet of new 4” conduit and cable, directional bored within the 95th Street/Archer Avenue intersection right-of-way (ROW), in the vicinity of Red Gate Woods. PROPOSED LICENSE REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”), as Licensor to grant a License to ComEd, Grantee, to locate, operate and maintain approximately 482 feet of existing electric line overhead on newly installed power poles on the north side of Dundee Road in Palatine, to accommodate an Illinois Department of Transportation (“IDOT”) road improvement project. The road improvement project includes reconstruction of the road over a culvert and a new 8-foot-wide shared use path and retaining wall on the south side of Dundee Road within the existing road right of way (ROW). The proposed location of the overhead electric line would require removal of eight (8) trees, resulting in tree mitigation fees. In practice, more trees may need to be removed than originally estimated. Any increase in the tree mitigation fee will be in accordance with the Tree Mitigation Plan (see Board Item No. 20-0279), and if such increase is more than 20% of the original estimate, then approval will be sought from the Forest Preserves of Cook County Board of Commissioners.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”) to grant a permanent and a temporary easement to the Illinois Department of Transportation (“IDOT”) at Des Plaines River Road north of Foster Avenue in Schiller Park for 0.501 acres or 21,823 square feet.

Reason: IDOT is seeking to address safety and the potential collapse of the road into the Des Plaines River and improve pedestrian safety. The permanent easement is for construction and maintenance of a retaining wall, rip rap, a new sidewalk and other related improvements described in the plans and specifications. The temporary easement will be used for construction access. The work would require removal of sixteen (16) living trees and one (1) dead tree, resulting in tree mitigation fees. In practice, more trees may need to be removed than originally estimated. Any increase in the tree mitigation fee will be in accordance with the Tree Mitigation Plan (see Board Item No. 20-0279), and if such increase is more than 20% of the original estimate, then approval will be sought from the Forest Preserves of Cook County Board of Commissioners. Staff is recommending waiver of easement compensation in light of safety and environmental benefits of riverbank stabilization. IDOT has agreed to pay tree mitigation fees. The term of the temporary easement is five (5) years, or completion of construction, whichever comes first.

The area for the permanent easement is 0.298 acres, and the area for the temporary easement is 0.203 acres. IDOT indicates that seventeen (17) trees are expected to be removed for this project.

AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR SPRING LAKE

AN ORDINANCE CREATING A FOREST PRESERVE in part of Section 16, Township 42 North, Range 9, East of the Third Principal Meridian, all in Cook County, Illinois near Poplar Creek Land and Water Reserve in District 15.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the “District”), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands connecting such forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof; and

BE IT ORDAINED by the Board of Commissioners of the District as follows:

Section 1. That a unified Forest Preserve be and the same is hereby created within the District which shall contain and connect lands now owned and lands to be acquired in substantial accordance with the plat now on file in the office of the General Superintendent of the District, which by reference is hereby made a part hereof, and for the purposes of said Forest Preserve and for the carrying out of the statutory purposes more particularly set out in the preamble of this ordinance, it is necessary and desirable for the District to own and it shall acquire property hereinafter described in Section 2 of this ordinance, for the purpose of creating a Forest Preserve and for District uses.

The Property, commonly known as 324 Sutton Road # A, Barrington Hills, Cook County, Illinois consists of approximately 5.04 ± acres. The Property is an infill parcel directly adjacent to current holdings in an 1007-acre section of Spring Creek forest preserve and will expand habitat and provide a buffer from impacts from neighboring properties. The Property will be acquired with a reserved life estate.

The Property has remnant oak-hickory woodland. Protection of this parcel will keep habitat adjacent to 765-acre Schaumburg Road Grassland to the west.

Through negotiations, the Owner of Record (the “Seller”), has agreed to sell the Property to the Forest Preserves for the sum of FIVE MILLION SIX HUNDRED FIFTY THOUSAND DOLLARS AND 00/100 (\$5,650,000.00) plus closing costs up to \$10,000.00 (up to \$5,660,000.00 in total). PROPOSED RESOLUTION

AUTHORIZATION TO ACCEPT IDNR GRANT

WHEREAS, the Forest Preserves of Cook County (the “Forest Preserves”) applied for a Fiscal Year 2024 Land and Water Conservation Fund grant through the Illinois Department of Natural Resources (“IDNR”) requesting \$1,150,000 in federal funds to support the acquisition of three (3) properties totaling 25 acres at 338, 339 and 340 Old Sutton Road in Barrington Hills in northwest Cook County, Illinois; and WHEREAS, the Forest Preserves submitted its application in September 2023 along with a waiver of retroactivity, as the parcels were to be acquired before the anticipated 2025 grant announcement; and

WHEREAS, the Forest Preserves acquired the properties in 2024, as authorized by the Board of Commissioners on January 23, 2024, via Board Item Nos. 23-0596, 23-0598, and 23-0600 for a total approved not-to-exceed amount of \$2,293,500; and

WHEREAS, the addition of these properties buffer and expand the Spring Creek Forest Preserve, a forest preserve system with more than 45 miles of winding unpaved trails that are visited and enjoyed by thousands of people each year and that provide important habitat for countless pollinators, birds, and other wildlife; and

WHEREAS IDNR has notified the Forest Preserves its Land and Water Conservation Fund proposal has been approved and the Forest Preserves is eligible to receive reimbursement of up to \$1,150,000 in acquisition costs; and

WHEREAS, the Forest Preserves requests authorization to enter into a grant agreement with IDNR to accept the Land and Water Conservation Fund award and associated reimbursement; and

WHEREAS, IDNR is expected to provide the Forest Preserves with the necessary grant agreement and require its expedited execution within the month of March 2026; and

WHEREAS, the Forest Preserves' will use its best judgment to negotiate the terms and conditions of the grant agreement, subject to the General Superintendent's approval of the final agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby authorizes the President to execute the above-referenced grant agreement with IDNR to accept reimbursement of the above-referenced funds through the Land and Water Conservation Fund for the acquisitions totaling 25 acres.

BE IT FURTHER RESOLVED, that the Forest Preserves will report back to the Board of Commissioners by June 2026 regarding the terms and conditions of any such grant agreement if so executed.
