Public testimony must not exceed three minutes; the Secretary will keep track of the time and advise when the time for public testimony has expired. After each virtual speaker has completed their statement, they will be removed from the meeting. Written comments will not be read aloud at the meeting, but will be posted on the meeting page and made a part of the meeting record.
