**WHEREAS**, the Forest Preserves of Cook County manages nearly 70,000 acres of public land including some of the highest quality natural lands in the State of Illinois that provide residents and visitors opportunities for recreation, education, and pleasure; and

**WHEREAS**, the mission of Friends of the Forest Preserves is to be “the voice of a diverse community inspiring and organizing people to protect, restore, and expand the forest preserves in Cook County”; and

**RECOGNIZING MEMBERS OF THE FOREST PRESERVE DISTRICT OF COOK COUNTY DEPARTMENT OF LAW ENFORCEMENT FOR DEDICATION TO DUTY RELATED TO SEARCH AND RECOVERY EFFORTS IN MAY 2017**

**WHEREAS**, the Forest Preserve District of Cook County Department of Law Enforcement is dedicated to its mission of serving and protecting the residents of Cook County and visitors of the Forest Preserves' attractions and properties; and

**WHEREAS**, the sworn law enforcement officers of the Forest Preserves' Department of Law Enforcement enforce ordinances and laws of the Forest Preserves, Cook County, and the State of Illinois, develop good public relations; perform duties pertaining to the welfare of the public and the operation of the Forest Preserves; and maintain peace, order and quiet within the Forest Preserves; and

**WHEREAS**, on Saturday, May 13, 2017, members of the Forest Preserves' Department of Law Enforcement were the first to respond to a multijurisdictional dispatched call to Thatcher Woods regarding an individual entering the Des Plaines River from a railroad trestle and not resurfacing; and

**WHEREAS**, the Forest Preserves' Department of Law Enforcement immediately utilized all available personnel and resources to engage in an extensive search and recovery effort for the individual and were later joined by several other first responders from other law enforcement and rescue organizations; and

**WHEREAS**, dedicated members of the Forest Preserves Department of Law Enforcement worked cooperatively and tirelessly for days in the search and recovery mission including patrolling the river and using search canines in and around the Des Plaines River until, despite their diligent efforts, the search tragically ended on Thursday, May 18, 2017; and

**HONORING THE JOHN G. SHEDD AQUARIUM IN ITS PARTNERSHIP WITH THE FOREST PRESERVES OF COOK COUNTY**

**WHEREAS**, the John G. Shedd Aquarium is a world-renowned aquarium, research and conservation institution, and Chicagoland destination that partners and collaborates with the Forest Preserves of Cook County; and

**WHEREAS**, this partnership and collaboration reflects a commitment to improving the health of our local waters, our native flora and fauna and a recognition of the importance of actively engaging Cook County residents; and

**WHEREAS**, since 2010, Shedd Aquarium has partnered with the Forest Preserves to engage hundreds of local teens to learn and care about the Forest Preserves via stewardship and litter clean-up activities; and

**WHEREAS**, in 2015, the Shedd Aquarium partnership expanded with the creation of the "Amphibians" exhibit; where global and local amphibians and the Forest Preserves were highlighted, raising the profile of these important assets to Shedd visitors; and

**WHEREAS**, Shedd Aquarium created “Bringing Light to Amphibians”, a 5-minute video that celebrates local amphibians and the importance to steward and protect their habitats; the video has been viewed by audiences around the region; and

**WHEREAS**, Shedd Aquarium, as part of their “Great Lakes Action Days” initiative, has adopted three Forest Preserves’ sites intersecting three waterways: McClaughrey Springs Woods and Mill Creek Stream; Somme Woods and the North Branch of the Chicago River; and Bob Mann Woods and Salt Creek Stream; and

**WHEREAS**, Shedd Aquarium has made a significant effort and organizational investment to engage communities in stewardship along our local waterways by hosting stewardship volunteer days and engaging thousands of volunteers, who are contributing thousands of volunteer hours to the Forest Preserves on an annual basis; and

**WHEREAS**, Shedd Aquarium engages the public in stewardship practices including invasive species removal, seed collection and community science activities such as water quality monitoring and amphibian monitoring, which encourages learning and caring about our local natural resources; and

**WHEREAS**, Shedd Aquarium shares the Forest Preserves’ commitment to protect the integrity of the natural environment and wildlife from litter and pollution, and its “Shedd the Straw” campaign is a commendable effort to encourage businesses and government entities to commit to provide biodegradable straws upon request, discontinue use of plastic straws, and to promote sustainable benefits of reducing single-use plastic pollution.

**TO APPROVE AND ADOPT AMENDED EMPLOYEE TRAVEL POLICY**

**WHEREAS**, the Forest Preserve District of Cook County (the “Forest Preserves”) recognized the occasional need for employees to travel to various conferences, seminars, meetings, and other work related events; and

**WHEREAS**, the Forest Preserves created the Employee Travel Policy to provide guidelines on the following: (1) the types of official business for which travel, meal, and lodging expenses are allowed; and (2) maximum allowable reimbursement for travel, meal, and lodging expenses; and

**WHEREAS**, the Employee Travel Policy was approved by Forest Preserves Board of Commissioners on October 25, 2016; and

**WHEREAS**, the Forest Preserves now would like to amend such Employee Travel Policy to (1) establish pre-approval process for overnight travel; (2) to specify when travel to and from alternate work locations would be reimbursed; and (3) to otherwise clarify rules and bring consistency to the reimbursement process; and

**Summary:** The Forest Preserve District of Cook County (the “Forest Preserves”) operates and maintains the North Branch Bicycle Trail in Northern Cook County. The Village of Niles proposes to construct two trail segments, each approximately 300 linear feet in length, to connect residents and businesses to the trail as part of a larger bike and pedestrian improvement program.

The Village of Niles will be responsible for design, construction and future maintenance costs associated with the project. Minimal impact to trees on Forest Preserves land is anticipated, however, the Village of Niles will be responsible for submission of a tree survey and payment of tree mitigation fees for any impacted trees. The license fee, license application fee, and the YELAR fee will be waived, as is the typical practice for trail connection project requests from municipalities. There is no cost to the Forest Preserves.

Niles has funding for the design and construction of the trail segments. The IGA constitutes a license for Niles to construct and maintain the trail in perpetuity, subject to termination by the Forest Preserves after twenty (20) years. **Summary:** The Cook County Sheriff's Office has a program to train inmates and participants from the Vocational Rehabilitation Impact Center to provide deconstruction and building material salvage services. Upon completion of the program, each participant will receive basic carpentry and building material reuse training and an OSHA 10-hour safety certificate. The Forest Preserves of Cook County (the "Forest Preserves") seeks authorization to continue use of this program to remove unneeded buildings from recently acquired properties and on sites intended for redevelopment as needed.

Forest Preserve staff are seeking to extend an on-going partnership with the Cook County Sheriff's Office for a fifth year to continue deconstruction and demolition of additional vacant Forest Preserve buildings at various locations. Work in the first two (2) years focused primarily on removal of old campground cabins with an original amount of \$84,839.00. On June 7, 2016, the agreement was extended again to allow removal of buildings at other sites with an increase of \$100,000.00 (Agenda Item

16-0234) and was extended again on June 6, 2017 for time only (Agenda Item 17-0229). Three (3) non-camp buildings were removed in 2017 after asbestos removal and utility disconnections were completed by others. Remaining funds are expected to be sufficient to cover the costs for the removal of 4-5 additional buildings in 2019. This fourth renewal is to extend time for an additional year.
