WHEREAS, Homeland Security Presidential Directive (HSPD-5) establishes the National Incident Management System (NIMS); and

WHEREAS, NIMS establishes a single, comprehensive approach to domestic incident management to ensure all levels of government across the nation have the capability to work efficiently and effectively together using a national approach to domestic incident management; and

WHEREAS, NIMS provides a consistent nationwide approach for federal, state and local governments to work together to prepare for, respond to and recover from domestic incidents regardless of the cause, size or complexity; and

WHEREAS, NIMS provides the interoperability and compatibility among federal, state and local capabilities and includes a core set of concepts, principles, terminology and technologies covering the incident command system, unified command, training, management of resources and reporting; and

WHEREAS, HSPD-5 requires all federal departments and agencies to adopt the NIMS and use it in their individual domestic incident management and emergency prevention, preparedness, response, recovery and mitigation programs and activities, as well as in support of all actions taken to assist state and local entities; and

WHEREAS, HSPD-5 requires all federal departments and agencies to make adoption of the NIMS by state and local governments a requirement for providing federal preparedness assistance through grants, contracts or other activities to local governments; and

WHEREAS, NIMS mandated guidelines shall be incorporated into the County's Emergency Operations Plan.

NOW, THEREFORE, BE IT RESOLVED, by the President and Board of Commissioners of Cook County, Illinois that the County of Cook hereby adopts the National Incident Management System (NIMS) as its system of preparing for and responding to disaster incidents.
