When we hear young people who are part of the Conservation Corps share comments like those, we know the Forest Preserve Foundation's work changes lives. As we've gone about implementing our strategic plan over the last year, we remain ever committed to our core mission: expanding the programming that engages youth and families in the Forest Preserves of Cook County.

Understanding the role nature plays in the health of individuals and communities, in 2017 we provided a grant to fund the design and installation of nature-based sculptures at the Forest Preserve General Headquarters, Thatcher Woods Pavilion and Trailside Museum. Another grant supported a Conservation Corps crew that spent six weeks this summer doing conservation and restoration work in the Dan Ryan Woods. Your participation in the 6th Annual Conservation Cup allows us to be a vital philanthropic partner to the Forest Preserves. Since the Foundation started, we have invested more than \$750,000 into programs that broaden the Forest Preserves experience.

Program Grants Awarded in 2017

The **Forest Preserve Foundation** engages people with nature. Since 2012, the Foundation has granted over **\$750,000** in support of nature-based recreation and conservation in the Forest Preserves of Cook County.

Conservation Corps employs high school-age youth and young adults from underserved communities in hands-on stewardship projects throughout the preserves. Crews restore natural habitats by removing invasive plant species, improving trails, collecting field data, and providing outreach to communities. Participants cultivate critical job skills, learn plant identification and skills for native habitat restoration, and gain knowledge about potential careers in environmental fields.



Volunteer Recognition celebrates the spirit and impact that volunteers have on making the forest preserves healthy and vibrant. Volunteers are recognized for their service and the considerable time that they commit to enhancing the forest preserves.

I Love My Preserves is a program for residents who feel a special affinity for a specific preserve and want to help it continue to thrive. The Foundation helps direct gifts to benefit restoration, education and other initiatives at specific sites.

Memorial Tree and Bench Program offers residents the opportunity to honor a special person or occasion by planting a tree or installing a bench in the Forest Preserves of Cook County.

Public Art at Gateway Sites are unique art pieces that celebrate the role of the Preserves in the Oak Park/River Forest community. They are constructed of natural materials that will naturally decay over time to become part of the



landscape. The program encourages teen and community engagement in developing and building public art pieces that celebrate their connection with nature.

Nature Play connects young people to nature by offering elements of fun, discovery and adventure in a naturebased setting. Nature play sites were

installed in Dan Ryan Woods on Chicago's South Side and Camp Bullfrog in the Willow Springs area.

Bird the Preserves program connects diverse communities to the preserves through programs and activities that establish the Forest Preserves as premiere birding destination in the Chicago Wilderness region.
