Cronkhite Heavy Duty Equipment Trailers

The Fleet department is requesting a purchase order for a one-time purchase of fifteen (15) Cronkhite heavy duty equipment trailers to be assigned to the Department of Resource Management for land management operations.

Resource Management is requesting trailers with specialized ramps that only one manufacturer can produce this year. The specialized ramp will aid Resource Management field staff with the transportation of field equipment (such as track machines) to and from work sites. The ramps needed on the trailers have a specific width to accommodate our specialized machinery. Additionally, the hitch set up we are looking for along with the deck make-up, in particular the size and hauling capacity tilt deck, are not available at the specifications we are requesting from the other vendors.

The request is based on two specific reasons: customization and operational needs. Operational need is critical as the Resource Management trailer fleet is in need of partial replacement due to age and supplementation due to increased staffing. With the addition of 3 staff to the existing 5 resource crews and the additional newly added 6th resource crew in Thorn Creek we simply just need more trailers. Currently we are borrowing trailers across crews or in some instances dropping equipment with a trailer and then having to return to the yard to pick up another piece of equipment to go to the same work site. This lack of trailers is restricting our ability to split our crews up and work as two crews within one region – which was the intent when adding additional staffing to each crew. Significant impact on efficiency of work and a negative impact on our sustainability/emission goals.

The customization requests that we are looking for have all been agreed to by the Cronkite manufacturer. Other vendors that we spoke with could not meet the customization at all or provide a substitute that we determined was NOT sufficient. The only other manufacturer that could manufacture this trailer was Feilling Trailer who is backlogged 76 weeks. This makes Cronkhite the only manufacturer that can produce the specified trailer in a reasonable timeframe. Atlas Bobcat, LLC is the distributor for Cronkhite.

We respectfully request that we use Atlas Bobcat, LLC distributor of Cronkhite heavy duty trailer as a sole source vendor.
