PROPOSED RESOLUTION

IN SUPPORT OF AN ILLINOIS TRANSPORTATION ENHANCEMENT PROGRAM GRANT APPLICATION FOR BICYCLE AND PEDESTRIAN IMPROVEMENTS ON THE DES PLAINES RIVER TRAIL

WHEREAS, the Forest Preserves of Cook County (the "Forest Preserves") desires to submit a grant application to the Illinois Transportation Enhancement Program (ITEP) to request support for Phase 2 Engineering services for relocation, reconstruction and new pedestrian bridges on a 4.9-mile portion of the Des Plaines River Trail from Irving Park Road to Fullerton Road, also known as Segments 5 and 6 (the "Project"); and

WHEREAS, the Project would advance goals set forth in the Forest Preserves' Trail Master Plan and Next Century Conservation Plan to improve access to outdoor recreation opportunities and would significantly improve 4.9 miles of this regional trail system; and

WHEREAS, the Des Plaines River Trail reconstruction is a current project that involves multiple partners and municipalities including the Village of Franklin Park and Village of River Grove; and

WHEREAS, this ITEP Grant would fund 80% of eligible Phase 2 Design Engineering costs of the Project with the remaining ineligible costs to be paid for with local Forest Preserves funds; and

WHEREAS, should the Forest Preserves be awarded this ITEP grant for the Project on Segments 5 and 6 of the Des Plaines River Trail, the Forest Preserves would request authorization from the Forest Preserves of Cook County Board of Commissioners to accept the funds and execute an agreement for the ITEP grant funds.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners authorizes the Forest Preserves of Cook County to apply for this ITEP grant and commit to paying the local match (up to 20% of total Project costs), estimated to be \$583,525.00, to complete the Phase 2 Design Engineering services and for all ineligible costs associated with the Project.

PROPOSED RESOLUTION

RESOLUTION TO ACCEPT ADDITIONAL GRANT FUNDS

WHEREAS, on 1/26/2021, the Forest Preserve District of Cook County Board of Commissioners approved the acceptance of \$750,000.00 in grant funding from the Illinois Department of Natural Resources (IDNR) Museum Capital Grant program (Board Item No. 21-0101) to improve the Crabtree Nature Center in Barrington Hills; and

WHEREAS, the Forest Preserve District of Cook County's ("Forest Preserves") Department of Planning and Development successfully completed this grant project in 2023, improving the nature center's accessibility and energy efficiency and updating its exhibits and signage; and

WHEREAS, due to various factors including supply chain issues during and following the COVID-19 pandemic, the actual project construction cost was significantly higher than the estimated total project cost of \$1,000,000.00 at the time of the original IDNR Museum grant award; and

WHEREAS, the IDNR consequently intends to award the Forest Preserves an additional \$300,000.00 towards this grant project's expenses at no cost to the Forest Preserves, increasing the original grant award from \$750,000.00 to \$1,050,000.00.

NOW, THEREFORE, BE IT RESOLVED that the Forest Preserves of Cook County Board of Commissioners hereby authorizes the Forest Preserves' General Superintendent or their designee to accept any additional grant funds from IDNR towards the grant-funded renovation project of the Crabtree Nature Center located in Barrington Hills.

Summary: The Forest Preserves is working with several municipalities to improve ten (10) miles of the Des Plaines River Trail from North Avenue to Touhy Avenue. River Grove is anticipated to be sub-awarded American Rescue Plan Act ("ARPA") funds from the Cook County Department of Transportation and Highways ("DOTH") in the amount of \$750,000.00 to cover a portion of Phase II Engineering costs for the mainline trail segment within River Grove (Fullerton Avenue to North Avenue), including two (2) connections, one to Strieby Drive and a second to Evans Field, all in accordance with the related Phase I Study. River Grove advised the Forest Preserves that it needs support to pay costs in excess of ARPA funding to engineer the mainline and two (2) connecting trail spurs.

As the local sponsor under the proposed Intergovernmental Agreement, River Grove would be responsible for contracting for the completion of the Phase II engineering work with an estimated total cost of \$1,423,000.00. DOTH is anticipated to reimburse River Grove up to a maximum of \$750,000.00 via the ARPA grant funds, whereas the Forest Preserves would then reimburse River Grove for the remaining

costs. The Forest Preserves is hereby seeking authority to provide the remaining engineering costs not to exceed a total of \$957,600.00 (\$673,000.00 in matching funds + a 20% contingency estimated at \$284,600.00).

Phase II design work is expected to be completed by the winter of 2026. Final agreement is subject to legal review and approval.

Vendor: Indigo Sports, LLC (formerly Billy Casper Golf), a wholly owned subsidiary of Troon Golf, LLC, Scottsdale, Arizona

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into an agreement

Reason: The Forest Preserves sought proposals through a Request for Proposals ("RFP") process for the management of its ten (10) golf courses and four (4) driving ranges. Indigo Sports, LLC was selected out of four (4) total respondents due to their offer being the most lucrative and sustainable for the longevity of the Forest Preserves' golf portfolio. The Forest Preserves also partnered with a golf consultant to assist in developing the RFP as well as evaluating potential golf course management providers (See Board Item No. 24-0168). Indigo Sports, LLC (known previously as "Billy Casper Golf"), which has managed the Forest Preserves' golf courses since 2003, presented the strongest financial package and management plan for the upcoming term. Purchase Order #74000014226, is added for tracking purposes.

Contract Period: 1/1/2025 - 12/31/2034 with one (1) optional extension for an additional ten (10) years.

Estimated Fiscal Impact: N/A (revenue generating as provided below)

The Forest Preserves will receive the following revenue: a Minimum Annual Fee for the golf courses of \$700,000.00 for Years 1-5 and \$1,400,000.00 for Years 6-10 and the Extension Term, *or* the total gross revenue percentages identified below, whichever is greater.

- A. Gross Golf Revenues
 - i. Years 1-5: Five Percent (5%)
 - ii. Years 6-10: Ten Percent (10%)
- B. Food & Non-Alcoholic Beverages Revenues

The purchase of these EV Chargers will help the Forest Preserves reduce Green House Gas (GHG) emissions by enabling the use of Electric Vehicles in the Forest Preserves' Fleet. The nineteen (19) EV Chargers will have dual heads and allow a total of thirty-eight (38) fleet vehicles to be charged overnight. The Forest Preserves intends to install these units in house with IBEW Local 134 electricians. The ChargePoint units were chosen from a pool of six (6) EV Charger companies. ChargePoint has a large market share presence, longevity, offered a dual head charger, has an access system similar to the existing fuel management system for charger use management, and is also being utilized by Cook County in their EV Charger program.

AQL developed the Legal Request Dashboard to handle a variety of requests via automated flows to create a central intake system, reduce duplication, email stakeholders, create/move folders, upload documents, approve/reject requests, etc. The process incorporates numerous inter-departmental communications automatically exchanged via SharePoint. It streamlines the current processes making the Forest Preserves more efficient and effective. The initial beta testing revealed various technical issues to resolve for the Dashboard to have optimal efficiency. Thus, the Forest Preserves seeks to extend and increase the contract to address these outstanding issues in order to improve the Dashboard's overall effectiveness.

Summary: In 2017, the Forest Preserves entered into an agreement with Chicago River Canoe & Kayak (CRCK) to manage the Maple Lake Boathouse. This agreement included a provision for CRCK to cover a certain percentage of utility costs. However, a review by the Forest Preserves' Finance, Facilities and Permits Departments revealed that CRCK was also paying for utilities in areas not directly managed by them, such as restrooms and parking lot lighting.

Due to this oversight, this contract amendment would require CRCK to reimburse the Forest Preserves for 70% of the utility costs incurred during the boathouse season, instead of the originally agreed upon 100%. Accordingly, and to support the sustainability of this concession, the Forest Preserves also seeks authorization to waive 30% of the utility fees for the 2024 season under this amendment. Using 2023 utilities data, the Forest Preserves estimates that CRCK will reduce their utility payment to the Forest Preserves by approximately \$758 annually. With this accommodation, CRCK continues to pay the Forest Preserves per its contracted terms under this agreement and other boat concession agreements with the Forest Preserves.
