WHEREAS, on January 17, 2024, Cathy Geraghty, Raquel Garcia-Alvarez and Xochitl Lopez, and the Forest Preserves of Cook County's Youth Outdoor Ambassador Program were all honored with a Chicago Wilderness George B. Rabb Force of Nature Award during a ceremony held at the Morton Arboretum in Lisle, Illinois; and

WHEREAS, the George B. Rabb Force of Nature Awards recognize individuals and organizations whose conservation, restoration, advocacy or educational activities in the region are inspirational examples for others; and

WHEREAS, Cathy Geraghty, Director of Strategic Initiatives for the Forest Preserves, was recognized

as one of the region's most ardent champions of biodiversity, dedicating her professional career and her free time to protecting nature; and

WHEREAS, she has led many successful initiatives, including the Next Century Conservation Plan and the Centennial Campaign Plan and is a founding member of the Chicago Wilderness Alliance, where she has contributed to building an extensive and welcoming network of people who share expertise and resources to improve the environment for people and nature; and

WHEREAS, Raquel Garcia-Alvarez and Xochitl Lopez, volunteer site stewards with the Forest Preserves, were recognized for leading and engaging Latinx communities in conservation at Possum Hollow Woods since 2017; and

WHEREAS, Xochitl and Raquel's leadership and expertise effectively center Latinx and BIPOC communities, building a culture that includes both Spanish and English speakers, welcoming intergenerational families and creating connections for generations to come; and

WHEREAS, the Forest Preserves' Youth Outdoor Ambassador Program was recognized for its efforts to engage young people to serve as "ambassadors" to the Forest Preserves and identify how their peers can become lifelong advocates for nature; and

WHEREAS, the Youth Outdoor Ambassador Program serves as an excellent model for other organizations on how to genuinely engage young people in influencing and improving programming and communication strategies, ensuring that nature thrives and that people of all ages feel connected with their public land agencies.

## PROPOSED ORDINANCE

## AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR SWEET WOODS

AN ORDINANCE CREATING A FOREST PRESERVE in part of Section 23, Township 35 North, Range 14, East of the Third Principal Meridian, all in Cook County, Illinois near Sweet Woods in District 5.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the "District"), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof; and

## **BE IT ORDAINED** by the Board of Commissioners of the District as follows:

Section 1. That a unified Forest Preserve be and the same is hereby created within the District which shall contain and connect lands now owned and lands to be acquired in substantial accordance with the plat now on file in the office of the General Superintendent of the District, which by reference is hereby made a part hereof, and for the purposes of said Forest Preserve and for the carrying out of the statutory purposes more particularly set out in the preamble of this ordinance, it is necessary and desirable for the District to own and it shall acquire property hereinafter described in Section 2 of this ordinance, for the purpose of creating a Forest Preserve and for District uses.

Section 2. That the lands referred to in Section 1 of this ordinance are more particularly described as follows:

This ordinance is hereby made and ordained to be severable as to each parcel of land or portion thereof or right of interest in any of the same hereby authorized to be acquired, and failure to acquire any of the said parcels of land described in Section 2 hereof or right of interest in any of the same shall not impair or invalidate the authority by this ordinance granted to hold, own, or acquire any other of said parcels or any right or interest therein, it being the intention of said Board of Commissioners of the District to carry out the general plan provided in this ordinance so far as legally and financially practicable, and to negotiate for purchase, condemn, or otherwise acquire from time to time the several parcels of land described in Section 2 hereof and all right or interest therein.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval.

WHEREAS, in 2020, the Forest Preserves of Cook County ("Forest Preserves") issued a Request for Proposals and retained Hillard Heintze to analyze the Forest Preserves' Law Enforcement Department (i.e., "Police Department" or "Department") and recommend best practices to: (a) maintain and strengthen police and community relations, (b) create a work culture that is inclusive and equitable to all people, and (c) support a diverse police force through recruitment, retention and promotion; and

WHEREAS, the final report of the independent analysis of the Department from Hillard Heintze was presented to the Committee on Law Enforcement (the "Committee") on September 21, 2021, and such report recommended best practices and includes a work plan, timetable, and cost estimates for implementing the best practices, as well as tools to measure progress toward those goals; and

WHEREAS, the report outlined 21 recommendations needed to improve recruitment and retention, update policies and procedures, improve communication across ranks, and enhance police and community relations; and

WHEREAS, one of the key findings is that the Department has a ready, willing and able workforce capable of helping transform the Department into a model police force; however, although those employees interviewed as part of the report were willing to help improve the Department internally, as well as its external relationships, many were concerned that change would not happen once the

assessment concluded, and indicated that they have seen previous efforts to assess the Department or effectuate change, that were curtailed or failed to result in meaningful changes; and

WHEREAS, to ensure that the report recommendations are adhered to, and that the Forest Preserves continues to recognize the importance of establishing an aggressive timeline to implement said recommendations and to report back to the Board on progress being made towards achieving said recommendations the Board passed Resolution 21-0474, requesting the Forest Preserves to outline and deliver a detailed timeline for all elements needed to achieve the goal of a Model Forest Preserve Police Department as recommended in the *Independent Analysis of the Forest Preserves of Cook County Police Department* and that the General Superintendent and the Chief of the Department update the Board via the Committee on progress being made towards achieving such goal on a quarterly basis beginning with the first quarter of the 2022 fiscal year; and

#### PROPOSED PARTNERSHIP AGREEMENT

**Request:** Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into a Partnership Agreement with the Chicago Horticultural Society, Glencoe, Illinois.

Reason: The Forest Preserves and the Chicago Horticultural Society, which operates the Chicago Botanic Garden (the "Garden"), seek to partner for cooperative land management at Turnbull Woods, and to utilize the Garden's unique expertise in plant propagation to assist with the launch of the Forest Preserves' in-house seed amplification program. The Garden is a recognized global leader at the forefront of research on floristic genetics and species diversity for landscape restoration efforts throughout the Upper Midwest. Through this partnership, the Garden would recruit, hire, and train a plant Nursery Manager and a Nursery Technician to support restoration on Forest Preserves properties through the development of seed beds, greenhouse infrastructure, collection and propagation of seed, etc. The Garden will staff the positions for a two-year period starting in 2024. Cultivating native seed and plants from local populations is critical to the resiliency of ecological restoration efforts throughout the preserves by

ensuring that native plants are genetically adapted to our local habitats.

This partnership would also provide support for the Garden's Stewardship and Ecology of Natural Areas ("SENA") internship program to conduct ecological restoration activities at Turnbull Woods. The SENA program provides advanced workforce training for aspiring natural resource professionals, with a focus on stewardship, ecological monitoring, data collection and analysis. The SENA interns, under the Garden's direction, will conduct invasive species removal, seed collection, prescribed burning and other restoration actions in accordance with the Forest Preserves' approved management schedule.
