PROPOSED RESOLUTION

HONORING THE CAREER AND CONTRIBUTIONS OF EILEEN FIGEL

WHEREAS, Ms. Eileen Figel has served as the Forest Preserves of Cook County's Interim General Superintendent since January 2024 and previously served as the Forest Preserves' Deputy General Superintendent since July 2014 and has led the nation's oldest and largest forest preserve district in building a culture of inclusivity and equality; and

WHEREAS, Eileen is a member of the American Planning Association and holds a master's degree in Urban and Regional Planning from the University of Illinois at Urbana-Champaign, and a Bachelor of Arts in Management Science from the University of California San Diego. Prior to joining the Forest Preserves, Eileen served as the founding director for the Institute for Comprehensive Community Development, led an independent consulting practice, and served as former Mayor Daley's First Deputy Commissioner for the City of Chicago Department of Planning and Development, and as a municipal planner for the cities of Baltimore, Maryland, Long Beach, California and Highland Park, Illinois; and

WHEREAS, Eileen has been deeply committed to ensuring that the Forest Preserves' infrastructure and culture is based on equity and inclusion, and under her leadership, ensured that programming, development, and initiatives contributed to creating a welcoming environment for all Cook County residents and visitors; and

WHEREAS, Eileen spearheaded the implementation of the 2014 Next Century Conservation Plan, an ambitious and visionary strategy that laid out a set of bold actions that positioned the Forest Preserves as a national leader in urban conservation and ensured the people of Cook County treasure and sustain this amazing resource then, now and in the future and guided the launch and formation of the Conservation and Policy Council, an advisory body of distinguished civic-minded experts who generously volunteer time to the mission, established by ordinance and charged with guiding the efforts to implement the Next Century Conservation Plan; and

WHEREAS, under her direction, the Council and Forest Preserves' staff undertook the creation and implementation of five position papers that outline a set of principles and recommendations on key issues facing the Forest Preserves today and in the future including land acquisition and disposition, nature-compatible recreation, scaling up volunteers, and racial equity, diversity and inclusion; and

WHEREAS, her leadership and tireless advocacy contributed to build a community of support for the Forest Preserves, with 69% of Cook County voters approving a tax referendum to increase funding for nature and help the Forest Preserves maintain funding now and in perpetuity; and

WHEREAS, under her steady and focused leadership, the Forest Preserves have been managed with excellence, efficiency, transparency, and sound financial practices, and have continued to advance ambitious goals including acquiring land for the benefit of Cook County's people and nature resulting in - at long last - surpassing 70,000 acres of public land and updating the Forest Preserves' Land Use Code to ensure that these public lands will forever be available for public use and enjoyment; and

WHEREAS, Eileen has strongly supported the Forest Preserve Foundation, the Forest Preserves' philanthropic partner dedicated to protecting and restoring natural habitats and to enhancing outdoor experiences for all people, to improving workplace culture by listening to and supporting staff in finding resolutions to challenging situations and resources for key Forest Preserves programs and initiatives. The Forest Preserve Foundation has become a stalwart supporter of the Forest Preserves' Conservation Corps program, has helped restore critical natural areas including Cap Sauers Holdings Nature Preserve, and has raised more than \$3,000,000 to support the Forest Preserves; and

WHEREAS, Eileen is a tireless advocate for staff and has improved workplace culture by supporting and guiding her staff through challenging situations, modeling behavior, values and attitudes she wished to see from Forest Preserves' staff, encouraging employees to explore new best practices that can lead to improvements and increased efficiencies, and shared her limitless energy, frankness, and commitment to excellence with all of her colleagues; and

WHEREAS, Eileen is enthusiastic about traveling, camping and other outdoor recreation activities including cycling, hiking, and walking her dogs, and shares her love for nature with her family and friends; and

WHEREAS, Eileen has worked tirelessly on behalf of the Forest Preserves and the people and nature of Cook County and she will be sorely missed for her leadership and work ethic, her commitment to inclusivity, and her sense of humor.

Summary: Adam D. Bianchi has been nominated by President Toni Preckwinkle to serve as the General Superintendent of the Forest Preserves of Cook County.

With over 17 years of experience in public land and natural resource management through the United States Forest Service, Mr. Bianchi brings a strong history of leadership, innovation, and collaborative conservation to the Forest Preserves of Cook County.

Mr. Bianchi most recently served as District Ranger for the White River National Forest's Dillon Ranger District in Colorado, overseeing a complex 312,000-acre National Forest that receives nine million visitors annually. Managing a committed and dedicated workforce, his tenure was marked by strategic land-use planning, expansive community engagement, and successful partnerships that brought in over \$3 million in external funding in 2024 alone.

Throughout his career, Mr. Bianchi has led major projects integrating environmental sustainability with community needs. His leadership has been critical to the restoration of forests, diverse ecosystems, and wildlife habitats.

Mr. Bianchi's background in managing large-scale, multi-use landscapes and his commitment to inclusive, forward-thinking leadership aligns with the Forest Preserves' mission "*[t]o acquire, restore and manage lands for the purpose of protecting and preserving public open space with its natural wonders, significant prairies, forests, wetlands, rivers, streams, and other landscapes with all of its associated wildlife, in a natural state for the education, pleasure and recreation of the public now and in the future.*"

With his prior experience at the United States Forest Service, Mr. Bianchi is uniquely positioned to work with the Forest Preserves' senior team, staff, and partners to protect and restore natural lands while expanding access to nature for all Cook County residents. Mr. Bianchi was selected as the next General Superintendent of the Forest Preserves following a wide-ranging search. Former General Superintendent Arnold Randall was part of the interview team.

Mr. Bianchi holds a Bachelor of Science in Forestry from Iowa State University and is the recipient of numerous awards, including the United States Forest Service Chief Honor Award and multiple Rocky Mountain Region Forester's Awards for leadership and public service.

AUTHORIZATION TO ENTER INTO A JOINT FUNDING AGREEMENT AND ENGINEERING SERVICES AGREEMENT WITH THE ILLINOIS DEPARTMENT OF TRANSPORTATION (“IDOT”) FOR DES PLAINES TRAIL RECONSTRUCTION AND TO PAY IDOT THE LOCAL SHARE OF COSTS

WHEREAS, the Forest Preserves of Cook County (the “Forest Preserves”) is seeking to construct a new pedestrian bridge over active Union Pacific Railroad tracks in Des Plaines, Illinois (the “Project”) for the purpose of improving safety and connectivity in the Des Plaines River Trail in North Cook County; and

WHEREAS, in 2019, the Chicago Metropolitan Agency for Planning (“CMAP”) approved a major federal grant through the Congestion Mitigation and Air Quality (“CMAQ”)/local Transportation Alternatives (TAP-L) program for 80% of unfunded construction and construction engineering costs, estimated at that time at \$3,530,000 and \$350,000.00, respectively, with such funds to be administered by the Illinois Department of Transportation (“IDOT”); and

WHEREAS, in 2021, the Forest Preserves became aware of Grade Crossing Protection Funds (“GCPF”) through the Illinois Commerce Commission (“ICC”) and received a preliminary award of \$1,350,220.00 to cover 60% of the bridge structure portion of the Project, subject to agreement with the Union Pacific Railroad (hereafter “the Railroad”) to allow the Project and grant a ground and air rights easement; and

WHEREAS, after several years of detailed engineering, review by the Railroad and legal action before the ICC, the Railroad has tentatively agreed to grant a ground and air rights easement and allow the Project to proceed subject to reimbursement of the Railroad for certain costs described in an agreement that will require separate approval by the Forest Preserves Board of Commissioners (Board Item No. 25-0034); and

WHEREAS, in 2024, CMAP approved a request to increase federal CMAQ/TAP-L grant funds to \$4,493,000.00 for construction costs, including related utility relocation costs, railroad reimbursement and other related costs requiring separate board authorization (Board Items No. 25-0034 and 25-0266); and

WHEREAS, IDOT is responsible for the award of construction contracts and the Forest Preserves is now seeking approval for IDOT to post the Project for construction bids; and

WHEREAS, IDOT requires a resolution to reaffirm the Forest Preserves funding commitment to enter into a Joint Funding Agreement for Federally Funded Construction and an Engineering Services Agreement to pay IDOT the local share of unfunded construction and construction engineering costs associated with the Project that will not be covered by other grants; and

WHEREAS, the current estimated cost of construction is \$8,362,366.00 but is subject to potential unanticipated increases that could require drawing upon the approved maximum CMAQ/TAP-L grant amount; and

WHEREAS, the Forest Preserves is anticipating that the ICC will award a total of \$3,538,804.00 in GCPF (\$1,350,220.00 approved in the interim order and \$2,188,584.00 in requested supplemental funds) to cover 60% of eligible project costs once a final agreement with the Union Pacific Railroad is executed and a final ICC Order is issued; and

WHEREAS, after deduction of GCPF project costs (up to \$3,538,804.00 including anticipated supplemental funds), federal CMAQ/TAP-L funding is expected to cover up to 80% (\$3,858,850.00) of remaining project construction costs (\$4,823,562), leaving the Forest Preserves with responsibility for 11.5% (\$964,712.00) of the total estimated construction cost; and

WHEREAS, in the event the ICC does not award supplemental funds, 30.1% (\$2,519,146.00) of total estimated construction cost will be required as local match; and

WHEREAS, TAP-L funding was increased to cover up to 80% of Phase III construction engineering costs estimated at \$750,000.00; and

WHEREAS, the Forest Preserves is requesting supplemental funding from the ICC to cover up to 60% of eligible construction engineering costs (up to \$750,000.00), once a final agreement with the Union Pacific Railroad is executed, and a final ICC Order is issued; and

WHEREAS, IDOT recommends that a qualified consulting engineering firm be employed to perform Phase III construction engineering services prior to posting the Project for bid to meet deadlines for use of the funds provided via the federal CMAQ/TAP-L grant; and

WHEREAS, the Forest Preserves is recommending award of a construction engineering services contract separately (under Board Item No. 25-0033) to Bowman Consultant Group after issuing a Request for Qualifications “RFQ” for Phase III Engineering Services and based on qualifications with a total contract amount of \$690,563.00, 20% of which (\$138,112.60) would be Forest Preserves responsibility, but which could be reduced to \$51,344.00 after the pending final ICC approval of Grade Crossing Protection Funds; and

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby authorizes the Forest Preserves, through its President, to enter into a Joint Funding Agreement and Engineering Services Agreement with IDOT in connection with the Project, and to pay an amount not to exceed \$750,000.00 for Phase III Construction Engineering services subject to reimbursement of up to 80% by IDOT, and to pay the remaining balance of total estimated unfunded construction cost after approved Grade Crossing Protection Funds and CMAQ/TAP-L Funds, directly to IDOT in an amount not to exceed \$2,519,146.00 or 30.1% of the total estimated construction cost assuming the ICC does not approve supplemental GCP funds; and

BE IT FURTHER RESOLVED, that Bowman Consultant Group, of Lisle, Illinois, be engaged to perform Phase III Engineering services in connection with the Project, and that the President of such Board of Commissioners is hereby directed to execute, on behalf of the Forest Preserves, an agreement by and between the Forest Preserves and Bowman for Phase III Engineering services (the “Engineering Services Agreement”); and

BE IT FURTHER RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby confirms that sufficient funds are, or will be available, pending annual appropriations, in the Forest Preserves capital funding accounts to pay the local share of construction and Phase III Construction Engineering Services costs; and

BE IT FURTHER RESOLVED, that copies of the Joint Funding Agreement for Federally Funded Construction and the Engineering Services Agreement for Federal Participation when executed in their respective final form, shall be submitted to IDOT for approval and final processing.

WHEREAS, the FOREST PRESERVE DISTRICT OF COOK COUNTY (the “Forest Preserves”) has authorized various banks as depositories of its accounts; and

WHEREAS, from time to time, the Forest Preserves may also seek to open lines of credit or purchase appeal bonds from various insurers, bond companies or other institutions to cover the costs of judgments against the Forest Preserves in the event the Forest Preserves, upon Board approval, decides to appeal such judgments; and

WHEREAS, the various banks that serve as depositories of the Forest Preserves' accounts require the manual or facsimile signature of duly elected or appointed Officers of the Forest Preserves for the warrants, checks, drafts or other orders on these accounts; and

WHEREAS, the various insurers, bond companies and other institutions with whom the Forest Preserves may seek to open a line of credit, or from whom the Forest Preserves may seek to purchase an appeal bond, may require the manual or facsimile signatures of duly elected or appointed Officers of the Forest Preserves in order to allow the Forest Preserves to establish lines of credit or purchase appeals bonds; and

WHEREAS, from time to time, based on changes in Forest Preserves personnel, it is necessary to advise banks, insurers, bond companies and other institutions of changes to the list of elected or appointed Officers of the Forest Preserves who are authorized to sign on behalf of the Forest Preserves in order to allow the Forest Preserves to issue checks, warrants or other orders with respect to Forest Preserves bank accounts; establish lines of credit; or purchase appeals bonds; and

WHEREAS, effective July 25, 2025, this Resolution shall supersede the prior Resolution, Board Item No. 24-0054, which was approved by the Forest Preserves Board of Commissioners on January 23, 2024 regarding authorized signatures.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserve District of Cook County Board of Commissioners hereby authorizes, effective on July 25, 2025, that the manual or facsimile signatures of any three of the following officers shall appear on all lines of credit opened; appeal bonds purchased; or warrants, checks, drafts or other orders drawn on the bank accounts or other accounts of the Forest Preserves:

AUTHORIZATION TO ENTER INTO AGREEMENTS FOR RELOCATION OF UTILITIES AND PAY UTILITY RELOCATION AND OTHER MISCELLANEOUS COSTS RELATED TO DES PLAINES TRAIL BIKE/PEDESTRIAN BRIDGE CONSTRUCTION

WHEREAS, the Forest Preserves of Cook County (the “Forest Preserves”) is seeking to construct a new pedestrian bridge over active Union Pacific Railroad tracks and reconstruct adjacent portions of the Des Plaines River Trail in Des Plaines, Illinois (the “Project”) for the purpose of improving safety and connectivity on the northernmost portion of the Des Plaines River Trail; and

WHEREAS, the Project requires relocation of various utilities, including fiber optic line owned by Lumen Technologies, Inc. (“Lumen”) and electric line and facilities owned by Commonwealth Edison (“ComEd”) and requires permits by various regulatory agencies; and

WHEREAS, the utility companies require agreements to pay for relocation costs which are estimated at \$65,216.72 for relocation of a Lumen fiber optic line and a similar amount for relocation of various ComEd lines, and the Project may require payment of other miscellaneous fees or costs to other utilities or agencies; and

WHEREAS, the total cost of all utility relocation and other miscellaneous fees or costs is estimated at a total of \$130,217.00, and federal grant funds described in a separate Resolution (Board Item No. 25-0032) are anticipated to reimburse 80% or \$104,174.00 of the estimated costs, with local Forest Preserves capital funding the balance; and

WHEREAS, the Forest Preserves may be required to pay these miscellaneous costs directly to utility companies or regulatory agencies if those costs are not included in a construction contract expected to be awarded by the Illinois Department of Transportation (“IDOT”) for the Project.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby authorizes the Forest Preserves, through its General Superintendent, to enter into agreements with various utility companies to pay relocation costs, and for the Forest Preserves to pay directly other miscellaneous costs associated with the Project, in a total amount not to exceed \$156,260.00 (\$130,217.00 plus 20% contingency) subject to IDOT reimbursement of up to \$104,174.00 (80% of estimated costs); and

BE IT FURTHER RESOLVED, that the Forest Preserves’ Board of Commissioners hereby confirms that sufficient funds are, or will be available, pending annual appropriations in the Forest Preserves capital funding accounts, to pay the total costs of utility relocation and other miscellaneous costs for the Project in an amount not to exceed \$156,260.00 (subject to reimbursement as described above).

Vendor: Union Pacific Railroad, Omaha, Nebraska

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”) to enter into an agreement

The UPRR estimates its costs for project management, engineering review, construction observation and other costs to be \$83,425.00, and the easement value not to exceed \$30,000.00. GCP funds are expected to cover 60% (\$50,055.00) of UPRR costs excluding easement costs, subject to ICC approval of a future final order.

Federal grant funds under the Congestion Mitigation Air Quality (“CMAQ”)/Transportation Alternative Program-L (“TAP-L”) program are expected to cover up to 80% of the Forest Preserves’ match after GCP funds are applied and 80% of the UPRR easement cost and other miscellaneous costs under a separate Joint Funding Agreement with the Illinois Department of Transportation (“IDOT”) (see Board Item No. 25-0032).

Contract Period: Continuous from the date of execution of the Agreement until expiration of the life of the bridge subject to earlier termination in accordance with agreement terms; provided, however, term is permanent for Ground and Air Rights Easement.

SMG's proprietary system integrates with Genetec software, enabling real-time access management and reporting. A prior installation at Miller Meadow has been successful, with over five hundred (500) registered users.

In 2023, the Permits, Rentals, and Concessions (PRC) Department issued RFP 23-40-009531 for a keyless entry system at Miller Meadow. Requirements included solar-powered operation, user code access, and real-time remote updates. Of two (2) respondents, only SMG Security Holdings LLC met all criteria. PRC now plans to expand the system to Beck Lake (Des Plaines) by October 1, 2025, and Bremen Grove (Tinley Park) by spring 2026. This expansion will support nearly three thousand (3,000) users, enabling real-time monitoring and user management. Estimated costs are \$35,000.00 per site, with an \$11,000.00 service fee per year based on a \$200 service fee per location per month. These estimated monthly costs are higher than the provided quotes to allow the PRC Department to have a monetary contingency for this project. The Department of Permits, Rentals, and Concessions expect that this program will save the Forest Preserves \$15,000.00 annually on physical keys.

Summary: The Forest Preserves has an operational need to maintain our onsite fuel filling locations across the district. These locations require services on both a monthly and annual basis. The Forest Preserves has piggybacked off the State of Illinois contract #22-416CMS-BOSS4-P-39072, which is valid through 7/31/2030, for these services. The current agreement was approved by the board on December 12, 2023 (Board Item No. 23-0569) with \$175,000.00 in available funding for the life of the agreement, but that funding amount is only enough to include on-call repairs for our fuel tanks and Fuelmaster system.

The requested increase of \$500,000.00 will allow our fuel tanks to be regularly inspected to help ensure they are in full compliance with the Office of the State Fire Marshall (OSFM) requirements.

The Forest Preserves' aboveground storage tanks (ASTs) and underground storage tanks (USTs) are critical to the ongoing operations at its facilities, providing essential storage for fuels that support logistics, maintenance, and emergency response activities. Consolidating or removing these tanks would disrupt operations, increase transportation risks, and reduce site efficiency.

With this new funding, our fuel tank maintenance program will now include monthly walkthrough inspections of USTs as mandated by the Office of the State Fire Marshall (OSFM), annual testing of equipment such as line leak detectors, shear valves, and spill buckets, and monthly and annual inspections of ASTs following best management practices and manufacturer recommendations. All inspections and maintenance activities will be logged digitally and in hardcopy for audit readiness.

The Forest Preserves is therefore requesting this additional \$500,000.00 to fund a more comprehensive fuel tank maintenance program so that both UST and AST systems are kept to the highest standards, our organization mitigates environmental risk and helps ensure community safety and preserves operational readiness. The decision to continue using these storage systems is rooted in our commitment to sustainability, efficiency, and full regulatory compliance.

Maintaining the two (2) USTs and seventeen (17) ASTs is justified based on operational needs and a proactive safety and maintenance strategy. Continued adherence to OSFM guidance helps the Forest Preserves operate safely, lawfully, and in an environmentally responsible manner.

PROPOSED RESOLUTION

DECLARING THE FOREST PRESERVES OF COOK COUNTY'S SUPPORT OF THE INSTITUTE OF MUSEUM AND LIBRARY SERVICES AND BROOKFIELD ZOO CHICAGO

WHEREAS, the Institute of Museum and Library Services (IMLS) was established by the Museum and Library Services Act (MLSA) on September 30, 1996; and

WHEREAS, as a federal agency that administers discretionary programs, IMLS is funded through the annual federal appropriations process; and

WHEREAS, with its budget, IMLS supports a vast range of museums, including art, history, natural history, nature centers, botanical gardens, and zoos; and

WHEREAS, IMLS provides essential funding and guidance for the vast collections of museums across America, acting as community anchors, supporting youth and senior citizens, serving people with disabilities, and helping veterans heal; and

WHEREAS, beyond education, museums, zoos, aquariums, and libraries are economic engines, providing jobs, driving tourism, and serving as community cornerstones; and

WHEREAS, in 2024, IMLS awarded \$11,347,695 in grants to Illinois institutions, with \$3,214,842 awarded specifically for museum services; and

WHEREAS, we in Illinois have seen the great benefit this IMLS funding has on our local community as it has supported groundbreaking programs at Brookfield Zoo Chicago, including local community engagement initiatives, profound international research studies, and internal accessibility endeavors; and

WHEREAS, more than 180 million people visit United States zoos and aquariums each year, contributing more than \$22.5 billion to the American economy, with Brookfield Zoo Chicago welcoming 2 million of those visitors annually; and

WHEREAS, for decades, IMLS has played a critical role in advancing the capabilities of zoos and aquariums by funding foundational research on their importance to conservation, supporting the creation of a nationwide network of early childhood nature play programs, and enabling groundbreaking multi-institutional welfare studies for species like elephants and dolphins, backing cutting-edge research in reproductive technologies to enhance population sustainability, and promoting greater accessibility in zoos and aquariums for staff, volunteers, and visitors of all abilities; and

WHEREAS, museums cannot do this vital work without the support and funding they receive from agencies like IMLS; and

WHEREAS, support for museums is overwhelmingly popular, with 96% of Americans saying they would approve of lawmakers who act to support museums and 96% of Americans saying they want to maintain or increase federal funding for museums; and

WHEREAS, on March 14, 2025, the Trump Administration issued Executive Order 14238, ‘Continuing the Reduction of the Federal Bureaucracy’ which directs that, among other agencies, the IMLS’s “non-statutory components and functions...shall be eliminated to the maximum extent consistent with applicable law, and...shall reduce the performance of their statutory functions and associated personnel to the minimum presence and function required by law”; and

WHEREAS, IMLS’s impact and support for Brookfield Zoo Chicago cannot be overstated, with the Brookfield Zoo being awarded over \$1.5 million in programs and grants from IMLS over the last 5 years; and

WHEREAS, these grants have been directed towards supporting the Zoo’s impactful programs and projects focusing on animal welfare, accessibility, and education; and

WHEREAS, as a result of the Administration's gutting of IMLS, Brookfield Zoo Chicago was notified of the termination of several grant-funded programs; and

WHEREAS, this included Grant MA-251511-OMS-22, 'Behavioral Diversity as a Potential Positive Indicator of Welfare', a project that was designed to help animal care staff at accredited zoos and aquariums across the United States evaluate positive animal welfare, focusing on continuous improvement in animal care and management; and

WHEREAS, under this program, the Zoo would develop lists of behaviors across animal species, train researchers to observe the varieties of behaviors exhibited by each animal, and use chemical analyses to determine the relationships between various behaviors and stress hormones, with a goal of providing a new tool for monitoring animal welfare to be shared with institutions across the nation; and

WHEREAS, Brookfield Zoo Chicago also received termination notice for Grant MG-249218-OMS-2, 'The Zoo and Aquarium Radiology Database: A collaborative resource to advance veterinary care' that addresses a continuous challenge veterinarians face in the evaluation of health and disease in wild animals - the lack of adequate and freely available veterinary images such as x-rays, ultrasound, and CT scans for reference from healthy animals; and

WHEREAS, this project would establish the Zoo and Aquarium Radiology Database, the first and only free centralized database site for radiology images from zoo animals, which would enable further disease research and evaluation of population health, supporting the continued stewardship of living collections and species sustainability in the wild; and

WHEREAS, under these two grants, animal care staff can focus on enhancing animal welfare resulting in visitors experiencing healthy, engaged animals, elevating their overall zoo experience which in turn can lead to increased visitation by satisfied customers, continuing to bolster local economic growth within communities around zoos and aquariums across the United States; and

WHEREAS, IMLS has since notified Brookfield Zoo Chicago of the reinstatement of these grants in accordance with a Preliminary Injunction Order under *State of Rhode Island, et al. v. Trump et al.*, but notes that a pending appeal may affect the reinstatement of the grants in the future; and

WHEREAS, the permanent gutting of IMLS would be a huge blow for zoo and museum innovation and local community services and engagement; and

WHEREAS, protecting this essential agency is critical to preserving the vital role museums, libraries, zoos, and aquariums play in education, the economy, and community infrastructure across the country and in our own local communities; and

WHEREAS, though the U.S. District Court for the District of Columbia granted a temporary restraining order to block the Trump Administration's dismantling of IMLS on May 1, 2025, it remains crucial that we continue to uplift our support for IMLS, the work it does nationally, and its impact here in Cook County through Brookfield Zoo Chicago;

PROPOSED ORDINANCE

AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR CERMAK WOODS

AN ORDINANCE CREATING A FOREST PRESERVE in part of Section 36, Township 39 North, Range 12, East of the Third Principal Meridian, all in Cook County, Illinois near Cermak Woods in District 16.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the "District"), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands connecting such forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof; and

BE IT ORDAINED by the Board of Commissioners of the District as follows:

Section 1. That a unified Forest Preserve be and the same is hereby created within the District which shall contain and connect lands now owned and lands to be acquired in substantial accordance with the plat now on file in the office of the General Superintendent of the District, which by reference is hereby made a part hereof, and for the purposes of said Forest Preserve and for the carrying out of the statutory purposes more particularly set out in the preamble of this ordinance, it is necessary and desirable for the District to own and it shall acquire property hereinafter described in Section 2 of this ordinance, for the purpose of creating a Forest Preserve and for District uses.

Section 2. That the lands referred to in Section 1 of this ordinance are more particularly described as follows:

LOT 10 IN BLOCK 5 IN RIVERSIDE LAWN, BEING A SUBDIVISION IN SECTION 36, TOWNSHIP 39 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

SAID PARCEL CONTAINING 6,098 SQUARE FEET, OR 0.14 ACRES, MORE OR LESS.

Section 3. This ordinance is hereby made and ordained to be severable as to each parcel of land or portion thereof or right of interest in any of the same hereby authorized to be acquired, and failure to acquire any of the said parcels of land described in Section 2 hereof or right of interest in any of the same shall not impair or invalidate the authority by this ordinance granted to hold, own, or acquire any other of said parcels or any right or interest therein, it being the intention of said Board of Commissioners of the District to carry out the general plan provided in this ordinance so far as legally and financially practicable, and to negotiate for purchase, condemn, or otherwise acquire from time to time the parcel(s) of land described in Section 2 hereof and all right or interest therein.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval.

The Property, commonly known as 3850 Columbus Blvd, Unincorporated Riverside Township, Cook County, Illinois, consists of approximately 0.14 ± acres.

Through negotiations, the Owner of Record (the “Seller”), has agreed to sell the Property to the Forest Preserves for the sum of ONE HUNDRED THIRTY THOUSAND DOLLARS AND 00/100 (\$130,000.00) plus closing costs up to \$10,000.00 (up to \$140,000.00 in total). The purchase price is based upon two (2) M.A.I. appraisals obtained by the Forest Preserves and is subject to the Forest Preserves’ satisfactory completion of its due diligence.

Permission is now sought, upon satisfactory completion of all due diligence and negotiation of any and all required documentation as determined by the Forest Preserves Legal Department, to effectuate payment in the amount of the purchase price plus closing costs as full compensation for the acquisition of the Property.

This land acquisition advances the goals of the Forest Preserves’ Land Acquisition Plan, and Acquisition and Disposition of Land Position Paper.
