PROPOSED RESOLUTION

HONORING THE FOREST PRESERVES OF COOK COUNTY'S BUSSE FOREST NATURE PRESERVE FOR RECEIVING A CHICAGO WILDERNESS EXCELLENCE IN ECOLOGICAL RESTORATION ACCREDITATION, AND THE FOREST PRESERVES OF COOK COUNTY'S POWDERHORN LAKE HABITAT RESTORATION PROJECT FOR RECEIVING A CHICAGO WILDERNESS FORCE OF NATURE AWARD

WHEREAS, on October 22, 2025, the Forest Preserves of Cook County's Busse Forest Nature Preserve was honored with a Platinum Accreditation, the highest level possible, from the Chicago Wilderness Excellence in Ecological Restoration Accreditation Program, and the Forest Preserves' Powderhorn Lake Habitat Restoration project was honored with a Chicago Wilderness George B. Rabb Force of Nature Award at a ceremony at the Peggy Notebaert Nature Museum in Chicago, Illinois; and

WHEREAS, the Excellence in Ecological Restoration Accreditation Program recognizes the organization's management of the largest and highest-quality natural areas in the Chicago region and highlights projects that set an example of best practices in natural resource management and ecological restoration; and

WHEREAS, the 1,213-acre Busse Forest Nature Preserve is the seventh largest nature preserve in the State of Illinois and is part of the 3,558-acre Ned Brown Preserve, popularly known as Busse Woods in northwest Cook County near Elk Grove Village, Illinois and receives tens of thousands of visitors each year who seek out the preserve for outdoor recreation and nature exploration; and

WHEREAS, Busse Forest Nature Preserve protects a mosaic of habitats including woodlands, a sedge meadow, shrub swamp, and freshwater marsh, and the subtle changes in the site's topography and soils foster an intermingling of natural communities and create a hot spot of biological diversity, including over two hundred seventy (270) native plant species, including several state-listed species; and

WHEREAS, the George B. Rabb Force of Nature Awards recognize individuals and organizations whose conservation, restoration, advocacy or educational activities in the region are inspirational examples for others; and

WHEREAS, the Powderhorn Lake Habitat Restoration project was completed in 2023 and restored more than 100 acres of wetlands by reconnecting the Forest Preserves' 50-acre Powderhorn Lake to the Illinois Department of Natural Resources' 950-acre Wolf Lake; and

WHEREAS, Powderhorn Lake is located within Powderhorn Forest Preserve on the southeast side of Chicago, an area that has been shaped by significant urban and industrial development and yet still harbors a globally rare dune and swale habitat and is considered one of the most biodiverse natural areas in Illinois; and

WHEREAS, in 2016, the Illinois Department of Natural Resources' Coastal Management Program supported the development of a hydrology plan for Powderhorn Lake that the Forest Preserves did not anticipate being able to implement due to cost and complexity; and

WHEREAS, Audubon Great Lakes, a long-time Forest Preserves conservation and community engagement partner, secured funding from the Great Lakes Commission and the National Oceanic and Atmospheric Administration to conduct this visionary and ambitious project leading to the successful hydrologic reconnection between Powderhorn Lake and Wolf Lake, reestablishing vital marsh habitat for migratory birds, thriving fish nursery, and reducing flooding and erosion in neighboring communities; and

WHEREAS, the Powderhorn Lake Habitat Restoration project also benefitted from the support of numerous other partner organizations including The Nature Conservancy, Chicago Park District, The Wetlands Initiative and others and demonstrates what is possible through the collective expertise, coordination, and collaboration of dedicated partners.

NOW, THEREFORE, BE IT RESOLVED, that Toni Preckwinkle, President, and the Board of Commissioners of the Forest Preserves Cook County, congratulate the staff and partners involved in both the Chicago Wilderness Excellence in Ecological Restoration Accreditation and George B. Rabb Force of Nature Award and thank them for their commitment to the mission of the Forest Preserves; and

APPROVING EXTENSION OF THE TERM OF A COLLECTIVE BARGAINING AGREEMENT NEGOTIATED BETWEEN THE FOREST PRESERVES OF COOK COUNTY AND THE ILLINOIS FRATERNAL ORDER OF POLICE LABOR COUNCIL (POLICE OFFICER UNIT)

WHEREAS, the Illinois Public Labor Relations Act (5 ILCS 315/1 et seq.) has established regulations regarding collective bargaining with a union; and

WHEREAS, a Collective Bargaining Agreement between the Forest Preserves of Cook County (the “Forest Preserves”) and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit) is currently in effect for a term of January 1, 2021 through December 31, 2025 covering Police Officers in the Law Enforcement Department of the Forest Preserves (Board Item Nos. 23-0523 and 24-0309); and

WHEREAS, the Forest Preserves and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit) have negotiated an extension to the Collective Bargaining Agreement between the Forest Preserves of Cook County and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit) through December 31, 2027.

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners hereby approves, with respect to such above-referenced Collective Bargaining Agreement, the proposed time extension, a one-time lump sum payment, salary adjustments and general wage increases as follows:

Summary: The Forest Preserves of Cook County (the “Forest Preserves”) is requesting authorization for the General Superintendent or a designee to have discretionary spending up to \$300,000.00 per year for up to two (2) years, totaling up to \$600,000.00, beginning March 1, 2026, and ending February 29, 2028, for advertising and promotional services with a variety of media vendors to promote and showcase the amenities, programs and natural areas of the Forest Preserves. The media vendors would be engaged for periods of one (1) year or less. Media purchases would align with the communications goals of the Forest Preserves, which include focused geographic and demographic outreach to communities in Cook County that have been identified by the Chicago Metropolitan Agency for Planning as Economically Disconnected Areas.

The advertising and promotional spending packages would be suggested by the Forest Preserves’ Communications Division as part of an integrated marketing plan that may include electronic, print, broadcast and out-of-home (billboard) advertising and vetted based on the desired audience, frequency, reach and budget offered by local media. The marketing strategy also complements the short- and long-term goals of the Forest Preserves.

PROPOSED LICENSE REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”), as Licensor to grant a License to Nicor Gas Company, Grantee, to locate, operate and maintain a 4-inch gas main, the total length of which is 2,728 linear feet of pipe on Forest Preserves land, including 2,112 feet on land designated for the operation of a zoo by the Chicago Zoological Society (“Zoo-designated land”) and the remaining 616 feet outside Zoo-designated land. At the standard license width of 15 feet, the license area is 0.21 acre(s) outside Zoo-designated land and 0.73 acre(s) inside Zoo-designated land. Historically, the Zoo has had the autonomy to allow utility infrastructure installation deemed essential to its operation and maintenance without going through the Forest Preserves’ license approval process. Due to part of the licensed area being outside Zoo-designated land, this license request is being submitted to the Board of Commissioners for approval. License fees are only being charged for the portion of the gas main which will be located outside Zoo-designated land. The Zoo’s risk management staff have indicated this secondary gas line is needed as backup service in case of emergencies to avoid disruption in natural gas service. One (1) tree (a callery pear) will need to be removed. The new line will be located substantially within existing rights-of-way and a large portion will be under an existing shared use path.

Term: Ten (10) years

License Fee: \$20,787.88

The Forest Preserves staff have reviewed this license application and plans and have found them to be acceptable; therefore, it is recommended that the Forest Preserves of Cook County Board of Commissioners approve the issuance of this license.

PROPOSED PARTNERSHIP AGREEMENT

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”) to enter into a Partnership Agreement with the Eugene S. Pike House Foundation, Inc. (the “Foundation”) and the Beverly Area Arts Alliance (the “Alliance”) for the preservation, restoration, operation and long-term maintenance of the Eugene S. Pike House located at 1826 W. 91st Street, Chicago, Illinois (the “Pike House”).

Reason: This former watchman residence that was built in 1894 has fallen into disrepair and requires significant expenditure to restore the building. Under the proposed agreement, the building and adjacent yard area, approximately 0.3 acres (the “Licensed Area”), would be restored and maintained by the Foundation and the Alliance as a community center at no cost to the Forest Preserves for uses that support the Forest Preserves mission by providing nature-based education, recreation and cultural opportunities.

The critical repairs necessary to stabilize and preserve the Pike House would need to be completed by the Foundation within three (3) years of the effective date of the proposed agreement. The Foundation is proposing to fund most of the work with a major grant from the Illinois Department of Commerce and Economic Opportunity. All construction, including non-critical repair work, shall be completed within five (5) years of the effective date of the proposed agreement, unless otherwise mutually agreed to in writing by the respective parties. If construction on the project does not commence within two (2) years of the effective date, the Partnership/License Agreement will automatically terminate.

The Alliance will be responsible for the daily maintenance of all property within the Licensed Area except for any trees, including but not limited to, keeping the property in good repair, clean, and safe to the public.

The proposed agreement includes terms and conditions relating to the use of the Pike House property by the Alliance that ensures that programs, exhibits and events support the Forest Preserves mission and do not adversely affect the Forest Preserves or adjacent neighbors. Various types of insurance would be maintained by the Foundation and the Alliance throughout the proposed agreement term, and an annual community outreach plan would also be submitted to the Forest Preserves to ensure there is outreach to Cook County residents outside the Beverly Area for the center's various events.

The Forest Preserves previously issued a Request for Expressions of Interest in connection with the Pike House. Emergency roof repairs were previously authorized by the Board of Commissioners on 10/22/2024 (Board Item No. 24-0371). With respect to Title 2, Chapter 5 of the Forest Preserves' Code of Ordinances (Acquisition, Conveyance, License, and Use of District Property), waiver of license related fees and non-applicable provisions is recommended due to the minimal impact to Forest Preserves land and the above benefits of the proposed use.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”) to grant a temporary easement to the Illinois Department of Transportation (“IDOT”) at Forestway Drive for 0.13 acre or 5,445 square feet for road improvements.
