WHEREAS, the freedoms we enjoy as Americans have been demonstrated through patriotic commitment and sacrifice of many veterans from Cook County; and

WHEREAS, Cook County veterans are owed a great debt for serving in defense of this nation; and

WHEREAS, those sacrifices of our veterans have resulted in permanent injury or death, yet their spirit remains in the continued promise and perseverance of liberty for all the oppressed individuals throughout our world; and

WHEREAS, over 2 million members of the United States Armed Forces have been deployed to warzones since the commencement of Operation Enduring Freedom, Operation Iraqi Freedom, and Operation New Dawn; and

WHEREAS; many have been deployed for multiple tours of duty. More than 5,500 troops have been killed while serving in Iraq or Afghanistan, and tens of thousands have been seriously wounded in the line of duty; and

WHEREAS, in honor of these dedicated citizens of Cook County, the Cook County Forest Preserve Commissioners wish to memorialize the enduring efforts of our veterans in preserving the site at the Cook County Forest Preserve Headquarters area as a lasting symbol to the principles of freedom and democracy; and

PROPOSED LICENSE REQUEST

Request: Requesting authorization for the Forest Preserve District of Cook County ("the Preserves"), as Licensor to grant a License to National Wireless Ventures, LLC., Grantee, to locate, operate and maintain a communications tower near the intersection of 31st Street and Prairie Avenue on the Preserves land currently managed by agreement with the Brookfield Zoo. The location of the communications tower is upon a distressed maintenance area of the Brookfield Zoo not open to the public. This site has been approved by the staff of the Preserves and the Brookfield Zoo. Grantee is solely responsible for compliance with all the Preserves and County ordinance and permit requirements related to construction, operation and removal of communication towers.

Term: Five (5) years with four (4) additional five-year extension terms.

License Fee: During the term of the License, Grantee shall pay the Preserves \$30,000.00 Base Fee annually beginning upon the Construction Start Date. Additionally, after the first sublicense, Grantee shall pay a Sublicense Fee of \$9,750.00 annually for each additional sublicense added to the communication tower. Both the Base Fee and Sublicense Fee shall increase by 3% annually. These fees are to be collected monthly.

Total one-time upfront fee of \$12,000.00 (payable as \$2,000.00 at time of execution of the License and \$10,000.00 on the Construction Start date) in further additional compensation is due to the Preserves from the Grantee for the term of the License (Sec. 5-2A-4 and 5-2B-4)

PROPOSED LICENSE REQUEST

Request: Requesting authorization for the Forest Preserve District of Cook County ("the Preserves"), as Licensor to grant a License to National Wireless Ventures, LLC., Grantee, to locate, operate and maintain a communications tower near the intersection of 31st Street and Prairie Avenue on the Preserves land currently managed by agreement with the Brookfield Zoo. The location of the communications tower is upon a distressed maintenance area of the Brookfield Zoo not open to the public. This site has been approved by the staff of the Preserves and the Brookfield Zoo. Grantee is solely responsible for compliance with all the Preserves and County ordinance and permit requirements related to construction, operation and removal of communication towers.

Term:Five (5) years with four (4) additional five-year extension terms.

License Fee:During the term of the License, Grantee shall pay the Preserves \$30,000.00 Base Fee annually beginning upon the Construction Start Date. Additionally, after the first sublicense, Grantee shall pay a Sublicense Fee of \$9,750.00 annually for each additional sublicense added to the communication tower. Both the Base Fee and Sublicense Fee shall increase by 3% annually. These fees are to be collected monthly.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserve District of Cook County ("the Preserves") to grant a temporary easement to the Illinois Department of Transportation ("IDOT") at Cicero Avenue (IL Rte 50) at Midlothian Creek in the Midlothian Meadows Preserve for 0.05 Acres or 2,059 square feet.

Reason: IDOT proposes to replace the existing 60-80 year old culverts that convey Midlothian Creek under Cicero Avenue with a new concrete structure. The temporary easement is needed for grading to align the existing stream bank with the new structure. The proposed stream bank grading will reduce the existing stream bank erosion along the south bank of the creek, on the Preserves' land.

No permanent structures are proposed to be built on District land.

The area for the temporary easement is 0.05 acres. IDOT indicates that no trees are expected to be removed for this project.
