PROPOSED RESOLUTION

TO ALIGN WORKERS' COMPENSATION PAYMENT PROCESS WITH STATE STATUTE

WHEREAS, the Forest Preserves of Cook County (the "Forest Preserves") administers workers' compensation benefits for Forest Preserves employees pursuant to the Illinois Workers' Compensation Act, 820 ILCS 305/1 et seq. (the "Act"); and

WHEREAS, the Finance Subcommittee on Workers' Compensation authorizes workers' compensation settlements and awards as presented by the Forest Preserves' Legal Counsel; and

WHEREAS, the Forest Preserves' Legal Department works to ensure that employees with workplace related injuries receive proper workers' compensation benefits/payments as required under the Act; and

WHEREAS, recent amendments to the Act require medical providers to bill an employer or its designee directly and requires payment of such bills within thirty (30) days of receipt; and

WHEREAS, under the Act the Forest Preserves could face interest charges at the rate of 1% per month for late payment of medical provider bills; and

WHEREAS, on June 6, 2019, the Cook County Board of Commissioners passed a resolution granting the County's Department of Risk Management authority to resolve and execute all workers' compensation claim payments, provided, that a monthly report of such approved payments be made available to the Finance Committee of the County Board (County Board Item 19-2123).

NOW, THEREFORE, BE IT RESOLVED, by the Forest Preserves of Cook County Board of Commissioners that the Forest Preserves' Finance and Legal Departments be granted the authority to resolve and execute all workers' compensation claim payments. A report of such approved workers' compensation claim payments shall be made available to the Finance Committee of the Forest Preserves' Board on a monthly basis beginning no later than March 2020 by the Finance and Legal Departments.

Summary: The Department of Permits, Rentals and Concessions ("PRC") contracts with a third-party consultant, Penn and Associates, to survey customers who hold picnics or special events in our groves on a weekly basis throughout the summer months. This year, seven hundred ninety-four (794) patrons

completed questionnaires, a 17% response rate. Overall, customer satisfaction increased in 2019 compared to a year ago and the results showed continuous month-by-month improvement throughout the 2019 season. PRC, Department of Landscape Maintenance, and Department of Law Enforcement staff who interacted with customers all received extremely high ratings. The full report and presentation include detailed findings. Results of the survey are reviewed by all relevant staff on a weekly basis during the summer months to gauge and improve areas of operations within the Forest Preserves of Cook County.

Summary: In September of 2019, the Cook County board approved a sole source contract with Axon Enterprise, Inc. Axon Enterprise, Inc. provides Taser weapons and body worn cameras to over sixty (60) law enforcement agencies across the country. The Forest Preserves has determined that the use of

Taser weapons and body worn cameras, along with maintenance and Cloud-based storage, would be beneficial for its Law Enforcement Department as well.

The Taser weapons, body worn cameras, maintenance and Cloud-based storage will aid in the safekeeping of thousands of visitors of the Forest Preserves' with more than three hundred fifty (350) miles of trails, nearly three hundred (300) picnic groves, six (6) nature centers and five (5) campgrounds. The purchase also will help ensure the safety of the police officers assigned to protect the nearly 70,000 acres of Forest Preserves property and its visitors.

The Taser weapons are less than lethal weapons that will allow officers to de-escalate situations, thus preventing the use of deadly force. The body worn cameras will provide a clear substantiation of encounters with citizens. The Cloud-based storage will allow the Department of Law Enforcement to receive and retain video accounts of police-citizen interactions.

REQUEST TO REGISTER A PORTION OF ELIZABETH CONKEY WOODS AS AN ILLINOIS NATURE PRESERVE

Department: Department of Resource Management

Summary: Requesting authority, pursuant to Section 9 of the Cook County Forest Preserve District Act (70 ILCS 810/9), to dedicate a portion of Elizabeth Conkey Woods as an Illinois Nature Preserve with the Illinois Nature Preserve Commission ("INPC").

This dedication contributes to one of the key goals set forward in the Next Century Conservation Plan to dedicate and register 20,000 acres with the INPC by 2025. Dedication of a site as a Nature Preserve provides the highest level of protection for land in Illinois, and is granted only to natural areas of important natural and cultural significance.

The proposed Elizabeth Conkey Woods Nature Preserve is an approximately 180-acre portion of the preserves located in the villages of Crestwood and Palos Heights in southwest Cook County. The site consists of mesic oak woodlands and mesic floodplain forest adjoining Tinley Creek, and is home to several species identified as being in greatest need of conservation. The site also contains important cultural resources of state-wide significance which merit its dedication and protection.

The Forest Preserves of Cook County (the "Forest Preserves") currently has twenty-five (25) dedicated Nature Preserves and four (4) Land and Water Reserves. The addition of Elizabeth Conkey Woods would bring the Forest Preserves' total INPC protected lands to approximately 10,050 acres.

It is respectfully requested that authority be granted to Forest Preserves to submit Elizabeth Conkey Woods to the Illinois Nature Preserve Commission for review and formal dedication as an Illinois Nature Preserve.

Summary: Friends of the Forest Preserves has received additional grant funding from The Caerus Foundation to continue a North Branch Conservation Corps program providing conservation and leadership skills training to young adults, ages 18-24, at stewardship sites located along the North Branch of the Chicago River. Participants will receive the training and technical expertise necessary to pursue a long-term career in ecological restoration and related fields.

The Conservation Corps co-facilitates innovative job training and employment programs that provide participants with paid, hands-on experiences in conservation that train the next generation to restore and be responsible stewards of the land.

Total project costs are \$500,000.00 over the two (2) year term, with \$246,000.00 in match by the Forest Preserves leveraging \$200,000.00 in investment by The Caerus Foundation and \$54,000.00 in investment by Friends of the Forest Preserves. The overall annual contract authority was increased in anticipation of additional funding opportunities. This program advances the goals of the Next Century Conservation Plan.
