Good morning, Chairman Arroyo and Commissioners. I am Jean Franczyk, President and CEO of the Chicago Botanic Garden. Thank you for the opportunity to offer public support for putting a referendum on the ballot that calls for a modest property tax increase that will support the Forest Preserves, the Brookfield Zoo, and the Chicago Botanic Garden. Thanks to each of you for recognizing how important these 70,000 acres are to the health and well-being of this entire region.

The Chicago Botanic Garden is an international leader in plant conservation, and we are recognized as one of the top 10 most-visited botanic gardens in the U.S. The Garden is one of the top cultural attractions in the Chicago area, welcoming more than 1 million visitors a year from throughout the region and the world. We are proud to be a scientific and cultural asset to Cook County, and one that, through our work, shapes how people value, perceive, and care for the environment.

Friends of the Chicago River partners regularly with the Forest Preserves on ecological restoration and public access projects. We've partnered to install osprey polls for nesting habitat and bat maternity wards. Last winter alone, we expanded our land restoration footprint by 172 acres, removing invasive and nuisance plant species so these areas can be returned to a native and diverse ecosystem. Not only do we protect and enhance the forest preserves for wildlife, but Friends is part of the coalition that oversees Centennial Volunteers, which organizes regular volunteer days in the preserves. And outside of my professional capacity at Friends, I myself have enjoyed volunteering at and visiting La Bagh Woods. As many can attest to during these times, access to the preserves has been helpful for my mental and physical health.

In addition to this on the work on the land, we know this measure will help improve water quality, ensuring that what flows to the Chicago and Calumet Rivers is clean. Forest Preserves, including wetlands and land along rivers and streams, filter rain and storm water. That keeps pollution from entering our rivers and streams and Lake Michigan. About 15,000 acres of Forest Preserves land are next to streams and rivers and we must protect and restore them to ensure water quality.
