Dear Commissioners,

Thank you for the proclamation that was submitted by Commissioner Britton at the November meeting in memoriam of my late husband, William Kelly. It was meaningful to our family that his life of service to Cook County was recognized before you.

I'm writing today not only as a citizen of Cook County, but as an educator who has worked in tandem with the staff at River Trails Nature Center in Northbrook for over 20 years to educate children and families using the Mighty Acorns Program. In 1999, East Prairie obtained a grant to begin an outdoor education program, working with staff at the Chicago Botanic Gardens and at River Trails Nature Center. Since 2011, our Mighty Acorns programming has taken place at the nature center in Northbrook. I have arranged multiple visits per year for third, fourth and fifth graders from East Prairie along with parent and adult volunteers. As such, our school has visited River Trails 54 times for a total of over 3000 individual visits. Naturalists from RTNC have also come to East Prairie for educational visits, and during the pandemic, we have even zoomed for educational programming. As an educator, I also wrote a letter in support of a grant that the naturalists at RTNC wrote and obtained.

Additionally, my oldest two sons completed their Eagle Scout Projects at River Trails and two of my younger children completed the Junior Naturalist Program there.

Having a local nature center dedicated to education is invaluable. Many of the students in my school have never been to the forest or seen native animals such as eagles, hawks, owls and coyote prior to our visits. Seeing live animals firsthand sparks students' interest in animals and local ecosystems in ways that would not be possible by simply reading books or science materials. Nature Center staff rehab and care for animals who are unable to be released into the wild. The animals at River Trails are treated humanely, responsibly, and ethically. Staff follow guidelines established by the USDA and the state of Illinois in the rehab and daily care of the animals at the nature center. Never have I had concerns about the staff or facilities at River Trails Nature Center, and of the thousands of people I have brought to the nature center on field trips or sent by personal recommendations, I have never heard any concerns about the treatment of the animals under the care of the naturalists.

We are fortunate to have such an amazing facility in Cook County to further the education of our students.

To: Cook County Board of Commissioners Regarding Forest Preserve Meeting re River Trail Nature Center Keeping the Coyote on January 11, 2022

I am sorry I was not given the opportunity to speak to the Board on behalf of Chicago Nature Seekers. In 2017 I created the Chicago Nature Seekers. This program is designed to introduce underserved children to nature. Since 2017 I have worked with about 10 underserved schools and brought more than 1000 children to River Trails and other nature centers to learn about nature. This year, In October and November I brought 400 3rd and 4th grade students out in spite of COVID, for a wonderful field trip. My students live in areas where the parks have been closed for most of the pandemic. They have no had field trips or hardly any coordinated outdoor experiences. The trip to River Trails is one they will remember for the rest of their life-they learned so much and were out in nature.

All children need to experience nature, but especially children in urban areas really need this kind of experience and access. They can't look out their windows and see deer or even squirrels They need to see live animals and be told why they should care about them and their environment.

Those who object to the care given the coyote at River Trail need to come out on one of our Chicago Nature Seekers trips, and listen to the naturalists explain how the coyote got there, how they care for it, and why protecting coyotes is important. Hearing the love from the Rangers, and then watching the children watch the coyote with amazement and asking questions is what makes it worth it for me to fund these adventures. The children learn to appreciate the importance of protecting animals. My students are required to send thank you notes to tell me what they liked or didn't like about the nature trip. (They always like everything). Many of them specifically mention the coyote. They learn why this coyote can't live alone in the woods anymore and how the staff play with him and make sure he is well cared for.

Having live animals be it snakes, turtles, disabled hawks, the coyote or anything else introduces the children to real animals and the importance of making sure we don't destroy their habitats. One of my goals in creating Chicago Nature Seekers is in the hopes that I will help create a group of people who when they become adults will care about the environment and work to assure it is protected.

The Forest Preserve Nature Centers always include live animals. This why I bring these underserved children to your wonderful centers. They get to have an outdoor experience that also includes live animals as well as great naturalists and wonderful exhibits. In the

same way that the hawk and eagles who can no longer live on their own are cared for at River Trails, the coyote is such a valuable animal for a learning experience.

Please don't let some group that doesn't truly understand the impact of having an enclosed coyote who is well cared for, and would be dead if left on its own, ruin the educational opportunity that really enhances the experience of these Cook County children to recognize that they can appreciate nature and their behavior can make a difference in how our environment is protected.

Please go to Chicagonatureseekers.org to see some of the children enjoying the wonderful facilities you have. When things hopefully are better in the Spring we would be honored to have you come to our programs and watch with delight the sheer amazement and joy of these elementary school children in discovering nature. Please don't let the misguided concern for the coyote of a few people ruin the incredibly amazing educational experience of hundreds of children.
