#### Dear Superintendent Randall:

We are pleased that the Cook County Forest Preserve (CCFP) will be reviewing its ambassador animal program and its practices regarding keeping animals in captivity. The current conversation over whether Rocky the coyote is being housed in a suitable habitat, while important, is part of a larger conversation that needs to take place about the CCFP's policies and practices regarding its captive and ambassador animals programs. We are requesting information about how the CCFP will conduct its review of its captive and ambassador animal programs. It is imperative that there be transparency in the review process, including which experts will be asked to conduct the review, and what standards and criteria will be used to evaluate current programs.

#### Reviewing the CCFP Captive Animals Program

The CCFP's captive animals program should follow the standards set by the Association of Zoos and Aquariums (AZA)--the best practices for keeping animals in captivity--rather than those set by the USDA, which are much lower standards. For example, here are the guidelines of each for coyote habitats:

#### USDA Standards for Coyote Habitats

The USDA space requirement standards for the Humane Handling, Care, Treatment, and Transportation of Warmblooded Animals Other Than Dogs, Cats, Rabbits, Hamsters, Guinea Pigs, Nonhuman Primates, and Marine Mammals (which is the category into which coyotes fall) are as follows: § 3.128 - Space requirements: Enclosures shall be constructed and maintained so as to provide sufficient space to allow each animal to make normal postural and social adjustments with adequate freedom of movement. Inadequate space may be indicated by evidence of malnutrition, poor condition, debility, stress, or abnormal behavior patterns. (Animal Welfare Act and Animal Welfare Regulations (usda.gov), page 231)

Rocky's housing does not even meet those USDA guidelines as he is showing signs of stress.

#### AZA Standards for Coyote Habitats

The AZA's Large Canid Care Manual state: 2.1 Space and Complexity: Careful consideration should be given to exhibit design so that all areas meet the physical, social, behavioral and psychological needs of the species. Animals should be displayed, whenever possible, in exhibits replicating their wild habitat and in numbers sufficient to meet their social and behavioral needs (AZA Accreditation Standard 1.5.2).

Enclosure size: Large canids should be provided with large, complex outdoor spaces. Enclosure shape, topography, substrate, plantings, and proximity to the public should all be considered in the design process. A large and varied enclosure will provide greater opportunity for canids to express their full range of natural, species-appropriate behaviors, and eliminate the associated stress and unnatural behaviors associated with housing in low quality environments. (See The AZA Large Canid Care Manual for more information.)

Science has evolved significantly since many of the CCFP's animal habitats were built, including those located at River Trail Nature Center. If the CCFP wants to put captive animals on display like zoos do, its habitats should meet the same standards that zoos meet.

#### "Animal-First" Ambassador Animals Program

In recent years, experts have developed new policies and practices for ambassador animal programs based on an evolution in understanding what practices lead to the best outcomes for the animals themselves. For example, the Lincoln Park Zoo discusses its "animal-first" ambassador animals program on its website:

Here at Lincoln Park Zoo, we believe in data-informed decision-making and putting animal welfare first. After evaluating several of our programs over the last few years with the help of the Animal Welfare Science Program and the Animal Care and Learning departments, the zoo is making "animal-first" changes to programming that involves ambassador animals.

"Animal-first" is an approach where various factors are considered: Does the animal have choice? Does the animal have control? Can the animal remain [in] the comfort of its habitat? Is the program to the animals' benefit? If the answer is 'yes' to all of these questions, that is an animal-first program. Moving forward, the zoo has committed to this approach for all ambassador animal programs and will be phasing out any program that does not meet these criteria. Changing the Approach to Caring for Ambassador Animals - Lincoln Park Zoo (lpzoo.org)

Just as the CCFP should meet AZA standards for captive animal habitats, it should also meet AZA standards and best practices for ambassador animals. (These resources offer further information: Recommendations for Developing an Institutional Animal Ambassador Program, Ambassador Animal Resource and Information Center Animal Welfare resources)

#### Anticipated Outcomes and Recommendations

We expect that a neutral third-party expert in best practices for keeping animals in captivity will determine that many of the CCFP's current habitats and enclosures do not meet AZA standards, and also that what the CCFP calls an animal ambassador program is not a true animal ambassador program. At that point, the CCFP will need to decide whether to invest resources to upgrade these habitats and programs. Perhaps implementation of these new standards can be phased in over a period of time. Perhaps the CCFP will determine that its captive animals program should not include more complex animals such as coyotes and foxes in the future.

If, as we anticipate, the expert determines that Rocky the coyote's habitat is not suitable, we are asking for the CCFP to either take immediate action to build a new enclosure that meets AZA standards within 60 days, or else agree to transfer Rocky to The Wild Animal Sanctuary, a nonprofit organization with substantial resources and over 40 years of experience with previously-captive animals. We are aware that Pat Craig, founder of The Wild Animal Sanctuary, has sent a letter with detailed information about the plan for Rocky's transfer and transition. We expect that he will get the best care and have the best possible outcome at The Wild Animal Sanctuary.

I am writing in support of the management and staff of the Cook County Forest Preserves. In particular, I would like to offer my support to the dedicated and competent staff of the River Trail Nature Center. I am asking you to trust them to do the jobs for which they are trained and well qualified.

While I am not currently a Cook County resident, I grew up there. And, the River Trail Nature Center played an important role in my life. I visited as a child and went on "dates" there with my then girlfriend (now wife). It had such an impact, that despite a 45 minute drive to get there, I still visit the center on occasion.

For the past several months the Forest Preserves and Nature Center have fallen victim to a growing trend in society. Context, understanding, and expertise are being discarded to accommodate the volume and reach of sometimes well-intentioned but not necessarily qualified voices.

This trend threatens the success of the entire Forest Preserve organization. We have seen this in other industries over the past few years. We've seen the dysfunction that is created when decisions are made based on popular opinion rather than expertise, facts, and science. What may appear wrong to a novice often is acceptable when understood, in context, by an expert.

It saddens me to see the dedicated staff of the River Trail Nature Center attacked personally in social media and other forums. Personal attacks are desperate, last-ditch tactics. They are used by people who know they do not have a credible argument regarding the actual issue at hand. And they quickly devolve our society. What's the point of having these beautiful outdoor spaces if the people who visit them cannot even be civil and respectful of one another? Who is going to want to visit a space drenched in derision, hostility, and disrespect? Who would want to want to work in such an environment? The great resignation has shown us what happens when employees are disrespected and unempowered.

It also concerns me that the voice of experts who have had limited exposure to an animal's behavior are given equal weight to similarly trained people who have day-to-day, on-going contact with the animal. That wouldn't be tolerated in other settings. Imagine a child in need of a customized learning plan. Who would you trust to develop it? A teacher who is 500 miles away who watched a five-minute video of the child in the classroom and read reports from non-educators who didn't like the current program? Or would you trust the judgement of the child's classroom teacher and other professionals at the school who work with the child on a daily basis?

The Forest Preserves are lucky to have high quality, dedicated, and expert staff. Their talent is reflected in the outstanding programs and services that are offered. I would strongly encourage you to empower them to use their expertise and training to do their job.

Nobody or no organization is above accountability or criticism. But there is also a responsibility for those who want to hold others accountable or criticize them. At a minimum, they must possess enough understanding, expertise, and context to act in a responsible, ethical, and fair way.

All citizens have a right to their opinion. They also have a right to express that opinion. However, as a board, you have a responsibility to distinguish the signal from the noise.

Please let your staff do their job. They have the training. They have the knowledge. They have the expertise.

I've seen it stated by the ForestPreserve District of Cook County that 'The coyote's enclosure is well sized for its needs according to the experts that provide its care.' Sure, that might be a valid thing to say, if we were back in the 1920s. We are NOT in the 1920s though, and our knowledge of animal husbandry has improved far beyond what it was then. This is an animal that would range for miles in the wild, while here it is being kept in a space smaller than a one bedroom trailer. This is not enough space for such an animal. There's scarcely any enrichment in the animal's enclosure, and its "shelter" consists of two doghouses, neither of which is equipped to insulate against colder temperatures. To keep this animal in such a small enclosure with little to no enrichment, to outright say that you are not willing to do improve its living conditions, is willful negligence and quite frankly abusive in my opinion. With all due respect, please put this animal in the hands of someone who is actually willing to properly care for it.

According to research published in the academic journal, Conservation Biology, it appears untrue that children are educated from visiting zoos. The research conducted surveyed 2,800 children after guided and unguided visits to the London zoo. This survey revealed that 62% of children showed no change in knowledge regarding new facts about animals or anything pertaining to environmental conservation.

In fact, this study suggested children's knowledge over conservation is worsened, or a "negative learning outcome" forms, as the children feel they cannot do anything effective enough to solve the problem (One Green Planet 2014).

I personally find it difficult to believe that a reverse effect regarding education when visiting zoos would form, considering although most children will not learn anything, they will still have at least non- changed feelings towards conservation and animals.

Liz Tyson, the director of the Captive Animals' Protection Society, supports the journal Conservation Biology, stating "Zoos present an entirely false view of both the animals themselves, and of the real and very urgent issues facing many species...Zoos do not educate nor do they empower or inspire children" (Captive Animals' Protection Society 2015). I agree with Tyson with the idea that zoos portray a false depiction of what they are actually like. The only true way to actually witness animals in their natural state is by watching them out in the wild.

I may not be an expert in "Wildlife" but I can recognize suffering and stress when I see it. I visited this coyote, he is stressed and in need of help. The Nature Preserve's attempt to continue inflict this on this helpless animal, shows they are not looking out for its best interests. Rocky is a "Side Show Attraction" and their desperate attempts to keep him there is quite obvious.

If he didn't have a chance to be introduced to a pack or the ability to be released into controlled freedom at the Colorado Sanctuary, I'd say life for Rocky is doomed to "side show" gawking by humans.
