It has recently come to my attention that there are citizens who have become particularly focused on the well being of a coyote at River Trails Nature Center. As someone who has been a dedicated volunteer with the Forest Preserves of Cook County, a volunteer Master Naturalist, an educational coordinator for a conservation trust, I would like to suggest that an outside entity be brought in to assess the health of the animal. Although it is idealistic to re-wild all of our wildlife, we cannot underestimate the impact that we have in individual lives within our natural world. Without this understanding we would not have the civilizations we have today, the pets we have today, the understanding of our ecosystems that we have today, the conservation efforts that we have today, or the respect for the health and well being for our environment. Many times, these efforts are well intentioned but not well informed. There is a lot of passion put behind these efforts to "save" animals that are impacted by human behavior when really it turns out to be a punishment for everyone involved. I admire the passion that these citizens bring but at the same time would like to highlight the need for research specialists, biologists, conservationists, academic specialists, zoologists, and all other relative fields who dedicate their lives to the well being of each individual being under their care.
