I signed up for the CLIC training at Camp Sullivan this past April in preparation for a camping trip for our Environmental Science and Science Club students at Solorio Academy High School. Our school is located in the Gage Park neighborhood. While some of my students have had incredible exposure to nature by camping with their families or visiting their relatives in rural Mexico, others have little experience with camping and outdoor activities. The activities our high schoolers engage in can shape their interests for the rest of their life. I want our students to feel confident as campers and excited to spend time outdoors. The CLIC program has given me this confidence! I am a visually impaired Puerto Rican woman who grew up in Oak Lawn about 15minutes from Camp Sullivan, yet I had never camped there until the CLIC program. When I did camp with my local girl scout troop, I was one of a handful of Latinas on the trip. I had camping experiences in college where group leaders refused to accommodate my disability and left me feeling like the outdoors wasn't for me. CLIC is excellent at preparing facilitators to bring camping to people from underrepresented groups. I was so impressed by the level of preparation they were training us to have. We talked about providing our campers with foods that were culturally relevant to them and allowing students to provide input on the camp itinerary. We discussed different ways to cater to medical problems among campers as well as how to ensure all students feel like they belong on the trip. The experience healed my relationship with camping and has really made me passionate about taking as many students as I can to experience the natural wonders of cook county. CLIC has also made it easy for my coworkers and I to bring a class to camp thanks to their gear library. I am proud to support this program!
