# PROPOSED ORDINANCE AMENDMENT

BIKE ORDINANCE

**BE IT ORDAINED,** by the Forest Preserve District of Cook County Board of Commissioners, that Title 4 - Motor Vehicles and Traffic, Chapter 3 - Bicycles of the Forest Preserve District of Cook County Code of Ordinances is hereby amended as follows:

# CHAPTER 3 - BICYCLES <u>AND EBIKES</u> 4-3-1: - OPERATION OF BICYCLES <u>AND EBIKES</u>.

A. <u>Definitions:</u>

- <u>"Bicycle" or "bicycle" means a device propelled by human power upon which any person</u> may ride, having two tandem wheels except scooters and similar devices. The definition of "Bicycle" or "bicycle" shall also encompass recumbent road bicycles and mobile elliptical trainers propelled by human power.
- 2. <u>"Bicycle Trail" means a trail on which the General Superintendent allows bicycle riding as</u> an exclusive or non-exclusive use of such trail, as indicated by sign or notice.
- 3. <u>"Ebike" means, for purposes of this ordinance, a bicycle equipped with fully operable pedals and an electric motor of less than 750 watts, which is classified as either "Ebike-Class 1" or "Ebike-Class 2." An Ebike is not a "moped" or a "motor driven cycle" as such terms are defined in 625 ILCS 5/1-148.2 and 625 ILCS 5/1-145.001 of the Illinois Vehicle Code. For purposes of this ordinance, the term "Ebike" does not include a "Class 3 low-speed electric bicycle" which is a low-speed electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 miles per hour.</u>
- 4. <u>"Ebike-Class 1" means a low-speed electric bicycle equipped with a motor that provides</u> assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 20 miles per hour.
- 5. <u>"Ebike-Class 2" means a low-speed electric bicycle equipped with a motor that may be</u> <u>used exclusively to propel the bicycle and that is not capable of providing assistance when</u> <u>the bicycle reaches a speed of 20 miles per hour.</u>
- B. <u>General:</u>
  - 1. <u>Persons may operate a bicycle or Ebike only on Bicycle Trails and must not operate a bicycle or Ebike on any other District property, unless authorized by the General Superintendent.</u>
  - 2. <u>No person may operate an Ebike on single track trails unless authorized by the General</u> <u>Superintendent.</u>
  - 3. <u>Persons operating bicycles and Ebikes must ride within the designated lane on the Bicycle</u> <u>Trail as indicated by signs or notice, or if no specific lane is designated, on the right-hand</u> <u>side of such Bicycle Trail.</u>
  - 4. <u>No person may operate a bicycle or Ebike more than two (2) abreast or side by side on any area designated for bicycle use.</u>
  - 5. <u>Persons operating a bicycle or Ebike shall walk or ride such bicycle or Ebike in single file</u> when approaching or overtaking another bicyclist, pedestrian or equestrian.
  - 6. <u>No person may operate a bicycle or Ebike while carrying another person on the handlebars, frame or fender, or so ride on a bicycle or Ebike, except in a suitable seat attached to such bicycle or Ebike for such purpose.</u>
  - No person may operate any bicycle or Ebike in any manner that endangers the safety of other persons or property, including, without limitation, other bicyclists and trail users, and taking into consideration, without limitation, weather; Bicycle Trail conditions, surfaces, hills, curves, intersections; and other bicycle, Ebike, pedestrian, and/or equestrian traffic.
  - 8. No person may operate any bicycle or Ebike in excess of a posted speed limit, or in the

absence of a posted speed limit, at a speed in excess of fifteen (15) m.p.h.

- 9. No person shall ride their bicycle or Ebike while it is attached to a moving vehicle.
- 10. The operator of a bicycle or Ebike shall yield the right-of-way to all pedestrians and equestrians on Bicycle Trails and follow all traffic rules, and shall walk their bicycle or Ebike in all areas where bicycle or Ebike riding is not specifically allowed by the General Superintendent, as indicated by sign or notice.
- 11. <u>The operator of a bicycle or Ebike shall give an audible warning, by horn, bell, voice or otherwise, when approaching any pedestrian from behind.</u>
- 12. No person may operate any Ebike-Class 3 or Class 3 low-speed electric bicycle.
- 13. <u>No person may operate any electrically powered scooter, unicycle, hoverboard or similar</u> electrically powered recreational device.
- 14. No person may operate any gas powered bicycle.
- 15. <u>This section does not prohibit any person with mobility impairment(s) from using an</u> electronic personal assistive mobility device in accordance with District policy.
- 16. <u>Any person in violation of this Section 4-3-1(B) shall be fined not less than seventy-five</u> dollars (\$75.00) or more than five hundred dollars (\$500.00) for each offense.
- C. <u>Helmets:</u> The District does not require but strongly recommends that no person shall operate a bicycle or Ebike on District property, particularly minor children age fourteen (14) and under, unless that person is wearing a properly fitted and fastened protective helmet that meets the standards promulgated by the United States Consumer Product Safety Commission. This recommendation also applies to a person in a restraining seat that is attached to the bicycle or Ebike, or in a trailer towed by the bicycle or Ebike.

A. General: Persons may operate a bicycle only on paths, trails, roadways or other areas designated for bicycle use. Persons operating bicycles must ride on the right hand side of such path, trail, roadway or other area designated for bicycle use by the General Superintendent. Not more than two (2) bicycles shall be operated abreast or side by side. No person may operate a bicycle while carrying another person on the handlebars, frame or fender, or so ride on a bicycle, except in a suitable seat attached to such bicycle for such purpose. No person may operate a bicycle in a reckless manner so as to endanger pedestrians. No person shall cling or attach himself/herself or his/her bicycle to any other moving vehicle. The operator of a bicycle shall walk his/her bicycle in all areas where riding is prohibited by the General Superintendent, as indicated by sign or notice. The operator of a bicycle shall give an audible warning, by horn, bell, voice or otherwise, when approaching any pedestrian from behind. Any violation of this Section 4.3.1.A. shall be fined not less than seventy five dollars (\$75.00) or more than five hundred dollars (\$500.00) for each offense.

- D. B. Motorized Bicycles: Persons may not use or ride within the District any electric or electric assisted bicycle capable of exceeding a speed of fifteen (15) miles per hour. Any violation of this Section 4 3 1.B. shall be fined not less than seventy five dollars (\$75.00) or more than five hundred dollars (\$500.00) for each offense. This section is not intended to prohibit any person with mobility impairment(s) from using an electronic personal assistive mobility device.
- E. C. Helmets:

- F. 1. No person age fourteen (14) or under shall operate a bicycle nor ride upon a bicycle on Cook County Forest Preserve property, bikeway, or trail unless that person is wearing a properly fitted and fastened protective helmet that meets the standards promulgated by either: The American National Standards Institute, the American Society for Testing, the United States Consumer Product Safety Commission, or the Snell Memorial Foundation, Inc., or standards subsequently established by those entities. This requirement also applies to a person who rides upon a bicycle while in a restraining seat that is attached to the bicycle or in a trailer towed by the bicycle.
- G. 2. A violation of Section 4.3.1.C. of this Ordinance No. 15.0256, is an infraction punishable by the following: first violation will be a warning; second violation will be a fine of ten dollars (\$10.00); and each additional violation will be a fine of twenty five dollars (\$25.00). The parent or legal guardian having control or custody of an unemancipated minor age fourteen (14) or under whose conduct violates this Ordinance No. 15.0256 shall be jointly and severally liable with the minor age fourteen (14) or under for the amount of the fine imposed.
- H. 3. Fines collected for a violation of Section 4.3.1.C. of this Ordinance No. 15.0256 shall be deposited in a special account of the Cook County Forest Preserve District to be used for bicycle safety education and for assisting low income families in obtaining approved bicycle helmets for children under the age of fourteen (14) years.
- I. 4. The Cook County Forest Preserve District shall create and implement a bicycle education safety program that at a minimum includes: Outreach to schools; development and distribution of an informational brochure; placement of safety information on the District's website; appropriate signage in Forest Preserves; and four (4) educational programs per year.
- J. 5. The Cook County Forest Preserve District Board of Commissioners has a desire to assure that all children have access to bicycle helmets regardless of their economic situations. To address this concern, the Forest Preserve District will develop a bicycle helmet rebate program in partnership with appropriate non profit groups for qualified, low income applicants. Proof of income, residency, and purchase must be provided. Eligibility for this program is based on Federal Poverty Guidelines.
- K. 6. To support this rebate program, the District will establish a designated account that can accept charitable donations and look for private, corporate, and organizational partners that would be willing to make financial contributions to the program. Additionally, fines collected for violations of Section 4.3.1.C. of this Ordinance No. 15.0256 can be used for the rebate program.

Effective date: This ordinance shall be in effect May 1, 2021.

## **PROPOSED LICENSE REQUEST**

**Request:** Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves"), as Licensor to grant a License to the Village of Crestwood ("Crestwood"), Grantee, to locate, operate and maintain a trunk storm sewer and drainage basin in Rubio Woods near the southwest corner of 135th Street and Central Avenue as part of a larger flood control project with the Metropolitan Water Reclamation District. The proposed stormwater infrastructure will replace an existing earthen berm of unknown origins that was placed on Forest Preserves land decades ago south of 135th Street behind the residential homes along South End Lane.

The trunk storm sewer and adjacent basin would occupy a license area of approximately 11,202 square feet (0.26 acres).

**Term:** Ten (10) Years

**License Fee:** \$23,144.63

License Application Fee: \$500.00

License Review Fee: \$3,000.00

**YELAR Fee:** \$6,750.00

Total one-time upfront fee of \$33,394.63 for the term of the License (Sec. 5-2A-4 and 5-2B-4)

Additional Benefits: As conditions of this license, Crestwood has also agreed to:

- improve approximately 100,721 square feet (2.31 acres) of adjacent Forest Preserves land by removing an existing berm and restoring this land within 12 months after the trunk sewer is completed;
- (2) pay associated construction access permit fees in 2022 for berm removal and associated tree removal, estimated at \$31,887.08 for a 60-day construction period, and estimated at \$96,029.74 for removal of 21 trees;

- (3) pay construction access permit fees in 2021, estimated at \$7,224.31 for a 60-day period for staging of construction equipment and some berm removal on an estimated 21,273 square feet (0.49 acres) adjacent to the trunk sewer;
- (4) mow previously-mowed portions of Forest Preserves land on a specified parcel south of the proposed trunk sewer on an annual basis until it is under active restoration management by the Forest Preserves;
- (5) survey the boundary and install markers at the property line with adjacent residential properties; and
- (6) provide advance notice and information to adjacent homeowners prior to future removal of the berm.

The area of the License is: estimated at 0.257 Acre

## PROPOSED AGREEMENT

Vendor: Antares Golf Management, Inc. (formerly Billy Casper Golf), Reston, Virginia

**Request**: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into an agreement

**Reason**: Antares Golf Management, Inc. (formerly Billy Casper Golf) ("Operator") manages the Forest Preserves' ten (10) golf courses and one (1) stand-alone driving range through a Golf Course Facilities Management Agreement (the "Golf Agreement") which expires on 12/31/2022. As part of the Golf Agreement, the Operator is required to provide a fleet of motorized golf carts ("Golf Carts") for rental and use by consumers. The Operator leases these Golf Carts pursuant to lease agreements, all of which will expire in 2020 (the "Existing Leases"). The optimal operating lease term from a reputable, national manufacturer is five (5) years; however, this term extends beyond the expiration of the Golf Agreement. The Golf Agreement provides an option for the Forest Preserves to assume any lease or financing held by the Operator for equipment at the end of the contract term.

The Forest Preserves proposes to authorize the Operator to lease <u>up to</u> four hundred and thirty-two (432) golf carts for five (5) years from reputable, national manufacturers to commence upon the expiration of the Existing Leases. Operator will leverage current pricing advantages and deliver quotes to the Forest Preserves which represent the best pricing and financing terms available to the Operator. Upon review and approval of the quotes by the Forest Preserves, the Forest Preserves and Operator will jointly enter

into and execute five (5) year operating leases of Golf Carts to commence upon the expiration of the Existing Leases ("New Leases") and any short-term extensions thereto. The Forest Preserves would sign the New Leases as a co-lessee, with the understanding that the responsibility for such leases would be transferred to the next competitively selected golf course operator. The Forest Preserves of Cook County Board of Commissioners approved a similar arrangement for seventy-four (74) golf carts at George Dunne (Agenda No 20-0251). The New Leases would be subject to legal review and approval.

# PROPOSED AGREEMENT

Vendor: Antares Golf Management, Inc. (formerly Billy Casper Golf), Reston, Virginia

**Request**: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into an agreement

**Reason:** Antares Golf Management, Inc. (formerly Billy Casper Golf, Inc.) ("Operator") manages the Forest Preserves' ten (10) golf courses and one (1) stand-alone driving range through a Golf Course Facilities Management Agreement (the "Golf Agreement") which expires on December 31, 2022. As part of the Golf Agreement, the Operator is required to provide a fleet of motorized golf carts ("Golf Carts") for rental and use by consumers. The Operator leases these Golf Carts pursuant to lease agreements, all of which will expire in 2020, subject to any short-term extensions (the "Existing Leases"). Due to current regulations issued by the State of Illinois in response to the COVID-19 pandemic, multiple person use of golf carts is limited. As a result, the Operator seeks to lease seventy-four (74) additional electric golf carts to supplement its existing fleet and provide more capacity. The optimal operating lease term from a reputable, national manufacturer is five (5) years; however, this term extends beyond the expiration of the Golf Agreement. The current Golf Agreement provides an option for the Forest Preserves to assume any lease or financing held by the Operator for equipment at the end of the contract term.

The <u>Forest Preserves proposes to authorize proposed agreement authorizes</u> the Operator to lease <u>up to</u> seventy-four (74) Lithium Ion electric golf carts for five (5) years from a reputable, national manufacturer. Operator will leverage current pricing advantages and deliver a quote to the Forest Preserves which represent the best pricing and financing terms available to the Operator. Upon review and approval of the quote by the Forest Preserves, the Forest Preserves and Operator will jointly enter into and execute the five (5) year operating lease. The Forest Preserves would sign the lease as a

co-lessee, with the understanding that the responsibility for such lease would be transferred to the next competitively selected golf course operator. The lease agreement would be subject to legal review and approval.

**Summary:** In July 2012, state legislation authorized the Forest Preserves of Cook County (the "Forest Preserves") to establish provisions to address the underuse of minority and women-owned businesses with respect to procurement contracts. An ordinance establishing the program's parameters and guidelines was passed by the Forest Preserves of Cook County Board of Commissioners in September 2012. This initiative is significantly benefitting the residents of Cook County by increasing the pool of qualified minority and women-owned businesses that have the opportunity to be selected for contracts awarded by the Forest Preserves each year.

To remedy historic inequity and to facilitate greater inclusion, the Forest Preserves established aspirational contract goals for the participation of minority and women-owned businesses as set forth under the Forest Preserve District of Cook County Code of Ordinances.

The Minority and Women-Owned Businesses program accomplishments in FY 2020 include awarded contracts achieved 48% minority and women-owned businesses participation; and 47% of contract payments were made to minority and women-owned businesses either as prime contractors or sub-contractors.

# AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR GLENWOOD WOODS

**AN ORDINANCE CREATING A FOREST PRESERVE** in part of Section 4, Township 35 North, Range 14, East of the Third Principal Meridian, all in Cook County, Illinois near Glenwood Woods in District 6.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the "District"), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands connecting such forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof; and

BE IT ORDAINED by the Board of Commissioners of the District as follows:
