I would like to offer written testimony regarding numerous benefits, both direct and indirect, regarding ecological restoration efforts in Cook County Forest Preserves. I have volunteered for the county in this effort since 2013, and I have been a Volunteer Steward at the Cap Sauers Holdings site since 2015.

Benefits I think are important are listed below:

- Free outdoor space for the public to enjoy nature. As our restoration efforts continue to enhance areas in Cap Sauers Holdings, people visiting the area thank us for our efforts. The site also has greatly benefited from a \$250,000 donation towards restoration work from a wealthy donor who lives near the site. He asked me what I was doing one day, liked the idea, spoke with FP ecologists who were at the site one day, and then ended up making the donation. Additional restoration work through his donation has greatly enhanced this site to for more diversity of plants and wildlife (more bald eagle sightings, too!) Many people we meet on the trail have commented on noticeable improvements. Before the recent election, I approached many people in the preserves about the FP referendum, whether they were walking, biking, or riding horses, and all were in favor of the small increase in their property taxes.
 - Excellent resource for school children; occasionally we include school groups from Chicago in our workdays, when arrangements have been made, and paperwork completed, between school officials and Forest Preserve officials. It is a delight to have children come out to see these areas. We hope they return either to volunteer again, or to visit with their families.
 - Increased safety; before I started volunteering, I sometimes hiked trails in the Palos area near my home, and areas where thick brush grew on both sides of the trail felt creepy and unsafe. I would make sure to go out when other trail users were out as well, but I felt uneasy walking by thick areas of nonnative invasive brush. The brush has now been removed from many areas. When a fellow volunteer (male) commented to me recently that it looked as if more women were feeling okay walk trails alone these days, I told him it is because it feels safer now, when we do not have to walk by brush so thick we cannot see into it. He had not thought of the feeling of safety from his perspective, but I think the safety issue is important to note, and a nice side effect of restoration work.
 - Less illegal use of Forest Preserve property; as a result of ecological restoration efforts for the same reason as above. Natural habitats are more open and make it difficult to hide illegal activities. In Cap Sauers Holdings, for example, contractor work in one part of the site in 2016 uncovered evidence of an illegal marijuana growing operation. It would be extremely difficult for such an operation to operate secretly in this area today.
 - Good opportunity for public outreach. I often hiked with a hiking group through Forest Preserves before volunteering, and we sometimes commented on the great value we receive from our property taxes for supporting these areas.
 - National recognition; my adult daughter, in her 30s, is a Corporate Strategist for a company based in Seattle, Washington. She regularly attends corporate meetings there in person. Corporate officers wondered when she mentioned she sometimes spends free time walking in nature areas near Chicago. Seattle has "in your face" nature with Mt. Rainier and Cascade Mountains in plain sight, so they were impressed and surprised when she explained how many natural areas and miles of hiking trails are in the Chicago area.
- In conclusion, I am proud to be a resident of Cook County where commissioners many years ago had the foresight to save these natural areas, and I very much appreciate the opportunity to volunteer in current endeavors.

Greetings to the Commissioners. The following is a statement explaining my support for the Forest Preserves of Cook County.

I have lived in Cook County my whole life and have been involved with the Forest Preserve District of Cook County since I was a little girl going on family outings. We visited places such as Little Red Schoolhouse Nature Center, where I began to learn about the plants and animals that form the ecosystem in which we live. These experiences made a deep impression, so that later I took my own children to visit places like Thatcher Woods and Trailside Museum in River Forest. More than twenty years ago, I began to volunteer at Thatcher Woods, helping the stewards clear out invasive buckthorn and garlic mustard. We also picked up a great deal of trash! While doing this, the site stewards and other experienced volunteers taught us new volunteers a great deal of botany as well as practical restoration skills. As I learned about and helped care for the woods, I made friends, some of whom I volunteer with to this day. I took advantage of FPD classes, with the goal of becoming a site steward myself. Other site stewards and FPD Volunteer Resources staff mentored me as I developed qualifications.

Owing to work and family responsibilities, reaching this goal took many years. However, once I was qualified to lead workdays, I combined my work as an instructor at Triton College with volunteering by leading groups of students in various projects. Restoration workdays, ecology walks, and clean-up events added to their educational experience. When I retired during the early days of the pandemic, Volunteer Resources invited me to serve as an apprentice steward at National Grove Woods in North Riverside. Of course, I said yes. It is a small preserve, a floodplain forest next to the Des Plaines River, full of ancient trees and wildflowers that are especially colorful in spring. During lockdown, even though I couldn't run public workdays, my husband and I frequently took walks, and were able to do some restoration work ourselves. We relished the freedom and sense of purpose that being outdoors and caring for the woods brought during that terrible time. We often encountered others on the trails and by the river, who also found walking in nature inspiring and of comfort.

Once lockdown ended, I began hosting regular workdays. I have recruited a group of devoted volunteers, who have put their energies into helping restore this beautiful woodland. We are all truly proud of the progress we've made. I also continue to help out at other Preserves, including Thatcher Woods. After being mentored by, and partnering with, other stewards, I became a full site steward in 2022 – a proud day in my life. This is my vocation now. I am grateful to have the opportunity to make a difference by contributing to the common good.

The Forest Preserves are a valuable and important part of Cook County. They improve the quality of life for our residents and make our environment better. Their existence elevates Cook County beyond many other metro regions in the United States. I am proud to be a volunteer. Thank you to the Commissioners for understanding the Preserves' importance and for doing the work to help them thrive.
