Dear Chairwoman Toni Preckwinkle and the Honorable Cook County Board of Commissioners,

On behalf of the Illinois Soybean Association and our 43,000 farmers in Cook and state-wide, I am writing to express our upmost support for Resolution #23-1426.

Farmers all over the state, including those who care for the 12,000 acres of farmland that fall within Cook County's boundaries, know the importance of agriculture in our food systems, as a major economic driver, and as an asset in virtually every other industry where people are moving, eating, and building throughout Illinois.

Soybean producers know first-hand of the importance their crop brings to the state, producing goods that feed the neighborhood corner-store patrons who need a milk alternative all the way over to Egypt where aquaculture scientists are finding new and sustainable ways to feed their fish. Our partners in agriculture know the weight we carry with every crop we sow, as it's what we plant in the ground that ultimately keeps our population alive, healthy, and well. Illinois' economy is growing in strength by the day, largely due to various agricultural commodities we export to feed and fuel the country and our world. Cook County is ranked second in the state for equine production with a sales volume of over 1.5 million dollars. Good jobs, business opportunities, and international capitol start and end in the field, with soybeans being a major economic driver for the state and, for the 9th year in a row, Illinois leads the nation in soybean production. Many people look to farms and agribusiness as corporate and sterile because of the massive business output they produce year after year; however, we know that 96% of farms are family owned. Generations of families have committed to feeding our nation, and the world, because the food that goes in your bellies, goes in ours as well.

We stand in solidarity with partners in agriculture and believe that the future of agriculture in Cook County is OUR future.
