PROPOSED RESOLUTION

RECOGNIZING THE DEDICATION OF JENS JENSEN GRASSLAND AND WOODLAND AS AN ILLINOIS LAND AND WATER RESERVE BY THE ILLINOIS NATURE PRESERVES COMMISSION

WHEREAS, on January 24th, 2017, at the 225th meeting of the Illinois Nature Preserves Commission, Jens Jensen Grassland and Woodland was approved for dedication as an Illinois Land and Water Reserve; and

WHEREAS, dedication of a site as an Illinois Land and Water Reserve provides a high level of protection for land in Illinois, and is granted only to natural areas of regional and state-wide ecological significance; and

WHEREAS, Jens Jensen Grassland and Woodland Land and Water Reserve is an approximately 220 acre, high quality portion of the larger Jens Jensen preserve also known as Deer Grove East located in the Village of Palatine in northwest Cook County. The site consists of remnant mesic woodlands and sedge meadows, along with reconstructed prairie and wetlands supporting 398 species of native plants and 25 bird species recognized as species in greatest need of conservation; and

WHEREAS, the namesake for this designation is Jens Jensen, a devout conservationist who was instrumental in the creation of the Forest Preserves of Cook County; and

WHEREAS, extensive restoration has been underway at the site since 2007 in partnership with Openlands as a part of an O'Hare Modernization Mitigation Account project, which provides mitigation of off-site wetland impacts resulting from the O'Hare Modernization Program; and

WHEREAS, this large-scale habitat restoration initiative was undertaken in conjunction and in cooperation with the Chicago District of the U.S. Army Corps of Engineers and the Chicago Department of Aviation; and

WHEREAS, restoration efforts have focused on restoring hydrology in degraded wetlands and adjacent uplands, as well as the removal of invasive brush and vegetation impacting the site via prescribed fire and reintroduction of native plants; and

WHEREAS, storm water modeling that encompassed the Jens Jensen Grassland and Woodland Land and Water Reserve has shown a significant increase in the amount of storm water staying on site because of the previously mentioned hydrologic and plant community restoration activities; and

WHEREAS, Jens Jensen Grassland and Woodland Land and Water Reserve has also benefitted from extensive long-term volunteer stewardship by the Deer Grove Natural Area Volunteers, whose countless hours of service and dedication have helped make the site what it is today and will help it continue to thrive into the future; and

WHEREAS, dedication of Jens Jensen Grassland and Woodland as a Land and Water Reserve advances the goal set forward in the Next Century Conservation Plan to dedicate 20,000 acres as Illinois Nature Preserve protected land by 2025.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Forest Preserves of Cook County does hereby acknowledge this momentous dedication and the Forest Preserves' steadfast commitment to protect and restore our region's significant natural resources; and

BE IT FURTHER RESOLVED, that a suitable copy of this resolution be presented to the Deer Grove Natural Area Volunteers, Openlands, the Chicago District of the U.S. Army Corps of Engineers, and the Chicago Department of Aviation as a token of appreciation for their service to the Forest Preserves and the residents of Cook County.

PROPOSED RESOLUTION**RECOGNITION OF THE *BIRD THE PRESERVES* INITIATIVE, A SUCCESSFUL COLLABORATION TO CONNECT PEOPLE WITH THE FOREST PRESERVES OF COOK COUNTY**

WHEREAS, the Forest Preserves of Cook County's nearly 70,000 acres of natural lands are home to some of the nation's most biologically diverse flora and fauna, including nearly 300 types of resident and migrant birds, both common and unusual, that depend on Forest Preserves' habitat; and

WHEREAS, birding is one of the most popular recreational activities in America and can serve as a gateway activity to a greater connection with the natural world, and is an excellent way to introduce people to the forest preserves, providing a positive, healthy, and fun experience in nature; and

WHEREAS, Bird the Preserves is an initiative that connects diverse communities to the Preserves by expanding birding programs and activities, celebrating the migration stories that people and birds share, and establishing the Preserves as a premier birding destination in the Chicago Wilderness region; and

WHEREAS, the U.S. Fish and Wildlife Service through Chicago Wilderness provided federal funding to the Preserves to launch the Bird the Preserves initiative in 2016; and

WHEREAS, over 17 partner organizations representing birding clubs, non-profits, and government agencies worked together to successfully implement the Bird the Preserves initiative throughout 2016, holding more than 220 bird walks and related events; and

WHEREAS, the Bird the Preserves initiative included a Big Year competition, a yearlong friendly contest where teams from throughout Cook County adopted different preserves and competed to find the most bird species and recruit the most new birders at that preserve. The Chicago Botanic Garden and Brookfield Zoo also formed teams and promoted the initiative; and

WHEREAS, the Big Year was a resounding success and had 21 official teams that spotted a total of 253 species of birds and had an estimated 2,400 people participate in bird walks and events--35% of whom were new birders, 35% had never birded in the forest preserves before, and over 190 unique zip codes were represented; and

WHEREAS, the Bird the Preserves initiative has proven so successful at connecting people with the Preserves, that the Preserves has sought and received additional funding from the Forest Preserve Foundation to incorporate elements of the Bird the Preserves initiative into the Preserves' permanent program offerings; and

WHEREAS, the initiative's successful communications and marketing campaign, led by the Preserves and partners, resulted in Bird the Preserves stories featured in nearly 20 online and print publications, on-air media coverage from FOX and WCIU's You and Me This Morning, a 593% increase in page views on the Preserves' birding webpage, and a major social media presence utilizing the hashtag #birdthepreserves; and

WHEREAS, Bird the Preserves is consistent with the goal of the Forest Preserves to increase connections between people and nature.

NOW, THEREFORE, BE IT RESOLVED, that we, the Board of Commissioners of the Forest Preserve District of Cook County, on behalf of ourselves and staff, do hereby congratulate the partners, Big Year teams, field trip leaders, staff, funders, and participants of Bird the Preserves on their success in launching a unique and influential initiative that can serve as a model for both the Forest Preserves and others; and

RECOGNIZING THE NAMING OF THREE (3) FOREST PRESERVES OF COOK COUNTY NATURE CENTERS TO AMERICANTOWNS MEDIA'S LIST OF THE 10 BEST NATURE CENTERS IN ILLINOIS

WHEREAS, Best of Illinois, a subsidiary of AmericanTowns Media, has compiled and published a list of "The 10 Best Nature Centers in Illinois"; and

WHEREAS, AmericanTowns Media is an online network of local lifestyle community guides that creates, curates, and distributes local content for over 29,000 communities across the United States; and

WHEREAS, nature centers are a valuable means of educating the public on the importance of preserving and respecting local natural areas, and encourage exploration and lifelong learning about our region's native habitats and wildlife; and

WHEREAS, Sand Ridge Nature Center, Crabtree Nature Center, and Little Red Schoolhouse Nature Center have each been named to this list of the ten (10) best nature centers in Illinois; and

WHEREAS, Sand Ridge Nature Center in South Holland stands on a 6000-year-old broad, low ridge of sand and water polished pebbles surrounded by 235 acres of woodlands, oak savannas and wetlands. The center features exhibits on the natural and cultural history of the Calumet region, and offers a number of special events annually, including Illinois Archaeology Day and Settlers' Day; and

WHEREAS, Crabtree Nature Center in Barrington Hills features 1,182 acres of woodlands, prairies, and wetlands which were shaped by glaciers and provide an important rest stop for migratory birds, attracting a wide variety of users and birding enthusiasts. Over 260 species have been recorded using these habitats, with at least 89 species breeding onsite; and

WHEREAS, Little Red Schoolhouse Nature Center in Willow Springs offers a glimpse into the historic past of the Palos Hills of southwestern Cook County. The center's grounds include attractions such as an orchard planted by early settlers in 1906, and an 1886 schoolhouse from which the center gains its namesake. The recently constructed visitor center features a variety of live animal exhibits and a children's activity room; and

Summary: Contract #17-31-105 is a Request for Proposals for professional engineering services to study, define, and propose practices to mitigate non-point source (i.e., stormwater runoff) pollution at the Powderhorn Lake site in Burnham. Understanding and mitigating stormwater impacts will allow the Preserves to improve and restore the hydrology of the site, thereby halting the degradation of this important native fish and migratory bird habitat. The Preserves received a total of four (4) proposals.

The Preserves assembled a review panel which consisted of various Preserve staff, who considered Hey & Associates' proposal the most responsive, with particular strengths in experience, expertise and performance capacity as it related to the work as requested in the contract specifications.

The project is being partially funded through a grant received from the Illinois Department of Natural Resources' Coastal Management Program, which was previously approved by the Board of Commissioners on 12/13/2016.
