Explanation: Why is this product or service the only one that would satisfy the requirement(s)? Stude GC is already the architect of record for a proposed office/training building and can update bid documents and vanous permits most expediducily and cost effectively to include a garage acciding now that new grant funding for this acciding has been identified in August 2019. Studio GC was hinted to design, secure permits and oversee construction for a proposed new maintenance office/training building and develop a master plan for the entire maintenance yard. During master planning, staff expressed a strong preference for a house garage acciding in July 2020, even though there was no funding for the garage acciding. In November 2020, the contract for construction of the office/training building only was awarded in late 2020 but then cancelled due to immediate supply chain issues. The plan was to watcut supply chain issues and reticing 2022 in September 2021, the Illinois DNR contacted PAD to invite us to apply for \$4.4 million Build Illinois Bond funds that will now fund construction of the new maintenance office building and garage accidion at the same time.	
Due Diligence. Describe the due diligence performed that led to the conclusion that this is a sole source.	
Consultant has performed extensive site specific storm water retention modeling for the office/training building and preliminary modeling for the garage addition and has been in contact with MWRD regarding the project. Adding/changing consultants at this time would increase time and costs to the project in an effort to coordinate with MWRD. This is also true for interactions with the Village of North Riverside and North Riverside Fire Department. The original RFP for this project was solicited publicly and seven (7) firms submitted proposals. A team of Forest Preserves Staff reviewed the proposals and determined Studio GC Inc., provided the most responsible and responsive proposal.
