**INTEROFFICE MEMORANDUM** 

On 1/26/2021, Resolution 21-0125 was proposed and adopted by the Board of Commissioners of the Forest Preserves of Cook County that grants the General Superintendent the authority to approve and execute utility agreements recommended by Ameresco. Ameresco, Inc is the consultant to the Forest Preserves for managing the institution's energy portfolio (Agenda No. 20-0363). Included in the approval of Resolution 21-0125 is a requirement to report on an annual basis, no later than the first Committee on Finance meeting after March 1st, a report covering all payments made pursuant to such Energy Contracts during the prior calendar year.

Constellation New Energy supplied electricity to the preserves at a wholesale rate structure for ten months in 2023 before we switched to Interstate Gas Supply, LLC. ComEd was paid directly in the time it took to switch services. Renewable Energy Credits (RECs) offset 100% of our electricity use in 2023. Constellation New Energy supplied all-natural gas to the Forest Preserves of Cook County in 2023.

The following tables present to the Board of Commissioners the financial expenditures for Ameresco services, electricity, and natural gas used by the Forest Preserves during the 2023 calendar year.
