IV. General Overview of Governing Statutes, Ordinances, Rules, Procedures, Powers, Jurisdiction

Mission

"To acquire, restore and manage lands for the purpose of protecting and preserving public open space with its natural wonders, significant prairies, forests, wetlands, rivers, streams, and other landscapes with all of its associated wildlife, in a natural state for the education, pleasure and recreation of the public now and in the future." (Source: https://fpdcc.com/about/mission-history/)

Background

"On November 3, 1914, the residents of Cook County voted in favor of establishing a forest preserve district whose boundaries would be analogous to the boundaries of Cook County. The Forest Preserve District of Cook County (generally referred to herein as the Forest Preserves of Cook County or Forest Preserves) was established on November 30, 1914 and the first meeting of the Board of Forest Preserve Commissioners was February 11, 1915.

On June 25, 1916 the first lands were obtained—500 acres of what is now known as <u>Deer Grove</u>—and by the end of the 1930s, the Forest Preserves held a total area of 33,000 acres. During this time, the Forest Preserves also worked to expand services for patrons. By 1920, the Forest Preserves created a special "Golf Committee" charged with setting aside land for golf courses and hiring concessionaires to serve golfers, and by the early 1930s, the Forest Preserves had begun construction on roads, walking trails and recreational facilities.

During the Depression, the influx of funds and labor through the New Deal's Civilian Conservation Corps, Public Works Administration, and the Works Progress Administration increased the pace of these improvements. In the *WPA Guide to Illinois, The Federal Writers' Project Guide to 1930s Illinois*, the authors wrote, "Within [the Cook County Forest Preserves] lie more than 150 miles of hiking trails, 40 miles of bridle paths, and special facilities ranging from ski and toboggan slides to swimming pools. Only a few minutes out of the city, they are extensively used by picnickers, hiking and nature study clubs, and those merely seeking a brief respite from the roar and clamor of the metropolis."

In 1934, the <u>Chicago Zoological Society opened the Brookfield Zoo</u> on land donated to and purchased by the Forest Preserves, and in 1972 the <u>Chicago Horticultural Society opened the Chicago Botanic Garden</u> on Forest Preserves land in Glencoe. Both the Zoo and Garden remain close partners with the Forest Preserves, which helps support the institutions and shares their mission of preserving and providing education about the natural world.

The Zoo grounds are located on 216 acres and include outdoor and indoor habitats for a vast array of animals, some of which are critically endangered. With its world-renowned plant collections and displays, the Garden is one of the most visited public gardens in the world. Both are preeminent centers for learning and scientific research.

Over the decades, as the scientific community's understanding of native ecosystems evolved, the Forest Preserves has also expanded its commitment to protecting and restoring the habitats in our

<u>care</u>. After World War II, the Forest Preserves created the Department of Conservation (now the Department of Resource Management), influenced by <u>Aldo Leopold's land ethic</u>, which outlines the human responsibility to the natural world. <u>The first prairie restoration</u> was implemented at Camp Sagawau in 1965, and in 1996 the Forest Preserves helped found Chicago Wilderness, a coalition dedicated to protecting nature in the region.

In 2014, the Forest Preserves released the Next Century Conservation Plan (NCCP), an ambitious blueprint for making Cook County a national leader in urban conservation. The NCCP calls for massive restoration and expansion of protected lands, as well as a commitment to making the preserves more accessible to the diverse people of Cook County. The following year, the Forest Preserves released the Natural and Cultural Resources Master Plan, which provides the guidance needed to implement the NCCP's natural resource goals. It also lays out a natural and cultural resources framework for future land acquisition, recreation development and capital improvement.

Much has changed in the more than 100 years that the Forest Preserves has been serving the residents of Cook County, but we continue our commitment to the county's natural wonders and the "education, pleasure and recreation of the public now and in the future."" Governance

Statutory Framework

The Forest Preserves is governed by its enabling statute, 70 ILCS 810/0.01 et. seq. There are other Illinois statutory provisions applicable to the Forest Preserves, such as, without limitation, the Illinois Pension Code, Property Tax Extension Limitation Law, and Forest Preserve District and Conservation District Design-Build Authorization Act.

Board of Commissioners

The Forest Preserves of Cook County is governed by the President and its Board of Commissioners. Per 70 ILCS 810/5, "[t]he county board of commissioners of the county in which a forest preserve district is located shall be the forest preserve district board of such district and the president of the county board shall be the president of the forest preserve district board. The members shall act without any other pay than that already provided by law." Thus, the elected President and seventeen (17) commissioners of the Cook County Board of Commissioner are by virtue of their offices also the President and Board of Commissioners for the Forest Preserves of Cook County. Commissioners must reside within the boundaries of their district. The President and Commissioners are elected for their Cook County offices every four (4) years, with the next election to be held in 2026. Upcoming meetings of the Forest Preserves of Cook County Board of Commissioners are available here. The Board operates subject to the requirements of the Illinois Open Meetings Act.

Tax Structure

The Forest Preserves of Cook County is a separate and distinct taxing body within Cook County (see 70 ILCS 810/22). Because the Forest Preserves of Cook County is a separate unit of local government, the revenues it generates can only be used for Forest Preserves of Cook County

purposes. This assurance is contrasted with general purpose governments like cities, villages, and counties that provide a multitude of services such as fire, public works, economic development, etc.

Referendum

In November of 2022, Cook County voters authorized a 0.025% increase in the preserves' property tax levy, raising an additional \$40 million to be used to expand and improve the benefits of the Forest Preserves, including the following:

- Acquire and protect more natural open land for the enjoyment of generations to come.
- Protect and restore wildlife habitat that is home to native plants and animals, some of which are threatened or endangered.
- Increase programs and events for the public and schools, including more outreach to communities from every part of Cook County.
- Expand and maintain trails, improve signage, and make amenities more energy efficient and accessible to all.
- Resolve the Forest Preserves' pension shortfall.
- Address the deferred capital needs of the <u>Brookfield Zoo</u> and <u>Chicago Botanic</u> Garden.

Good Governance and Best Practices

The Forest Preserves receives an estimated 62 million visits each year, providing an escape into a world teeming with wildlife and rich with <u>outdoor recreation</u> and <u>environmental education opportunities</u>¹. Schools or other Organizations can contact the Forest Preserves for guided talks, walks and programs. FPCC primarily provides programming for school at its sites but can do some in school programs as well. FPCC's Mighty Acorns program is part of a regional initiative to develop environmental educators who use the outdoors as a classroom. The Mighty Acorns program is a five year program focused on grades 3-5. These activities include:

The Forest Preserves runs a Conservation@Home program that encourages gardeners and other landowners to use forest friendly gardening techniques when managing their properties. Together with the University of Illinois Extension we host workshops, tabling events, a plant sale and a program where Cook County residents can get advice and their garden certified as a Conservation@Home garden. There are 166 gardens in Cook County certified as Conservation@Home. The Nature Conservancy Foundation started the Conservation@Home Program.

VI. Other Examples of Efficient Operations

Conservation Corps

Conservation Corps programs provide paid employment for youth and adult participants from across Cook County's diverse communities—including those with barriers to employment, those who have suffered from historical disenfranchisement, and those whose communities are

disproportionately impacted by environmental justice issues. Conservation Corps programs receive financial and/or training support from the Forest Preserves to engage the next generation of conservation leaders in hands-on ecological restoration work. Programs feature environmental education and soft skills training to prepare participants for future employment and connect communities to nature.

These programs engage approximately 300 participants annually. In 2023, a total of 289 participants logged over 57,108 service hours. Cumulatively, since 2005 the Conservation Corps have engaged 3,365 participants who have provided 795,208 service hours to the Forest Preserves.

Partnerships

Managing the Forest Preserves' nearly 70,000 acres of natural lands requires unprecedented levels of collaboration with other government agencies, contractors, public interest groups and community organizations. NeighborSpace

The Forest Preserves, along with the City of Chicago and the Chicago Park District, establish NeighborSpace as a non-profit in 1996 in order to preserve and expand open space for all residents in the city to enjoy. The Forest Preserves, through its Conservation & Experiential Programming (CEP) department makes great strides to partner with community organizations, schools, parks and other entities. CEP works with hundreds of new and repeat partners every year in a variety of ways. We count many collaborations and partnerships all with the goal of connecting the people of Cook County and beyond to nature. Conservation Corps programs provide paid employment for youth and adult participants from across Cook County's diverse communities—including those with barriers to employment, those who have suffered from historical disenfranchisement, and those whose communities are disproportionately impacted by environmental justice issues. Conservation Corps programs receive financial and/or training support from the Forest Preserves to engage the next generation of conservation leaders in hands-on ecological restoration work. Programs feature environmental education and soft skills training to prepare participants for future employment and connect communities to nature. These programs engage approximately 300 participants annually. In 2023, a total of 289 participants logged over 57,108 service hours. Cumulatively, since 2005 the Conservation Corps have engaged 3,365 participants who have provided 795,208 service hours to the Forest Preserves.

Managing the Forest Preserves' nearly 70,000 acres of natural lands requires unprecedented levels of collaboration with other government agencies, contractors, public interest groups and

community organizations. Over the past decade, we've forged hundreds of partnerships for cooperative land management, intergovernmental training, native seed enhancement, archaeological protection initiatives, and much more. Some of our most prominent partnerships have been in the field of wildlife research, including the Urban Coyote Research Project – North America's longest running urban coyote research program—and more recently the inaugural Illinois Zoological and Wildlife Health Management Residency program. Other partnerships have resulted in the development of major defining moments in the Forest Preserves' land management policies, such as the development of the Natural and Cultural Resources Master Plan, which initiated the comprehensive assessment and prioritization the Forest Preserves' open spaces.

The Forest Preserves selectively issues licenses to share facility workspace with several other governmental entities. These mutually beneficial relationships promote intergovernmental collaboration and efficiency pertaining to natural and culture resource regulations and offer state conservation police a base from which to better enforce species-protection laws in our region.

The Forest Preserves coordinate and host a series of environmental education programs aimed at providing ongoing training and enrichment opportunities for staff. These programs feature a wide range of conservation topics, including equipment use, best management practices, and often provide continuing education units (CEUs) for upkeep of professional licenses or certifications. Certain programs are made available to volunteers, partners, and the public. In 2023, the Department of Resource Management hosted 244 programs reaching over 4,000 people. That number expands to 2,147 programs since 2015.

The Forest Preserves feature wonderous natural habitats that support a wide variety of flora and fauna—including over one hundred threatened and endangered species. Our region is extremely biodiverse, making the Forest Preserves an ideal destination and natural laboratory for researchers studying nature in an urban environment. Hundreds of students and scientists have focused their studies on Forest Preserves property or collaborated directly with the Forest Preserves to advance our knowledge of the natural world. Research investigations include any monitoring, collecting, testing, study, observation, investigation or other related activity that benefit the Forest Preserves, public education or the community. Staff in the Department of Resource Management additionally host field practicums for college and high school students on the topics of wildlife research, prescribed fire, and advanced aquatic ecosystems. These programs allow students to work alongside the Forest Preserves' biologists to gain hands-on training and field experience.

Last year, the Forest Preserves recorded 21,443 volunteer engagements which in turn logged 98,487 hours of volunteer service to the Forest Preserves.

The Forest Preserves, along with the City of Chicago and the Chicago Park District, establish NeighborSpace as a non-profit in 1996 in order to preserve and expand open space for all residents in the city to enjoy. These founding groups charged the organization with the mission to acquire vacant lots and other properties to ensure their continued survival and use by

community gardeners. These three governmental agencies continue to provide leadership and financial support to protect community-managed open spaces in Chicago. NeighborSpace is the only nonprofit urban land trust in Chicago that preserves and sustains gardens on behalf of dedicated community groups.

IX. Recommendations for Increased Accountability and Efficiency

The Forest Preserves of Cook County is dedicated to the principles of government transparency and efficient use of taxpayer dollars. In 2022, voters showed their trust in the Forest Preserves to adhere to these good government principles by overwhelmingly voting to increase their own property taxes to provide the Forest Preserves with additional revenue.

Below is a list of recommendations that would increase the accountability and efficiency of the Forest Preserves of Cook County:

- 1. Allowing more time to provide a response to FOIA requests
- 2. Limiting unfunded mandates placed on the Forest Preserves
- 3. Restricting applicants with certain criminal backgrounds from working with children
- 4. Creation of a state agency that provides local governments with administrative services, such as cybersecurity and payroll
- 5. Creation of a local government grant clearinghouse that lists all available grants to local governments and creates a standardized application process
- 6. Refining strategies to reduce the amount of paper used without impacting operational efficiency
- 7. Allowing the units of local government to directly levy to other funds, such as real estate
- 8. Tying the levy year to the subsequent budget year
- 9. Penalizing transportation agencies if they do not maintain their rights-of-way and allow debris to end up in the Forest Preserves
- 10. A concerted effort by the state and federal government to reduce the cost of electric vehicles for local government agencies
- 11. The creation of an authority to create a regional plan for prescription fire and weed control
- 12. Limiting the availability of invasive species for the public to purchase

X. Other
