

Resident Watchman Annual Report

For the year 2018

- I. **<u>PROGRAM CHANGES</u>**. For the year 2018 there were no programmatic changes made to the Resident Watchman Program.
- II. **PROGRAM MONITORING.** There was a minimum of one internal physical walk through of each residence, and in many cases two or more visits and inspections were conducted as well as multiple inspections of Watchman assigned boundary areas and external property inspections. These inspections ensure all Watchmen are maintaining their respective residences and are performing assigned duties.
- III. FEE COLLECTIONS. Occupancy Fees are the payments made by Resident Watchmen for occupying the residences. All Resident Watchmen enter an Occupancy Agreement similar to a lease and Occupancy Fees are deducted via automatic Payroll Deductions. These fees cover the cost of the housing maintenance and repairs. Fees collected in 2018 were \$213,955, a slight decrease of \$9,042 from the 2017 amount collected of \$222,997. This decrease occurred due to Resident Watchmen moving out of the residences creating a higher than normal vacancy rate. 2018 ended with 26 Resident Watchmen, which was down five from 2017 (31 Resident Watchmen). Several properties sat vacant for an extended period of time during the year. The primary reason for residences to sit vacant is the cost of repairs. Many of the vacancies are the stand alone or "Free Standing" houses. In many cases these need electrical, plumbing, roofing or other mechanical/structural types of repair work to bring the residence up to Cook County Building and Zoning code. Over time these residences will be repaired, removed from the program and repurposed when feasible, or demolished.
- IV. PROGRAM EXPENSES. The expenses to cover the costs for the Resident Watchman program come from the Occupancy Fees paid by the residents. Expenses related to the program in 2018 were \$163,600.65. This is a decrease in expenditures of \$34,548.35 from 2017. In 2017 expenses were \$198,149. This decrease is due in part to a lower amount of fees collected and several projects that were initiated in 2018 that will not be completed until 2019. We expect to see 2019 expenses be significantly higher. 2018 expenses included asbestos removal; repairs for electrical, plumbing and HVAC systems; installation of new windows and roofs; addition of insulation; and other physical structural repairs. Watchman Residences are in better shape than before, but there remains a significant amount of deferred structural and mechanical maintenance and repairs, such as several more HVAC systems, new roofs, siding, windows, insulation, tuck-pointing, etc. for several of the residences. The District expects the 2019 Annual Report to reflect the entire or near entire budget to be spent on repairing and maintaining the residences. These expenditures are to be paid out of the housing fees collected by the District from the Resident Watchmen living in Resident Watchman residences.
- V. **OCCUPIED RESIDENCES & VACANCIES**. While the number of vacancies is currently unusually high, we expect to fill six residences in the first half of 2019. Also, the District's Housing Committee will look at removing up to five residences from its listings.

The District maintains three types of residences:

- Attached apartments- defined as an apartment physically attached to a District facility. There are ten (10) Attached apartments. At the start of 2018, nine (9) were occupied, at the end of 2018, seven (7) were occupied, leaving three (3) vacancies. All of these are expected to be occupied in 2019.
- Adjacent Houses defined as a house located at a District facility for example a Nature Center or maintenance facility. There are fourteen (14) Adjacent Houses. At the start of 2018, twelve (12) were occupied, at the end of 2018 ten (10) were occupied, leaving four (4) vacancies. We expect two of these to be occupied in 2019.
- 3) Free Standing– defined as a stand-alone house not located at a District facility. The District typically acquires these houses as part of a larger land purchase where the house was part of the parcel purchased. There are twenty (20) Free Standing houses. At the start of 2018, eleven (11) were occupied; at the end of 2018 nine (9) were occupied, leaving 11 vacancies. We expect the number of vacant Free Standing houses to be reduced in 2019 as well.

VI. <u>WATCHMEN ACTIVITY</u>. Watchmen are required to sit "Fire Watch" on weekends where conditions for fires are heightened, and to conduct visual inspection of assigned boundaries surrounding the residence they reside in. Certain locations may also be called on for snow removal or snow plowing when conditions require.

Resident Watchmen are required to submit a "Resident Watchman Bimonthly Report" twice a month, which categorizes their activity as watchmen. The categories that are reported on consist of "Fires", "Encroachments", "Hunting", "Debris", "Graffiti/Vandalism", "Missing Signs", "Tree/Branch Removal", "Citizen Assist", and "Other" which may include such things as snow removal / snow plowing, reporting a car accident to 911, noticing lights on in a facility after hours or looking for anything out of the ordinary that might require a police inspection or visit. "Fires" consists of two separate activities. They can be calling in wildland fires or responding to wildland fires after designated work hours. "Tree/Branch Removal" also consists of two separate tasks: the reporting of trees or large limbs down where they will impact the general public, or the removal of trees or large limbs down where they will impact the public. This work is performed after designated work hours.

2018 saw a significant decrease in the "Fires" category, and in the "Encroachments" category. "Tree / Branch Removal" saw a large increase as well as the "Other" category which includes activities such as the increased monitoring and snow plowing at facilities. Watchman Reports are available for review and a summary of the reports is included as Attachment A.
