WHEREAS, Maritza has also introduced culturally, spiritually, and nature-based curricula to a diverse

audience, actively participated in various committees, and assisted in placing the Little Red Schoolhouse Nature Center as the World's Largest Urban Night Sky Place; and

WHEREAS, Maritza holds numerous certifications in conservation and eco-conservation and is also specialized in youth development, community engagement, and outreach; and

WHEREAS, Maritza has also launched after-school apprenticeship programs for under-resourced youth, providing pathways to careers in Science, Technology, Engineering, Arts, and Mathematics (STEAM) fields; and

WHEREAS, Maritza is Joven Noble and Escalera Certified, a Latinos Outdoor Chicago Chapter Leader, worked at Mujeres Latinas en Accion and on the Board of Directors for the Environmentalists of Color Networks; and

WHEREAS, Maritza is a leader in the Latinx communities who has also played a crucial role in developing informative curricula for Latinx youth, nurturing the next generation of leaders.

#### PROPOSED ORDINANCE AMENDMENT

**OUTSIDE COUNSEL AND LEGAL FEES** 

**BE IT ORDAINED,** by the Forest Preserve District of Cook County Board of Commissioners, that Title 1, Chapter 19, Section 1-19-1 - OUTSIDE COUNSEL AND LEGAL FEES, Sections E (1), (2), and (4) of the Forest Preserve District of Cook County Code of Ordinances is hereby amended as Follows:

Sec. 1-19-1

# E. Fees, Expenses, and Rates

- 1. Fees and Expenses. Outside Counsel shall be paid reasonable fees and costs based on the type and nature of the case. Such fees and costs shall conform to the fees and costs authorized under this Section. Outside Counsel must pay for all expenses in advance unless otherwise expressly directed by the court or the Chief Attorney or Responsible Attorney. Reimbursement of expenses shall be requested as part of Outside Counsel's invoices. Expenses shall be reimbursed as follows:
  - a. Photocopying. Reasonable photocopying at actual cost, not to exceed ten cents (\$0.10) per page.
  - b. Messenger service. The use of messengers when there is a genuine need for expedited delivery at actual charges of a third-party vendor or, when an in-house firm messenger is used, at actual cost (not at the paralegal or legal assistant billing rate).

- c. Computerized research. Actual costs of reasonably necessary computerized research services.
- dc. Experts. The reasonable fees of qualified consulting and testifying experts retained to provide opinions necessary to the defense or prosecution of the litigation, except that all expert fees must be pre-approved by the Chief Attorney if they are anticipated to exceed five hundred dollars (\$500.00).
- ed. Travel. Air travel expenses must not exceed the highest fare coach rate for the flight. Mileage expenses shall be at the Internal Revenue Service deductible rates. Hotels, car rental companies and airlines offering moderate prices and discounted corporate rates shall be used. Outside Counsel shall reduce the hourly rate charged by fifty (50) percent while an attorney or paraprofessional is traveling, unless legal work is being performed and is documented.
- 2. General business costs. Law firm overhead expenses including, but not limited to, rent, electricity, supplies, secretarial and support services, computer system expenses (including online legal research), overtime expenses, local telephone service and other similar expenses, shall be considered part of the Outside Counsel's hourly rate.

\* \* \*

4. *Invoices*. Unless otherwise expressly directed by the court, Outside Counsel shall submit invoices for work performed on a periodic basis, no more frequently than monthly and no less frequently than quarterly. If the accumulated charges for the period are less than five hundred dollars (\$500.00), the charges shall be included in the next periodic invoice. The time spent performing the chargeable services shall be recorded on a daily basis to the nearest 1/10th of an hour and shall be broken down in detail, describing the work performed by each individual during that time period. Invoices shall contain the amount charged for each attorney and paraprofessional, including the time, the hourly rate and summary total for each. Invoices shall itemize expenses according to categories including the following: photocopying, messenger service, computerized research, experts and travel. Invoices shall be paid subject to the approval of the Litigation Subcommittee and the District Board of Commissioners. For Non-Contested Matters, invoices totaling less than five thousand dollars (\$5,000.00) per such matter may be approved at the discretion of the Chief Attorney.

#### PROPOSED RESOLUTION

APPROVAL OF A MEMORANDUM OF AGREEMENT EXTENDING THE TERM OF A COLLECTIVE BARGAINING AGREEMENT NEGOTIATED BETWEEN THE FOREST PRESERVES OF COOK COUNTY AND TEAMSTERS, LOCAL 700

**WHEREAS**, the Illinois Public Labor Relations Act (5 ILCS 315/1 et seq.) has established regulations regarding collective bargaining with a union; and

WHEREAS, a Collective Bargaining Agreement between the Forest Preserves of Cook County ("Forest Preserves") and Teamsters, Local 700 ("Local 700") is currently in effect for a term of January 1, 2021 through December 31, 2024 covering various employees in the Landscape Maintenance, Facilities and Fleet, Law Enforcement, Conservation and Experiential Programming, and Resource Management Departments of the Forest Preserves (Board Item No. 22-0118); and

WHEREAS, the Forest Preserves and Local 700 have entered into a Memorandum of Agreement subject to approval by the Forest Preserves of Cook County Board of Commissioners, and such Memorandum of Agreement makes the following adjustment to the term of the Collective Bargaining Agreement negotiated between the Forest Preserves of Cook County and Teamsters, Local 700:

a) January 1, 2021 to December 31, 2024 2025;

WHEREAS, the Memorandum of Agreement makes the adjustments below to the previously agreed upon salary adjustments and general wage increases included in the Collective Bargaining Agreement negotiated between the Forest Preserves of Cook County and Teamsters, Local 700, provided, however, that retroactive pay continues to not apply for seasonal employees:

- a) Effective the first full payroll period on or after July 1, 2021, the pay rates for all job classifications shall be increased by 1.5%;
- b) Effective the first full payroll period on or after January 1, 2022, the pay rates for all job

classifications shall be increased by 3.5%;

- c) Effective the first full payroll period on or after July 1, 2022, the pay rates for all job classifications shall be increased by 2.5%;
- d) Effective the first full payroll period on or after July 1, 2023, the pay rates for all job classifications shall be increased by 2.5%;
- e) Effective the first full payroll period on or after July 1, 2024, the pay rates for all job classifications shall be increased by 2%;
- f) Effective the first full payroll period on or after July 1, 2025, the pay rates for all job classifications shall be increased by 5%;

**WHEREAS**, the Memorandum of Agreement allows Forest Preserves employees who are members of Local 700 to be eligible for paid Parental Leave pursuant to the Cook County Bureau of Human Resources Parental Leave Policy, and addresses grievance related matters.

**NOW THEREFORE BE IT RESOLVED,** that the Forest Preserves of Cook County Board of Commissioners does hereby approve the terms of the Memorandum of Agreement as negotiated between the Forest Preserves of Cook County and Teamsters, Local 700.

Summary: Since 2014, the Forest Preserves has partnered with the Prairie Research Institute of the University of Illinois for the purpose of developing a Natural and Cultural Resources Master Plan, a landmark document that has helped guide the allocation of resources and informed strategies to pursue and meet the ambitious goals set forth in the Forest Preserves' Next Century Conservation Plan. A number of milestone projects have been achieved pursuant to implementation of the plan, including comprehensive field assessments of natural and archaeological resources within the preserves, the subsequent prioritization of Forest Preserves lands for restoration, development of a seed sourcing policy, and the development of standardized protocols for long-term assessment of conservation success.

The Forest Preserves seeks to continue its collaboration with the Prairie Research Institute in order to further our natural and cultural resource protection goals over the next five (5) years. Tasks include, but are not limited to:

- 1) Advanced LiDAR-based land cover and cultural resource mapping;
- 2) Classification and prioritization of streams and waterbodies for future restoration;
- 3) Advanced population surveys and analysis of high-priority species restoration targets;
- 4) Targeted ecological site assessments based on Illinois Natural Areas Inventory (INAI) criteria, which may further inform the selection and potential designation of additional Illinois Nature Preserves sites;
- 5) Ongoing archaeological field assessments to further identify and preserve cultural resource sites;

- 6) Engagement of staff and constituents through the development of interpretive materials, demonstrations, and presentations sharing the value of Cook County's cultural resources; and
- 7) Technical expertise and assistance supporting sustainability initiatives, including a Climate Resiliency and Adaptation Progress Report.

The Prairie Research Institute comprises five (5) state scientific surveys: the Illinois Natural History Survey, Illinois State Archaeological Survey, Illinois State Geological Survey, Illinois State Water Survey, and Illinois Sustainable Technology Center. This agreement enables the Forest Preserves to consult with and engage the technical expertise of each of these scientific institutions, based on annual tasks assigned by the Forest Preserves.

In exchange for shared use of the fence, the Northbrook Park District is responsible for routine maintenance in order to keep the fence secure and in good condition, at no cost to the Forest Preserves. The Forest Preserves is allowed reasonable access to the service gates at the park for easier maintenance of adjacent Forest Preserves properties.

The original IGA was approved in 2013 and an amendment was approved on 10/16/2018 (Board Item No. 18-0339) to renew the agreement through 2023. The Forest Preserves is requesting to renew said agreement with the Northbrook Park District for another five (5) years, with an additional five-year extension option subject to the approval of the General Superintendent.

**Summary:** The Forest Preserves issued a Request for Proposals (RFP #23-31-102) for the disposal of woody debris such as logs and woodchips generated through the Forest Preserves' vegetation maintenance and ecological restoration operations. This contract would serve to reduce the amount of debris stockpiled at Forest Preserves properties and facilities, promoting safety and ease-of-access for the public and personnel. Northwest Wood Products proposes to remove up to two hundred (200) loads of logs per year for milling into pallet lumber and hardwood landscaping mulch. Logs will be removed at no cost to the Forest Preserves.

Three (3) firms submitted proposals in response to a qualification-based selection process (RFP #23-31-102), two (2) of which are being recommended for award following review by an evaluation committee. The Forest Preserves is seeking approval of the other qualified firm through Board Item No. 23-0530. Proposals were evaluated based on cost efficiency, removal capacity, and potential for the materials to be repurposed for productive end use in alignment with the Forest Preserves' sustainability goals. The mitigation measures were negotiated as part of an environmental assessment of the impact of the proposed federally funded transit project on public recreation and wildlife resources.

The land parcels to be donated are currently owned by the City of Chicago but are anticipated to be conveyed to the CTA under a separate agreement to be approved by the Chicago City Council in November 2023. An Ordinance regarding the subject parcels is the subject of a separate Board Item No. 23-0515. The \$250,000.00 payment to the Forest Preserves for ecological restoration for habitat enhancement and beautification of expanded Beaubien Woods Boat Launch land will encourage use and enjoyment by community residents and visitors arriving by public transit. #### AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR BEAUBIEN WOODS

AN ORDINANCE CREATING A FOREST PRESERVE in part of Section 35, Township 37 North, Range 14, East of the Third Principal Meridian, all in Cook County, Illinois near Beaubien Woods in District 5.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the "District"), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof.

**BE IT ORDAINED** by the Board of Commissioners of the District as follows:

Section 1. That a unified Forest Preserve be and the same is hereby created within the District which shall contain and connect lands now owned and lands to be acquired in substantial accordance with the plat now on file in the office of the General Superintendent of the District, which by reference is hereby

made part hereof, and for the purposes of said Forest Preserve and for the carrying out of the statutory purposes more particularly set out in the preamble of this ordinance, it is necessary and desirable for the District to own and it shall acquire property hereinafter described in Section 2 of this ordinance, for the purpose of creating a Forest Preserve and for District uses.

Section 2. That the lands referred to in Section 1 of this ordinance are more particularly described as follows:

#### PROPOSED LICENSE REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves"), as Licensor to grant a License to Wireless Edge Towers II, LLC, Grantee, to locate, operate and maintain a cell tower in Meadowlark Golf Course pursuant to a master agreement approved by the Forest Preserves of Cook County Board of Commissioners on November 2, 2021 (Board Item No. 21-0002). # PROPOSED COLLECTIVE BARGAINING AGREEMENT, SALARY SCHEDULE, WAGE ADJUSTMENTS AND HEALTHCARE PLAN RESOLUTION

**WHEREAS**, the Illinois Public Labor Relations Act (5 ILCS 315/1 et seq.) has established regulations regarding collective bargaining with a union; and

WHEREAS, the Collective Bargaining Agreement Salary Schedule and wage adjustments, as well as healthcare plan revisions, and other terms and conditions of employment, for the period of January 1, 2021 through December 31, 2024, covering employees in the classification of Police Officer in the Law Enforcement Department of the Forest Preserves of Cook County (the "Forest Preserves"), have been negotiated between the Forest Preserves and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit); and

WHEREAS, the general increases and wage adjustments that have been negotiated are reflected in the Salary Schedule and are included in the Collective Bargaining Agreement negotiated between the Forest Preserves and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit); and

WHEREAS, the revisions to the current healthcare plan that have been negotiated are included in the Collective Bargaining Agreement negotiated between the Forest Preserves and the Illinois Fraternal Order of Police Labor Council (Police Officer Unit).

**NOW THEREFORE BE IT RESOLVED,** that the Board of Commissioners of the Forest Preserves of Cook County do hereby approve the proposed Collective Bargaining Agreement including, but not limited to, the Salary Schedule, wage adjustments, and one-time payments negotiated between the Forest Preserves and Illinois Fraternal Order of Police Labor Council (Police Officer Unit) for employees in the classification of Police Officer who are in active payroll status with the Forest Preserves on the date of approval of this Resolution, as follows:

- (a) Effective upon June 30, 2021, employees will be moved into the NEW Wage Schedule at the pay rates in accordance with the rules set forth herein and attached as Appendix A.
- (b) Effective upon Board of Commissioners of the Forest Preserves of Cook County approval of the Collective Bargaining Agreement, a \$3,000 one-time payment will be paid on the payroll closest to forty-five (45) days after Board approval to bargaining unit members in active status.
- (c) Effective upon Board of Commissioners of the Forest Preserves of Cook County approval of the Collective Bargaining Agreement, a \$1,000 one-time pandemic payment will be paid on payroll closest to forty-five (45) days after Board approval to bargaining unit members in active status.
- (d) Effective the first full payroll period on or after July 1, 2021, the pay rates for the classification of Police Officer shall be increased by 1.5%.
- (e) Effective the first full payroll period on or after July 1, 2022, the pay rates for the classification of Police Officer shall be increased by 2.5%.
- (f) Effective the first full payroll period on or after July 1, 2023, the pay rates for the classification of Police Officer shall be increased by 2.5%.
- (g) Effective the first full payroll period on or after July 1, 2024, the pay rates for the classification of Police Officer shall be increased by 2%.

**BE IT FURTHER RESOLVED**, that the Healthcare Plan (Appendix C) shall be revised as follows:

**BE IT FURTHER RESOLVED,** that the Forest Preserves' Director of Human Resources, Chief Financial Officer, and Director of Budget & Management are hereby authorized to implement the Salary Schedule, wage adjustments and healthcare provisions as negotiated and otherwise outlined above.

**BE IT FURTHER RESOLVED,** that the Forest Preserves' Director of Budget & Management is hereby directed to make all payments consistent with this resolution.
