HONORING THE LIFE OF RETIRED FOREST PRESERVE DISTRICT OF COOK COUNTY CONSERVATION SUPERINTENDENT ROLAND EISENBEIS

WHEREAS, Roland Eisenbeis was born in Ashley, North Dakota in 1918; and

WHEREAS, Roland Eisenbeis completed a two year program at the North Dakota State School of Forestry at Bottineau; and

WHEREAS, Roland Eisenbeis served his Country honorably during World War II working intelligence for the Army Air Force; and

WHEREAS, Roland Eisenbeis began his career at the Forest Preserve District of Cook County, the ("Preserves") in the Spring of 1947 as a Naturalist and retired as the Conservation Superintendent in the Summer of 1984; and

WHEREAS, Roland Eisenbeis was involved from the very beginning of establishing the conservation and resource management structure still used today; and

WHEREAS, Roland Eisenbeis worked diligently on ecological management, including early prairie restoration and spearheaded the shift to conduct active land management so that the Preserves' important biodiversity would thrive for generations to come; and

WHEREAS, Roland Eisenbeis created the modern nature center concept, not to be small "stuffy" museums but gateways to the outdoors; Little Red Schoolhouse opened in 1955, River Trail, Sand Ridge and Crabtree followed by 1971; and

WHEREAS, during his tenure interpretive trails were created as an essential component of the nature center experience; and

WHEREAS, Roland Eisenbeis initiated naturalist visits to schools and began outdoor education training for teachers at Camp Sagawau (now Sagawau Environmental Learning Center); and

WHEREAS, Roland Eisenbeis encouraged in-house training programs and was a key player in the formation of the Association of Interpretive Naturalists, professional organization that has evolved into the national and international National Associate for Interpretation; and

WHEREAS, the Preserves' volunteer and stewardship program, which became a national model, was the result of Roland Eisenbeis' encouragement and wise counsel; and

WHEREAS, Roland Eisenbeis represented the best qualities of citizenship, leadership and humanity through his work at the Preserves spanning more than three decades; and

WHEREAS, Roland Eisenbeis expanded the development of the volunteer program through positive leadership approaches resulting in high morale and dedication of the volunteers to the Preserves' vision; and

WHEREAS, Roland Eisenbeis had a great sense of humor and bright spirit and was responsible for many of the colorful and folksy names of the Preserves, such as "Belly Deep Slough."; and

WHREAS, Roland Eisenbeis had a deep love of nature and believed in sharing the experiences, benefits and wonders that lie in the Preserves with everyone; and

WHEREAS, the community has a lost a great steward and protector of the Preserves in Roland Eisenbeis. He will be sorely missed by his family, friends and colleagues; and

NOW, THEREFORE, BE IT RESOLVED, that a suitable copy of this Resolution be tendered to the loved ones of Roland Eisenbeis as a means of communicating our deep respect for his contribution to the Preserves.

RESOLUTION TO OFFICIALLY RECOGNIZE AND ADOPT NAMES OF FOREST PRESERVE LANDS AND AMENITIES

WHEREAS, the Forest Preserves of Cook County (the "Preserves") recognizes the need to protect the natural and cultural history reflected in the names of the groves, trails, nature preserves, natural areas, facilities, and other public places (the "Venues") owned or controlled by the Preserves. The Preserves seeks to ensure that these names are accurately represented so the residents of Cook County can easily find the Venues and the amenities they offer; and

WHEREAS, in 2015, an internal Naming Committee was charged with discerning the correct and official names of all Venues and reviewing requests for the purpose of determining which naming requests to recommend to the Board of Commissioners of the Preserves (the "Board") for approval; and

WHEREAS, the internal Naming Committee undertook an exhaustive review of the Venues to determine which names had been formally adopted by the Board, were in common use, or had been abandoned; and

WHEREAS, the internal Naming Committee compiled a comprehensive list of the various names associated with the Venues; and

WHEREAS, based upon the findings of the internal Naming Committee, it is recommended that the Board reaffirm those names previously adopted by the Board for approximately 145 Venues as reflected in Category 1 of the list of Venues provided as backup documentation to the Board in support of this resolution (the "Venue List"); and

WHEREAS, it is also recommended that the Board officially adopt those names not previously adopted, but that enjoy broad recognition among the general public, the Preserves, and other agencies that are separately identified in Category 2 of the Venue List; and

WHEREAS, it is further recommended that the Board officially retire those names, which also are identified in Category 3 of the Venue List, that, notwithstanding whether such names were ever adopted by the Board, have been abandoned, are no longer in use, or have been replaced with other names, in order to avoid future confusion.

The Preserves would therefore like to prequalify three (3) vendors to perform the following services, at this time:

- 1) **Homer Industries, LLC, Lockport, Illinois:** Homer Industries LLC will remove logs, and woodchips at locations with more than 800 cubic yards of material. These services will be provided at no cost to the Preserves.
- 2) **CH Benson IV, Inc., Arlington Heights, Illinois:** CH Benson IV, Inc. will mill logs into dimensional lumber for use in cabinetry and other small-scale woodworking projects. Logs will be removed at no cost to the Preserves.
- 3) **Semper Fi Land, Inc., Roselle, Illinois:** Semper Fi Land, Inc. proposes to purchase and process woodchips at locations with large stockpiles of approximately 2,000 cubic yards or more. Semper Fi will pay the Preserves \$0.75 per cubic yard of processed material.
