RECOGNIZING FRIENDS OF THE CHICAGO RIVER FOR DECADES OF SERVICE AND ADVOCACY TO THE FOREST PRESERVE DISTRICT OF COOK COUNTY

WHEREAS, Friends of the Chicago River is a non-profit organization established in 1979 for the purpose of advocating for and improving the health of the Chicago River system; and

WHEREAS, Friends of the Chicago River's mission calls for policy initiatives geared towards improving water quality, on-the-ground projects for the improvement and preservation of quality habitat, and education and outreach programs that inform and inspire support for the Chicago River as a catalyst for community revitalization; and

WHEREAS, Friends of the Chicago River has successfully raised resources that support exciting and meaningful projects that have directly benefitted the plants, animals, and people of the Forest Preserve District of Cook County (the "Forest Preserves"); and

WHEREAS, Friends of the Chicago River has committed these resources toward important ecological restoration activities that improve the health of the Chicago River and its surrounding watershed; and

WHEREAS, to date, Friends of the Chicago River has funded the restoration of over 100 acres of nesting habitat for at-risk populations of native turtles. Additionally, they have installed five osprey nesting platforms and six bat community houses on Forest Preserve property that support these important and iconic species in our region; and

WHEREAS, Friends of the Chicago River also contributed resources to education programs such as the Chicago River Schools Network, and citizen science activities including the Gullywalkers, a program that engages volunteers to identify and find ways to repair gullies caused by poorly managed stormwater that damage the health of the river and the preserves; and

WHEREAS, Friends of the Chicago River plays a key role in the Centennial Volunteers initiative that connects people from throughout Cook County in stewardship activities at numerous forest preserves along the North Branch and Little Calumet Rivers; and

WHEREAS, Friend of the Chicago River has been successfully inspiring and engaging people to adopt a stewardship ethic through numerous outreach activities including the annual Chicago River Day, as well as by offering paddling and other outdoor recreation activities; and

WHEREAS, in one year alone, 2017, Friends of the Chicago River contributed \$750,000 in raised funds, staff time, programs costs, volunteer time, and materials directly to the Forest Preserves. Report Title: Walking Green: Developing an Evidence-base for Nature Prescriptions in the Forest Preserve District of Cook County

Report Period: July 2015 - January 2018

Summary: Dr. Teresa Horton, Department of Anthropology at Northwestern University, was the principal investigator for the study "Walking Green: Developing an Evidence-base for Nature Prescriptions." The study was partially funded by the Forest Preserve District of Cook County (the "Forest Preserves") and compares the health effects of walking in the Forest Preserves property as compared to walking on a suburban sidewalk.

The purpose of the study was to gather data essential for the development of nature prescriptions, which can be recommended by doctors to patients to encourage them to get outdoors, connect to nature, enjoy, and support the Forest Preserves. The study demonstrates that the benefits of exercising in nature exceed those of an equivalent amount of exercise in other conditions, such as walking on a suburban sidewalk. The study also shows that there are significant mental health benefits including improved mood, reduced anxiety, and reductions in perceived stress that can be gained from taking a 50-minute walk on a Forest Preserve trail.

This study advances the Forest Preserves' Next Century Conservation Plan's priority to provide programs that emphasize health benefits and inspire the people of and visitors to Cook County to seek out the Forest Preserves for discovery, renewal, and fun.

Summary: The Forest Preserves would like to exercise the first of two (2) one-year extension options to allow Bike and Roll Inc. to continue providing bicycle rental services at various Forest Preserves locations on a seasonal basis. For the first three (3) years of the program, rentals were offered through kiosks at five (5) locations on the North Branch Trail, as well as at the Dan Ryan Woods.

During this extension period, Bike and Roll, Inc. will expand bicycle rental services to fifty (50) Forest Preserve locations, and the number of bikes available for rental will expand from fifty (50) to five hundred (500). If there is consumer demand, the Forest Preserves and vendor may agree on additional locations and an increased number of bikes available for rental. Additionally, the program will transition from a physical docking station model to a dockless model that allows bicycles to be parked within a defined space in Forest Preserves parking lots. The final amendment is subject to legal review and approval.

Reason: The Forest Preserves issued a Request for Proposals to provide food, beverage and retail sales at Cummings Square in River Forest. Tropical Sno was the sole bidder.

This three (3) year agreement with one (1) optional two-year extension will provide Tropical Sno with the ability to sell shaved ice and other minor retail concessions at the Forest Preserves' Cummings Square concession facility on a seasonal basis (May through October). Tropical Sno has agreed to pay the Forest Preserves \$2,350.00 in year one. This fee increases by \$50.00 per year thereafter.
