COMMEMORATING THE LIFE AND MEMORY OF THE ADMINISTRATOR OF ANIMAL AND RABIES CONTROL, DONNA M. ALEXANDER, VMD

WHEREAS, Dr. Donna M. Alexander was born in East Orange, New Jersey on October 24, 1956; and

WHEREAS, Dr. Alexander received her undergraduate and Veterinariae Medicinae Doctoris degree from the University of Pennsylvania; and

WHEREAS, while at the University of Pennsylvania, Dr. Alexander was the winner of the New Bolton Esquire Award (1982), was published in the Journal of Biochemistry (1978) and Journal of Animal Behavior (1982); and

WHEREAS, Dr. Alexander helped catapult a historic decrease in animal euthanasia while previously working at Chicago Animal Care and Control from 1989 to 1999; and

WHEREAS, Dr. Alexander, a true advocate who dedicated her life's work in the caring of all animals, began her Cook County career in 2007; and

WHEREAS, Dr. Alexander supported the mission of the Forest Preserves of Cook County (the "Forest Preserves") and recognized the role of wildlife in the maintenance and dissemination of disease; and

WHEREAS, Dr. Alexander utilized real time field information in collaboration with the Forest Preserves and other agencies to make informed policy decisions benefitting the health of people and companion animals in Cook County; and

WHEREAS, Dr. Alexander used wildlife information to integrate public health and utilized wildlife as biomonitors to inform physicians as to the presence of disease and/or vectors; and

WHEREAS, the Forest Preserves' work with Dr. Alexander resulted in required leptospirosis vaccinations for dog park users, as well as rabies vaccinations and registration of all cat colonies; and

WHEREAS, Dr. Alexander facilitated a "Health One" approach to issues of human/companion animal/wildlife health, and supported the use of telemetry and genetic modeling research methods to address environmental health questions; and

WHEREAS, Dr. Alexander was a voracious reader, avid Scrabble and Jeopardy player, an excellent cook that liked to prepare exotic meals from different ethnic groups, and was famously known for wearing socks that depicted animals; and

WHEREAS, Dr. Alexander passed away on May 29th, 2018 and has rejoined her sister Joyce Alexander Walker; and

WHEREAS, Dr. Alexander is survived by her mother Kathryn Edna Alexander; and

WHEREAS, Dr. Alexander was an integral partner to the Forest Preserves and will be sorely missed by colleagues, friends, family and all the animals throughout Cook County; and

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserves of Cook County Board of Commissioners commemorate the life of Dr. Donna M. Alexander, and herewith expresses its sincere gratitude for the contributions she has made to the citizens and animals, both domestic and wild, of Cook County, Illinois; and

PROPOSED RESOLUTION

TO AUTHORIZE THE FOREST PRESERVES OF COOK COUNTY TO ENTER INTO LOCAL AGENCY AND ENGINEERING SERVICE AGREEMENTS FOR CONSTRUCTION MANAGEMENT OF THE SAND RIDGE BICYCLE TRAIL

WHEREAS, the Forest Preserves of Cook County (the "Forest Preserves") has sought and been awarded funds from the Illinois Transportation Enhancement Program ("ITEP Grant"), a federally-funded program administered by the Illinois Department of Transportation ("IDOT"), to facilitate the construction of 1.3 miles of the Sand Ridge Bicycle Trail (hereafter the "Project"); and

WHEREAS, IDOT requires a resolution to reaffirm the Forest Preserves funding commitment for Phase III Engineering (construction management) and Construction costs associated with the Project as per the Local Agency Agreement; and

WHEREAS, the Local Agency Agreement also provides for the division of Phase III and Construction costs for the Project and payment of 20% of the engineering and construction costs by the Forest Preserves as the Local Agency; and

WHEREAS, ITEP provides 80% (or maximum of \$56,000.00) of Phase III Engineering costs for the Project estimated at \$70,000.00; and

WHEREAS, in order to meet deadlines for use of the funds provided via the ITEP Grant, IDOT recommends that a consulting engineering firm be employed to perform Phase III Engineering construction management services; and

WHEREAS, in 2013, the Forest Preserves issued an RFQ for Phase I, II, and III Engineering Services and subsequently selected Christopher B. Burke Engineering, Ltd., Rosemont, Illinois (CBBEL) to serve as Consulting Engineers for Phases I, II and III; and

WHEREAS, CBBEL's Phase III Engineering costs are \$69,696.55, ITEP funds will cover 80% (\$55,757.24) of the costs of Phase III Engineering Services to be provided in connection with the Project and the Forest Preserves shall be responsible for 20% of the cost of Phase III Engineering or \$13,939.31 in connection with the Project; and

WHEREAS, ITEP provides 80% (or maximum of \$546,000.00) of Construction costs for the Project estimated at \$682,000.00; and the Forest Preserves 20% local share of the construction cost is estimated at \$136,500.00; and

WHEREAS, IDOT is responsible for the bid letting and award of construction contracts and has accepted an apparent low bid from Iroquois Paving Corporation in the amount of \$607,080.16; and

NOW, THEREFORE BE IT RESOLVED that the Board of Commissioners of the Forest Preserves hereby authorizes the Forest Preserves, through its President, to enter into a local agency agreement (the "Local Agency Agreement"), with the Illinois Department of Transportation ("IDOT") to pay construction and phase III engineering service costs associated with the Project, subject to reimbursement of 80% by IDOT.

NOW, THEREFORE BE IT RESOLVED that the Forest Preserves of Cook County Board of Commissioners hereby authorize the Forest Preserves to pay 20% of the construction cost to IDOT pursuant to the Local Agency Agreement.

BE IT FURTHER RESOLVED that Christopher B. Burke Engineering, Ltd, of Rosemont Illinois be employed to perform Phase III Engineering services in connection with the Project, and that the President of such Board of Commissioners is hereby directed to execute, on behalf of the Forest Preserves, an agreement by and between the Forest Preserves and CBBEL for Phase III Engineering services (the "Engineering Services Agreement").

BE IT FURTHER RESOLVED that, the Forest Preserves of Cook County Board of Commissioners hereby confirms that sufficient funds are available in the Forest Preserves Construction & Development Fund Trail accounts 51009.560063, 51025.560063, 51054.560063, 51055.560063, 51055.560063, 51057.560063, 51058.560063; and Construction and Management Service accounts 51009.520860, 51025.520860, 51054.520860, 51055.520860, 51056.520860, 51057.520860, 51058.520860, and Grant account 51010.520860, and have been designated, to pay the total cost of Phase III Engineering services in the amount not to exceed \$69,696.55 of which the Illinois Department of Transportation will reimburse 80% or up to \$55,757.24 and the Forest Preserves' ultimately shall be responsible for 20% of the Phase III Engineering costs or a maximum of \$13,939.31, in addition to, 20% of construction costs not to exceed \$136,500.00.

BE IT FURTHER RESOLVED that copies of the Local Agency Agreement and the Engineering Services Agreement for Federal Participation, when executed in their respective final form, shall be submitted to the IDOT for approval and final processing.

Summary: The Nature Conservancy recently received a grant in the amount of \$574,507.00 from the National Fish and Wildlife Foundation to restore coastal wetlands in the Calumet region. The Forest Preserves have been sub-awarded a portion of these funds to complete 56 acres of wetland restoration at Thornton-Lansing Road Nature Preserve in south Cook County. In addition, through collaboration with other partners, 18 acres of wetland swale and adjacent upland habitat will also be revisited at Powderhorn Prairie and Marsh Nature Preserve in Burnham as well as comprehensive monitoring of wetland bird

populations across the project sites, providing information regarding the impact of restoration on wildlife throughout the region.

This project will be conducted in partnership with the Nature Conservancy, Chicago Park District, Audubon Chicago Region, and Greencorps Chicago. This project advances the goals of the Next Century Conservation Plan and the Natural and Cultural Resources Master Plan, which identified Thornton-Lansing Road Nature Preserve and Powderhorn Prairie and Marsh Nature Preserve as two (2) of the highest priority landscapes for conservation and ecological restoration.

Total project costs for the Forest Preserves' portion of the project are \$340,000.00, with a 50/50 match contribution by each partner.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to grant a permanent easement to the Illinois Department of Transportation ("IDOT") at 147th Street and Menard Avenue in the Tinley Creek Preserves for 0.492 acre or 21,430 square feet.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to grant a temporary easement to the Illinois Department of Transportation ("IDOT") at Illinois Route 58 Golf Road between East River Road and College Drive in Big Bend Lake, Kloempken Prairie, and Lions Woods Forest Preserve for 0.208 acre or 9,044 square feet.

Reason: IDOT requests temporary easements for regrading of existing berms along Golf Road to reduce flooding on the roadway near the CN Railroad underpass. The berms were originally constructed in 1930 and have eroded and/or settled over time. The berms are proposed to be raised to their original elevations.

The term of the temporary easement is five (5) years, or completion of construction, whichever comes first.

Summary: This Intergovernmental Agreement ("IGA") grants the Northbrook Park District use of a chain link fence located at the southwest corner of Somme Prairie Nature Preserve and owned by the Forest Preserves, for the purpose of operating an off-leash dog area at Coast Guard Park. In exchange for shared use of the fence, the Northbrook Park District is responsible for routine maintenance in order to keep the fence secure and in good condition, at no cost to the Forest Preserves. Additionally, the Forest Preserves are allowed reasonable access to the service gates at the park for maintenance of adjacent Forest Preserves properties.

The Forest Preserves would like to exercise its option to renew the aforementioned IGA with the Northbrook Park District for an additional five (5) years.
