HONORING THE FOREST PRESERVES OF COOK COUNTY'S DEER GROVE WEST

WETLAND AND WOODLAND NATURE PRESERVE **FOR** RECEIVING A CHICAGO WILDERNESS **EXCELLENCE** IN ECOLOGICAL RESTORATION AWARD. AND THE FOREST PRESERVES OF COOK COUNTY'S CONSERVATION CORPS AND FLORA THE CHICAGO REGION FOR EACH RECEIVING A CHICAGO WILDERNESS FORCE OF NATURE AWARD

WHEREAS, on November 14, 2019, the Forest Preserves of Cook County's Deer Grove West Wetland and Woodland Nature Preserve was honored with a Platinum Accreditation, the highest accreditation possible, from the Chicago Wilderness Excellence in Ecological Restoration Program and the Forest Preserves' Conservation Corps and the publication *Flora of the Chicago Region* by Gerould Wilhelm and Laura Rericha were both honored with a Chicago Wilderness George B. Rabb Force of Nature Award at a ceremony at the Chicago Botanic Garden in Glencoe, Illinois; and

WHEREAS, the Excellence in Ecological Restoration Program recognizes the organizations managing the largest and highest-quality natural areas in the Chicago region and highlights projects that set an example of best practices in natural resource management and ecological restoration; and

WHEREAS, the 240-acre project area that received Platinum Accreditation is part of the 1,950-acre Deer Grove West Wetland and Woodland Nature Preserve located in Palatine, Illinois that supports savanna, dry-mesic upland forest, mesic upland forest, wet floodplain forest, sedge meadow and wetland communities that collectively provide habitat for hundreds of native plant and animal species; and

WHEREAS, Deer Grove Natural Areas Volunteers began restoration work at the site over 20 years ago, and in 2015 the Forest Preserves and Openlands expanded on this work through O'Hare Modernization Mitigation Account funding to remove invasive species, maintain the ecological health of existing habitat and restore hydrology to the site's wetland habitat; and

WHEREAS, today Deer Grove West Wetland and Woodland Nature Preserve is one of our region's best examples of places that benefit both wildlife and people; and

WHEREAS, the George B. Rabb Force of Nature Awards recognize individuals and organizations whose conservation, restoration, advocacy or educational activities in the region are inspirational examples for others; and

WHEREAS, the Conservation Corps was developed to mobilize people to restore nature to health, and to train the next generation of conservation leaders and forest preserve advocates by providing youth and adults with paid, hands-on restoration experiences on the Forest Preserves' nearly 70,000 acres of public land; and

WHEREAS, the Conservation Corps is coordinated in partnership with the Friends of the Forest Preserves, Student Conservation Association, Greencorps Chicago, and Audubon Great Lakes; and

WHEREAS, the Conservation Corps is a Force of Nature because it strives to break down geographic

and racial barriers by creating a network where people of all backgrounds work together for a common cause and ensures that participants gain an understanding of local ecology and are empowered to become nature ambassadors within their communities and among their peers; and

WHEREAS, Flora of the Chicago Region: A Floristic and Ecological Synthesis by Gerould Wilhelm and Laura Rericha is the latest edition of Plants of the Chicago Region, a compendium of the Chicago region's vascular flora first authored by Floyd Swink in 1969; and

WHEREAS, this completely revised edition breaks new ground by documenting the relationship between flora and fauna, describing the habitats in which plants and their ecological counterparts occur, and noting the impacts of climate change and consequent habitat degradation; and

WHEREAS, few other regions within the United States have such a thorough resource available to them and the Chicago Wilderness area is fortunate to have such a guide to the natural world; and

NOW, THEREFORE, BE IT RESOLVED, that Toni Preckwinkle, President; and the Forest Preserves of Cook County Board of Commissioners thank and congratulate the winners of both the Chicago Wilderness Excellence in Ecological Restoration Award and George B. WHEREAS, Mr. Alvarez focused his career on community work when he began volunteering with the Pilsen Neighbors Community Council and, in 2014, began working at SER and with the PODER program where he currently coordinates the PODER program at Ruiz Elementary School, Chicago working to provide a safe space for young people afterschool, assisting with homework, and finding a variety of activities - STEM, team building, community work-for youth participation; and

WHEREAS, Mr. Alvarez learned about the Forest Preserves of Cook County and the Camping Leadership Immersion Course (CLIC); and took the CLIC training himself in May of 2017; and

PROPOSED ORDINANCE

Ordinance for the Levy of Taxes for the Year 2020

BE IT ORDAINED by the Board of Commissioners of the Forest Preserve District of Cook County:

Section 1. That this Ordinance is and the same is hereby termed the "Ordinance for the Levy of Taxes for the Year 2020."

Section 2. That the Committee on Finance of the Board of Commissioners of the Forest Preserve District of Cook County Illinois has considered the subject of the Annual Tax Levy for the year 2020 and the several sums necessary to be levied to meet the needs and requirements of the Forest Preserve District of Cook County for said year and has recommended that this ordinance for the levy of taxes be adopted.

Section 3. That the Commissioners of the Forest Preserve District of Cook County, heretofore having approved and adopted the Annual Appropriation Ordinance for the Forest Preserve District of Cook County for the year commencing January 1, 2020 at its meeting held November 19, 2019, which ordinance was published by authority of said Board as provided by law and which portion of said Appropriation Ordinance pertaining to Fund and Departmental Appropriations (together with marginal columns captioned "Payable from the Tax Levy" and "Payable from sources other than the Tax Levy" where applicable) is set forth hereinafter.

Section 4. That the sum of Ninety Nine Million, Two Hundred and Eighty Nine Thousand, and Three Dollars and No Cents (\$99,289,003), being the sum of Appropriations heretofore legally made which are to be paid from the collection of the Annual Tax Levy of the Forest Preserve District of Cook County, Illinois for the Levy Year 2020 A.D. for the corporate purposes, for the construction of improvements and development of the forests and lands, for payment for principal and interest on bonded debt, for payment for contributions to Employees' Annuity and Benefit Fund, and for the payment of amounts to the Chicago Zoological Society and the Chicago Horticultural Society, all as adopted by the Board of Commissioners of the Forest Preserve District of Cook County at its meeting held November 19, 2019 and published by the authority of said Board according to law, is hereby levied on all the taxable property within said Forest Preserve District of Cook County, Illinois for the Levy Year 2020 being composed of the specific amounts for the various purposes herein before named.

PROPOSED ORDINANCE AMENDMENT

ORDINANCE REQUIRING GENDER NEUTRALITY IN CODE LANGUAGE

BE IT ORDAINED, by the Cook County Forest Preserve District Board of Commissioners, that Title I - ADMINISTRATIVE, Chapter 1 - OFFICIAL FOREST PRESERVE DISTRICT CODE, Section 1-1-3: - AMENDMENTS and Chapter 3 - DEFINITIONS, Section 1-3-1: - CONSTRUCTION OF WORDS of the Cook County Forest Preserve District Code is hereby amended as Follows:

1-1-3: - AMENDMENTS.

- A. Any ordinance amending the Forest Preserve District Code shall set forth the title, chapter and section number of the section or sections to be amended, and this shall constitute sufficient compliance with any statutory requirement pertaining to the amendment or revision by ordinance of any part of this District Code. All such amendments or revisions by ordinance shall be immediately forwarded to the codifiers and the said ordinance materials shall be prepared for insertion in its proper place in each copy of this District Code. Each such replacement page shall be properly identified and shall be inserted in each individual copy of the Forest Preserve District Code.
- B. The Forest Preserve District Code is hereby amended to remove all gender-specific references within the Code. All future amendments to the Code shall be drafted with gender-neutral language.

• 1-3-1: - CONSTRUCTION OF WORDS.

<u>Plural to include singular:</u> Whenever any word in any section of this Forest Preserve District Code importing the plural number is used in describing or referring to any matters, parties or persons, any single matter, party or person shall be deemed to be included, although distributive words may not have been used.

<u>Singular to include plural:</u> When any subject matter, party or person is referred to in this <u>Forest Preserve</u> District Code by words importing the singular number only, or the masculine gender, several matters, parties or persons, and females as well as males and bodies corporate shall be deemed to be included.

; provided, that t These rules of construction shall not be applied to any section of this Forest Preserve District Code which contains any express provision excluding such construction or where the subject matter or context may be repugnant thereto.

The word "ordinance" contained in the ordinances of the Forest Preserve District has been changed in the content of this District Code to "Title," "Chapter," "Section" and/or "subsection" or words of like import for organizational and clarification purposes only. Such change to the Forest Preserve District's ordinances is not meant to amend passage and effective dates of such original ordinances.

Each of the words "woods," "timber," "forest" and "preserve," whenever used in this Code, means land owned by the Forest Preserve District of Cook County.

Summary: On September 10, 2013, the Forest Preserves of Cook County Board of Commissioners approved the Forest Preserves of Cook County (the "Forest Preserves") request to enter into an intergovernmental agreement with the Village of Hoffman Estates (the "Village") and the Hoffman Estates Park District (the "Park District") to participate in the development of trail improvements connecting the Prairie Stone Business Park to the Poplar Creek loop trail in Northwest Cook County (the "2013 IGA"). The Forest Preserves was authorized to spend \$84,531.00. Required authorizations to complete the project as designed were not received before the deadlines in the 2013 IGA. The Forest Preserves spent \$20,898.52 under the 2013 IGA.

The Forest Preserves now requests authority to enter into a new agreement with the Village and the Park District to jointly design and construct for the East-West portion of the original project which includes the paving of an existing ½-mile unpaved path through the Poplar Creek Forest Preserve from Route 59 west to the CN railroad tracks. 80% of the costs for this East-West portion of the project are anticipated to be covered by federal grant funds, with the remaining 20% of costs to be shared by the Forest Preserves, the Village, and the Park District. The Forest Preserves share under this new proposed intergovernmental agreement is \$72,212.50. However, the Forest Preserves is credited for the \$20,898.52 paid under the 2013 IGA so its final total cost is a not to exceed amount of \$51,313.98. The Forest Preserves will assume responsibility for maintenance and operation of the segment of the project on Forest Preserves property. The final agreement is subject to legal review and approval.

Summary: The Preserves of Cook County (the "Forest Preserves") recently completed a Forest feasibility study to extend the existing paved trails at 26th St. and 1st Ave. to Ogden Ave./Cermak-Ottawa Woods. The feasibility study identified multiple alternatives that included both on-street and off-street options for further Phase engineering study and design. It also included improved access to the Brookfield Zoo along 31st St. for pedestrians, bicyclists, and other non-motorized trail users. The Forest Preserves requests authority to enter into an intergovernmental agreement with the Villages for a Phase I Engineering Study for routes that will enable future trail users to safely travel from the Salt Creek trail system to the Chicago Portage National Historic Site. 80% of project costs will be covered by state grant funds, the Forest Preserves will make a one-time contribution of \$16,000.00, and the Villages will cover the remaining costs and expenses for the project. The Village of Brookfield will be the lead agency.

By committing a portion of the estimated cost of the Phase I study the Forest Preserves will contribute to the broader goal of connecting its trails with these surrounding communities and close a key segment depicted in the Northeastern Illinois Regional Greenways Plan. The final agreement is subject to legal review and approval.

Reason: Contract 19-40-498 is a request for Boathouse Vendor Operations at the Busse Lake Boathouse. The selected vendor, Chicago River Canoe and Kayak, was the sole respondent to the RFP after an exhaustive outreach effort. Chicago River Canoe and Kayak has operated the Busse Lake Boathouse since 2014 and will continue to be responsible for maintaining and providing boat rentals and related concessions at the Busse Lake Boathouse.

Chicago River Canoe and Kayak has agreed to pay the Forest Preserves 5% of gross sales, plus the following annual fee per year.
