IDNR provided an initial advance of \$500,000.00 in May 2015, which allowed removal of two (2) of the seven (7) dams. IDNR removed another two (2) of the seven (7) dams with their construction crew at no cost to the Forest Preserves. IDNR suspended this IGA effective 6/30/2015. On 3/9/2017 Amendment #2 of this IGA was retroactively approved by the Board of Commissioners to allow the project to continue in the event funding was restored. IDNR's funding has recently been restored and IDNR recommends an extension of this IGA until 6/30/2024 to allow time for the removal of the remaining dams. Final amendment is subject to legal review and approval.

# PROPOSED LICENSE REQUEST

**Request:** Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves"), as Licensor to grant a License to Commonwealth Edison Company ("ComEd"), Grantee, to locate, operate and maintain 10,500 linear feet of underground and overhead electric lines, poles and equipment along Bateman Road from Algonquin Road south to Penny Road at the Spring Creek Preserves. The project is proposed to improve reliability and resiliency services to the surrounding communities, to minimize outages and more quickly identify outages and restore power. The existing 6,800 linear feet of overhead lines and infrastructure has no known license, the new license will include the existing line. **Section 1.** That this Ordinance is and the same is hereby termed the "Ordinance for the Levy of Taxes for the Year 2020."

**Section 2.** That the Committee on Finance of the Board of Commissioners of the Forest Preserve District of Cook County Illinois has considered the subject of the Annual Tax Levy for the year 2020 and the several sums necessary to be levied to meet the needs and requirements of the Forest Preserve District of Cook County for said year and has recommended that this ordinance for the levy of taxes be adopted.

**Section 3.** That the Commissioners of the Forest Preserve District of Cook County, heretofore having approved and adopted the Annual Appropriation Ordinance for the Forest Preserve District of Cook

County for the year commencing January 1, 2020 at its meeting held November 19, 2019, which ordinance

was published by authority of said Board as provided by law and which portion of said Appropriation Ordinance pertaining to Fund and Departmental Appropriations (together with marginal columns captioned

"Payable from the Tax Levy" and "Payable from sources other than the Tax Levy" where applicable) is set forth hereinafter.

**Section 4.** That the sum of Ninety Nine Million, Two Hundred and Eighty Nine Thousand, and Three Dollars and No Cents (\$99,289,003), being the sum of Appropriations heretofore legally made which are to be paid from the collection of the Annual Tax Levy of the Forest Preserve District of Cook County, Illinois for the Levy Year 2020 A.D. for the corporate purposes, for the construction of improvements and development of the forests and lands, for payment for principal and interest on bonded debt, for payment for contributions to Employees' Annuity and Benefit Fund, and for the payment of amounts to the Chicago

Zoological Society and the Chicago Horticultural Society, all as adopted by the Board of Commissioners of

the Forest Preserve District of Cook County at its meeting held November 19, 2019 and published by the authority of said Board according to law, is hereby levied on all the taxable property within said Forest Preserve District of Cook County, Illinois for the Levy Year 2020 being composed of the specific amounts

# PROPOSED ORDINANCE AMENDMENT

ORDINANCE REQUIRING GENDER NEUTRALITY IN CODE LANGUAGE

**BE IT ORDAINED,** by the Cook County Forest Preserve District Board of Commissioners, that Title I - ADMINISTRATIVE, Chapter 1 - OFFICIAL FOREST PRESERVE DISTRICT CODE, Section 1-1-3: - AMENDMENTS and Chapter 3 - DEFINITIONS, Section 1-3-1: - CONSTRUCTION OF WORDS of the Cook County Forest Preserve District Code is hereby amended as Follows:

#### **1-1-3: - AMENDMENTS.**

- A. Any ordinance amending the Forest Preserve District Code shall set forth the title, chapter and section number of the section or sections to be amended, and this shall constitute sufficient compliance with any statutory requirement pertaining to the amendment or revision by ordinance of any part of this District Code. All such
- amendments or revisions by ordinance shall be immediately forwarded to the codifiers and the said ordinance materials shall be prepared for insertion in its proper place in each copy of this District Code. Each such replacement page shall be properly identified and shall be inserted in each individual copy of the Forest Preserve District Code.

B. The Forest Preserve District Code is hereby amended to remove all gender-specific references within the Code. All future amendments to the Code shall be drafted with gender-neutral language.

#### • 1-3-1: - CONSTRUCTION OF WORDS.

<u>Plural to include singular:</u> Whenever any word in any section of this Forest Preserve District Code importing the plural number is used in describing or referring to any matters, parties or persons, any single

matter, party or person shall be deemed to be included, although distributive words may not have been used.

Singular to include plural: When any subject matter, party or person is referred to in this Forest Preserve District Code by words importing the singular number only, or the masculine gender, several matters, parties or persons, and females as well as males and bodies corporate shall be deemed to be included, provided, that t These rules of construction shall not be applied to any section of this Forest Preserve District Code which contains any express provision excluding such construction or where the subject matter or context may be repugnant thereto.

The word "ordinance" contained in the ordinances of the Forest Preserve District has been changed in the content of this District Code to "Title," "Chapter," "Section" and/or "subsection" or words of like import for organizational and clarification purposes only. Such change to the Forest Preserve District's ordinances is not meant to amend passage and effective dates of such original ordinances. Each of the words "woods," "timber," "forest" and "preserve," whenever used in this Code, means land owned by the Forest Preserve District of Cook County.

#### PROPOSED INTERGOVERNMENTAL AGREEMENT

**Department:** Department of Planning and Development

Other Part(ies): Metropolitan Water Reclamation District of Greater Chicago ("MWRD")

**Request:** Authorization to enter into an Intergovernmental Agreement ("IGA") with MWRD for reconstruction and maintenance of the McCook levee.

**Goods or Services:** MWRD proposes to improve, raise, and maintain the McCook Levee on the west side of the Des Plaines River from 45th Street downstream to the railroad in Ottawa Trail Woods. This project will require the grant of a permanent easement from the Forest Preserves to MWRD.

**Agreement Number(s):** N/A

**Agreement Period:** Continuous

**District(s):** 16

Summary: MWRD proposes to repair, rehabilitate, and replace a levee along the west side of the Des Plaines River from 45th Street to Lawndale Avenue, known as the McCook Levee, to protect commercial and residential structures from flooding. MWRD will complete the proposed work and assume future maintenance responsibility for the levee pursuant to an agreement for project design and construction with the United States Army Corps of Engineers (Corps) and the proposed IGA. The proposed 3.58-acre permanent easement will provide access and right of entry to MWRD and the Corps for the construction, operation and maintenance of the levee on Forest Preserves property. Under the IGA, the Forest Preserves will have record keeping and reporting obligations, as well as use restrictions, in relation to MWRD funding certain improvements with bond funds.

A two-block portion of the Salt Creek Trail will be closed and temporary access to an on-street detour provided during the construction period. Tree mitigation and other fees will be waived for MWRD consistent with a Memorandum of Understanding providing for mutual waiver of fees between MWRD and the Forest Preserves approved on May 11, 2017. The Forest Preserves may also grant MWRD and the Corps waivers to applicable work-hour limits and truck-traffic restrictions upon written request. The proposed IGA is subject to final review and approval by the Forest Preserves' Legal Department.

# RESOLUTION IN SUPPORT OF THE FOREST PRESERVE DISTRICT OF COOK COUNTY LAW ENFORCEMENT DEPARTMENT AS A SEPARATE AND DISTINCT POLICE DEPARTMENT

**WHEREAS,** Section 810/15 of the Cook County Forest Preserve District Act, 70 ILCS 810/15, grants the Forest Preserve District of Cook County Board of Commissioners "the right and power to appoint and maintain a sufficient police force, the members of which may have and exercise police powers over the territory within such forest preserves for the preservation of the public peace, and the observance and enforcement of the ordinances and laws, such as are conferred upon and exercised by the police of organized cities and villages;" and

**WHEREAS,** the Forest Preserves of Cook County Law Enforcement Department serves and protects visitors and protects the Forest Preserves' almost 70,000 acres of natural lands and property - one of the largest public conservation districts in the United States - by upholding and enforcing all state, county, and

Forest Preserves laws and ordinances; and

WHEREAS, Forest Preserves officers are sworn officers who received additional training in conservation from the Illinois Department of Natural Resources and the Forest Preserves' Department of Resource Management, and archeological protection training from the Prairie Research Institute at the University of Illinois at Urbana-Champaign and perform a dual role: both the conventional duties of police

officers and tasks and duties performed by conservation officers; and

**WHEREAS**, the Forest Preserves Police are regularly engaged in duties and patrols specifically designed to enforce Forest Preserves of Cook County ordinances that protect the many important ecosystems in the Forest Preserves, including over 100 endangered species of plants and animals; and

**WHEREAS**, the Forest Preserves Police welcome and ensure the safety of residents who make more than 62 million visits each year to the Forest Preserves of Cook County to explore and take respite in

nature and Forest Preserves officers' presence and role as part of the Forest Preserve team is crucial for the visitor experience from answering questions about amenities to directing traffic at large events.

Each day, Forest Preserves police officers patrol the Preserves, by both traditional vehicular patrols and alternative patrols by foot, bike and other means. Forest Preserves police officers conducted 6,200 high-visibility alternative patrols on and off the trails last year; and

**WHEREAS**, the Forest Preserves Police value diversity and are committed to enhancing their cultural competency through on-going training including a recent cultural awareness forum co-sponsored by the Department of Justice and the Chicago Commission on Human Relations to listen to different perspectives

and have an honest conversation about what the Forest Preserves Police can do to be more culturally aware and welcoming to all residents, previous trainings on fostering a respectful workplace and working with people with disabilities, and will soon undergo training on implicit bias; and

WHEREAS, Sgt. Maninder Sangha of the Forest Preserve Police assists the Forest Preserves' Racial Equity Diversity and Inclusion (REDI) team in creating a work culture that embraces diversity and is inclusive and welcoming to all Forest Preserves of Cook County employees, visitors, and partners and has developed strategies to advance racial equity by improving the hiring process, broaden outreach efforts, and improve access to training for all employees; and

**WHEREAS,** Deputy Commander Martin Hasler represents the Forest Preserves Police on the Chicago Commission on Human Relations and Hate Crime Coalition to advocate for individuals and communities impacted by hate crimes; and

**WHEREAS,** the Forest Preserve Police support numerous events that promote equity and inclusivity within the Forest Preserves, including the annual *Peace in the Preserves* event attended by more than 700 participants to date and *Pride in the Preserves* event sponsored by the Northwest Side Coalition Against Racism and Hate; and

WHEREAS, Section 810/2.1 of the Cook County Forest Preserve District Act, 70 ILCS 810/2.1, defines this Forest Preserve District Board of Commissioners as the Cook County Board of Commissioners; and

WHEREAS, each of these governing bodies and their respective Law Enforcement Committees have examined and appreciate the value, operational efficiencies, cost effectiveness, collective contribution and dedication of the officers of the Forest Preserves Law Enforcement Department, and the unique role of the department and its officers to the success of the organization and the safety of visitors and Cook County residents; and

**WHEREAS**, House Bill 2297 in the Illinois General Assembly proposes to eliminate this duly elected body's authority to authorize a sufficient police force, pre-empting local control of a vital operation within

the regional treasure that is the Forest Preserves of Cook County; and

**WHEREAS,** House Bill 2297 would result in increased payroll cost for taxpayers to police the Forest Preserves by an estimated 20% to 25% and increase pension costs, if this vital function were taken on by the Cook County Sheriff's Office, or reduce the amount of law enforcement attention in the Forest

Preserves; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Forest Preserve District of Cook County Board of Commissioners does hereby oppose House Bill 2297 and support the men and women of the Forest Preserve Law Enforcement Department; and

**BE IT FURTHER RESOLVED,** that a copy of this resolution be sent to each member of the Illinois General Assembly.
