WHEREAS, the Illinois Public Labor Relations Act (5 ILCS 315/1 *et seq.*) has established regulations regarding collective bargaining with a union; and

WHEREAS, the Collective Bargaining Agreement Salary Schedule and wage adjustments, as well as healthcare plan revisions, for the period of January 1, 2018 through December 31, 2020 covering various employees in the Landscape Maintenance, Facilities and Fleet, Law Enforcement, Conservation and Experiential Programming, and Resource Management Departments of the Forest Preserves of Cook County (the "Forest Preserves") have been negotiated between the Forest Preserves and Teamsters Local 700; and

WHEREAS, the general increases, wage adjustments and signing bonuses that have been negotiated are reflected in the Salary Schedule and are included in the Collective Bargaining Agreement negotiated between the Forest Preserves and Teamsters Local 700; and

WHEREAS, such general increases, wage adjustments and signing bonuses were accounted for in the 2020 Annual Appropriations Ordinance as approved by the Forest Preserves Board of Commissioners on November 19, 2019 (Agenda Item No. 19-0419); and

WHEREAS, the revisions to the current healthcare plan that have been negotiated are included in the Collective Bargaining Agreement negotiated between the Forest Preserves and Teamsters Local 700.

NOW THEREFORE BE IT RESOLVED, that the Board of Commissioners of the Forest Preserves do hereby approve the Collective Bargaining Agreement, which includes the Salary Schedule, wage adjustments, and signing bonuses negotiated between the Forest Preserves and Teamsters Local 700 as follows:

- (a) effective upon board approval of the Collective Bargaining Agreement, \$1,200 lump sum bonus to be paid to all bargaining unit members in active status as a separate transaction on payroll closest to thirty (30) days after approval by Board
- (b) effective the first full pay period on or after July 1, 2019 the pay rates for all classifications shall be increased 2.00%
- (c) effective the first full pay period on or after July 1, 2020 the pay rates for all classifications shall be increased 2.00%
- (d) effective the first full pay period on or after July 1, 2019, the first five steps of the salary chart shall increase by 0.5%
- (e) effective the first full pay period on or after July 1, 2019, for longevity steps 1, 2, 3 and 4, pay differential increases from 1% to 2%.

BE IT FURTHER RESOLVED, that the Healthcare Plan (Appendix B) shall be revised as follows:

PROPOSED RESOLUTION

AUTHORIZING THE CHICAGO BOTANIC GARDEN TO COLLECT ADMISSION FEES

WHEREAS, Section 43 of the Cook County Forest Preserve District Act, 70 ILCS 810/43, authorizes the corporate authorities of the Forest Preserve District of Cook County (the “Forest Preserves”) to prepare and maintain grounds for a botanic garden “to acquire, plant, maintain and display botanic material, to conduct research for improvement of plant species and for plant protection against disease and harmful insects, for the general care and growing of plant material, and to erect and maintain such structures appropriate for the purposes aforesaid; or such corporate authorities may authorize the directors or trustees of any botanic garden existing and organized under the laws of Illinois, to maintain a botanic garden as aforesaid out of funds belonging to said botanic garden; or the corporate authorities of such forest preserve districts may contract with a botanic garden or horticultural society organized and existing under the nonprofit laws of Illinois to establish and maintain a botanic garden as aforesaid,...”; and

WHEREAS, the Forest Preserves Board of Commissioners adopted an “Agreement Between Chicago Horticultural Society and the Forest Preserve District of Cook County, Illinois” on August 4, 1975, revising a previous agreement between the Forest Preserves and the Chicago Horticultural Society entered into on January 27, 1965; and

WHEREAS, the Chicago Botanic Garden (the “Garden”), operated by the Chicago Horticultural Society, is currently one of the greatest living museums and a renowned conservation science center, one of the top attractions in Cook County and major cultural institutions in the State of Illinois; and

WHEREAS, more than one million people visit the Garden's 27 gardens and four natural areas annually,

which are uniquely situated on 385 acres on and around nine islands, with six miles of lake shoreline.

NOW THEREFORE BE IT RESOLVED, that the Forest Preserve District of Cook County Board of Commissioners hereby authorizes the Chicago Botanic Garden to charge the following not to exceed fees:

Admission Fee:	\$35 per each visitor (3-61 years of age)
Parking Fees:	\$30 per passenger vehicle
	\$60 per bus, limousine, RV, and mini-bus

BE IT FURTHER RESOLVED, that the Garden shall offer a reduced Admission Fee and reduced Parking Fees for residents of Cook County; and

BE IT FURTHER RESOLVED, that the Garden is authorized to offer discounts and/or waivers of fees for members, children, seniors, and veterans; and

BE IT FURTHER RESOLVED, that the above-referenced fees shall be used solely for the purposes of the improvement, operation and maintenance of the Garden; activities related to the study, propagation and culture of plants; and educational programs conducted by the Chicago Horticultural Society in furtherance of the programs of the Garden; and

BE IT FURTHER RESOLVED, that written approval of the General Superintendent is required if the Garden increases all or any fees per this resolution within the limits set forth above, including the reduced Admission Fees and reduced Parking Fees for residents of Cook County and any discounts and/or waivers of fees for members, children, seniors, and veterans. Increases that exceed the amounts set forth above require the approval of the Forest Preserve District of Cook County Board of Commissioners; and

BE IT FURTHER RESOLVED, that the Garden shall offer 52 free days per twelve (12) month period beginning January 1, 2022; and

BE IT FURTHER RESOLVED, that the effective date of this Resolution shall be June 30, 2021.

PROPOSED PARTNERSHIP AGREEMENT

Request: Requesting authorization for the Forest Preserves of Cook County (the “Forest Preserves”) to enter into a Partnership Agreement with the Bobolink Foundation, Chicago, Illinois.

Reason: The proposed agreement will authorize the Forest Preserves to partner with the Bobolink Foundation (the “Foundation”) to develop and implement ecological restoration projects on Forest Preserves property within the Spring Creek Forest Preserve complex, located in Barrington Township in northwest Cook County. Funding and contractual management services will be provided by the Foundation, at no direct cost to the Forest Preserves. An initial 100-acre project located west of Old Sutton Road between Penny Road and Dundee Road has been proposed, providing an estimated value of up to \$347,167.00 over a four (4) to five (5) year period for restoration work that will strengthen efforts to preserve, conserve and manage Forest Preserves lands. Subsequent projects may be developed and implemented within the Spring Creek complex, subject to additional funding opportunities.

Restoration activities will include invasive species control, seeding, and use of prescribed fire to restore native vegetation and benefit wildlife. Project design will require approval by the Forest Preserves. Final agreement is subject to legal review and approval.

The Bobolink Foundation is a not-for-profit organization with a mission to advance conservation and stewardship of biodiversity through the protection of natural areas, education, and building local constituencies for nature.

Contract period: Date of execution through 12/31/2024, with one (1) five-year extension option to be exercised at the discretion of the General Superintendent

Fiscal Impact: The Forest Preserves may provide in-kind staff support for the planning, implementation, and monitoring of projects.

Request: Permission for the Forest Preserves of Cook County (the “Forest Preserves”) to enter into an Intergovernmental Agreement (IGA) with the MWRD

Goods or Services: Green Infrastructure grant for the repaving of a Forest Preserves parking lot in unincorporated Cook County, adjacent to North Riverside and Forest Park. MWRD will contribute the lesser of \$203,107.00 or 41.8% of the total construction cost, as a reimbursement to the Forest Preserves, for the Schuth’s Grove Parking Lot Green Infrastructure Retrofit project.

Summary: As part of its Green Infrastructure Partnership Opportunity Program, the MWRD proposes to contribute the lesser of \$203,107.00 or 41.8% of the total construction cost, to retrofit an existing access drive and parking area to the Schuth’s Grove forest preserve near the Des Plaines River to reduce direct discharge of stormwater runoff to the river, corresponding downstream flooding and improve water quality. The project includes replacement of approximately 36,900 square feet of existing asphalt with porous unit paving and upgrades to bio-retention areas in four (4) parking lot islands. An anticipated related project includes an accessible path to the existing picnic shelter and a new canoe launch to the Des Plaines River, to be funded in part by a separate boat access grant from the Illinois Department of Natural Resources.

The Forest Preserves is responsible for maintaining the project, including the permanent posting of required signage. In addition to the costs described above, the proposed agreement includes provisions that could result in additional future costs to the Forest Preserves that are unknown at this time. The MWRD shall have the right (including any necessary right of access) to conduct its own annual inspection of the constructed project. The Forest Preserves is required to comply with applicable standards or provisions in MWRD's Purchasing Act and Affirmative Action Ordinance, as well as MWRD's applicable labor requirements. The agreement also contains requirements with respect to MWRD's Veteran's Business Enterprise Contracting Policy. The final agreement is subject to legal review and approval.

Summary: In July 2012, state legislation authorized the Forest Preserves of Cook County (the “Forest Preserves”) to establish provisions to address the underuse of minority and women-owned businesses with respect to procurement contracts. An ordinance establishing the program’s parameters and guidelines was passed by the Forest Preserves of Cook County Board of Commissioners in September 2012. This initiative is significantly benefitting the residents of Cook County by increasing the pool of qualified minority and women-owned businesses that have the opportunity to be selected for contracts awarded by the Forest Preserves each year.

To remedy historic inequity and to facilitate greater inclusion, the Forest Preserves established aspirational contract goals for the participation of minority and women-owned as set forth under the ordinances that comprise the Forest Preserve District of Cook County Municipal Code.

The Minority and Women-Owned Businesses program accomplishments in FY 2019 include awarded contracts achieved 41% minority and women-owned businesses participation; and 43% of contract payments were made to minority and women-owned businesses either as prime contractors or sub-contractors.

The Forest Preserves participated in sixteen (16) outreach and workshop conferences, many in collaboration with various government entities. Also, in 2019, the Forest Preserves, in collaboration with Cook County provided monthly workshops to Minority and Women-Owned Businesses on how to do business with the government.
