PROPOSED RESOLUTION

HONORING THE FOREST PRESERVES COOK COUNTY FOR RECEIVING OF THE **PUBLIC NATURAL** AREAS **FROM** THE **AWARD CHICAGO** REGION TREE INITIATIVE'S URBAN FORESTRY AWARDS PROGRAM FOR ITS TREE PROTECTION AND PRESERVATION SPECIFICATIONS MANUAL

WHEREAS, in December 2020 the Forest Preserves of Cook County's *Tree Protection and Preservation Specifications Manual* (the "Manual") received the Public Natural Areas Award from the Chicago Region Tree Initiative's Urban Forestry Awards program which celebrates stewardship and advocacy for natural areas on public property; and

WHEREAS, the Forest Preserves' *Manual* is a document that is used to make land use and management decisions that make the preservation, protection, and maintenance of trees a top priority; and

WHEREAS, the development of the *Manual* was made possible in part through a 2018 Urban and Community Forestry Grant, administered by the Morton Arboretum and supported by the USDA Forest Service Urban and Community Forestry Program; and

WHEREAS, the Forest Preserves strives to protect an estimated 20 million trees representing nearly 200 species which provide numerous benefits to the residents of Cook County including cleaning air and water, reducing stormwater runoff, limiting erosion, and providing shade and beauty, while also offering food and shelter to thousands of species of wildlife; and

WHEREAS, this *Manual* supports the Forest Preserves' mission to preserve, manage and protect the public lands in its care and ensure that everyone in Cook County has access to healthy and beautiful nature and to the benefits that come with spending time outdoors; and

WHEREAS, the Forest Preserves recognizes that the nearly 70,000 acres of public land in its care face pressures from development both externally and internally, and this *Manual* helps plan for the protection of its trees and forests and ensure that construction contracts and license agreements consider how to protect and minimize harm to trees prior to and while work is being initiated; and

WHEREAS, through this *Manual* the Forest Preserves will be able to increase the survivability of protected trees, avoid damage to trees that are preserved on a site, and improve the coordination of construction projects to minimize conflicts with trees and new construction elements; and

WHEREAS, the *Manual*, developed in collaboration with various Forest Preserves departments, contractors, and partners, allows the Forest Preserves to evaluate land use requests thoughtfully, taking into consideration the short-, medium-, and long-term effects of development on trees and proposing mitigation strategies to limit the harm and destruction of trees that often accompany new development features; and

WHEREAS, the *Manual* allows the Forest Preserves to work with neighboring municipalities, contractors, stakeholders, and with its own staff to ensure it can respond to land use requests wisely and take into account the preservation, protection and maintenance of trees for the benefit of all who call this region home now and in the future; and

WHEREAS, the Manual helps advance the Forest Preserves' Natural and Cultural Resource Master

Plan, Next Century Conservation Plan, and Sustainability and Climate Resiliency Plan which all seek to ensure that the Forest Preserves' natural resources will continue to thrive for generations;

NOW, THEREFORE, BE IT RESOLVED, that Toni Preckwinkle, President, and the Forest Preserves of Cook County Board of Commissioners thank and congratulate the Forest Preserves and its Department of Resource Management for being recognized by the Chicago Region Tree Initiative's Urban Forestry Awards.

Summary: The Forest Preserves of Cook County (the "Forest Preserves") has identified two parcels of land for acquisition that would add to the Forest Preserves' current holdings near Glenwood Woods (the "Property"). The Property, commonly known as a portion of Glenwood Academy, Glenwood, Cook County, Illinois, consists of approximately 23.992 ± acres. The Property contains the confluence of Butterfield Creek and Thorn Creek, and the acquisition would bolster the Forest Preserves holdings near Glenwood Woods.

Through negotiations, the Owner of Record (the "Seller"), has agreed to sell the Property to the Forest Preserves for the sum of ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS AND 00/100 (\$125,000.00) plus closing costs up to \$10,000.00 (up to \$135,000.00 in total). The purchase price is based upon two (2) M.A.I. appraisals obtained by the Forest Preserves and is subject to the Forest Preserves' satisfactory completion of its due diligence.

Permission is now sought, upon satisfactory completion of all due diligence and negotiation of any and all required documentation as determined by the Forest Preserves Legal Department, to effectuate payment in the amount of the purchase price plus closing costs as full compensation for the acquisition of the Property.

This land acquisition advances the goals of the Next Century Conservation Plan.

PROPOSED ORDINANCE

AN ORDINANCE TO CREATE A FOREST PRESERVE NEAR GLENWOOD WOODS

AN ORDINANCE CREATING A FOREST PRESERVE in part of Section 4, Township 35 North, Range 14, East of the Third Principal Meridian, all in Cook County, Illinois near Glenwood Woods in District 6.

WHEREAS, the Board of Commissioners of the Forest Preserve District of Cook County, Illinois (the "District"), pursuant to the statutes in such case made and provided, has from time to time acquired by purchase, condemnation, gift, grant, devise, or otherwise, lands necessary and desirable for District purposes containing one or more natural forests or parts thereof, or lands capable of being reforested for the purpose of protecting and preserving the flora, fauna, and scenic beauties within the Forest Preserve District of Cook County, Illinois, and to restore, restock, protect, and preserve the natural forests and said lands together with their flora and fauna, as nearly as may be, in their natural state and condition, for the purpose of the education, pleasure, and recreation of the public; and

WHEREAS, the said Board of Commissioners of the District also has acquired in like manner lands for the consolidation of such preserves into unit areas of a size and form convenient and desirable for public use and economical maintenance and improvement, and lands for the purpose of connecting such preserves with forested ways or links in order to increase their accessibility, use, and enjoyment, and lands for improvement by forestation, roads, and pathways, and lands for the purpose of constructing, maintaining, and operating recreational facilities; and

WHEREAS, the Board of Commissioners of the District has in a like manner acquired lands along water courses or elsewhere which, in their judgment, were required to control drainage and water conditions and necessary for the preservation of forested areas acquired or to be acquired as preserves and lands for the purpose of extension of roads and forested ways around and by such preserves and for parking space for automobiles and other facilities not requiring forested areas but incidental to the use and protection thereof; and

BE IT ORDAINED by the Board of Commissioners of the District as follows:

Section 1. That a unified Forest Preserve be and the same is hereby created within the District which shall contain and connect lands now owned and lands to be acquired in substantial accordance with the plat now on file in the office of the General Superintendent of the District, which by reference is hereby made part thereof, and for the purposes of said Forest Preserve and for the carrying out of the statutory purposes more particularly set out in the preamble of this ordinance, it is necessary and desirable for the District to own and it shall acquire property hereinafter described in Section 2 of this ordinance, for the purpose of creating a Forest Preserve and for District uses.

Section 2. That the lands referred to in Section 1 of this ordinance are more particularly described as follows:

This dedication contributes to one of the key goals set forward in the Forest Preserves' Next Century Conservation Plan to dedicate and register 20,000 acres with the INPC. Dedication of a site as a nature preserve provides the highest level of protection for land in Illinois, and is granted only to natural areas of important natural or cultural significance.

The proposed Somme Prairie Grove Nature Preserve is an approximately 85-acre portion of the preserves located in the village of Northbrook in northeast Cook County. The site consists of high-quality mesic savanna and dry-mesic woodland that support a host of conservative native plant species and a rich assemblage of savanna and shrubland breeding birds. Somme Prairie Grove has benefitted from a vibrant stewardship community since 1980, and represents one of the oldest and most comprehensive savanna and woodland restorations in the Midwest.

The Forest Preserves of Cook County (the "Forest Preserves") currently has twenty-six (26) dedicated Nature Preserves and five (5) Land and Water Reserves. The addition of Somme Prairie Grove would bring the Forest Preserves' total INPC-protected lands to approximately 10,405 acres.

The Forest Preserves respectfully requests authority to submit Somme Prairie Grove to the Illinois Nature Preserve Commission for review and formal dedication and registration as a nature preserve according to the Illinois Natural Areas Preservation Act.

County

Report Period: N/A

Summary: This is the third of four (4) position papers prepared by the Conservation and Policy Council to provide guidance regarding key issues that face the Forest Preserves. These position papers continue an important legacy of civic leadership related to the Forest Preserves. In 1959, an Advisory Committee paper stated, "The Board has kept in mind the fact that the great holdings of the District are the property of all the citizens of Cook County and has refused to dissipate them for community, municipal or other purposes not in the interest of the general public," and that it takes "vigilance, effort and courage" to sustain and enforce these polices with firmness and resolution. This position paper reinforces and builds upon previous efforts. It recommends that the Forest Preserves prioritize nature-compatible recreation and oppose new uses that are not aligned with the Forest Preserves' mission. The paper also recommends that existing recreational programs and/or facilities that do not align with the Forest Preserves' mission and are not financially sustainable be transformed to natural spaces or re-purposed for nature-compatible recreation.

Upon approval of the position paper by the Forest Preserves of Cook County Board of Commissioners, the Forest Preserves shall take steps to implement the recommendations, including creating or revising policies, ordinances, and other documents as necessary, as well as obtaining any required board approval related to such actions.

Report Title: Restoration Status of Next Century Conservation Plan/Natural and Cultural Resources Master Plan Identified Priorities

Report Period: 2015-2020

Summary: This document presents a five (5) year status report on ecological restoration achieved between the years of 2015-2020 in pursuit of the Forest Preserves of Cook County (the "Forest Preserves") Next Century Conservation Plan ("NCCP") goal of restoring 30,000 acres to ecological health by 2040.

The report includes introductory and background information on the Forest Preserves' approach to meeting its land management goals, a set of maps that shows where important work has been accomplished, and descriptions of the preserves prioritized for restoration. These 30,000 acres are comprised of fifteen (15) priority landscapes, seven (7) Illinois nature preserves, and an additional set of thirty-eight (38) priority stewardship sites identified and ranked through the Forest Preserves' Natural and Cultural Resources Master Plan.

In the initial five (5) years since the NCCP's debut in 2014, the Forest Preserves have dramatically expanded the number of acres under restoration from 5,800 to 12,200 acres, which equates to 40% of our

priority lands under restoration. At our current pace and with appropriate funding, it is anticipated that our 30,000-acre NCCP goal can be achieved by 2035.

The work that has been achieved to-date is substantial and is critical to re-establishing healthy ecosystems for the benefit of the natural communities, plant and animal species, clean water, and long-term sustainability of our region.

EASEMENT REQUEST

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to grant permanent and temporary easements to Illinois Department of Transportation ("IDOT") at Rand Road and the Des Plaines River for 0.040 permanent and 0.044 temporary acres or 1,731 permanent and 1,916 temporary square feet.

Reason: IDOT has requested two (2) small permanent easement areas and two (2) small temporary easement areas on the south side of Rand Road between the Des Plaines River and the Des Plaines River Trail in Belleau Woods for relocation of a sidewalk and trail crossing by a few feet as part of a larger bridge and road infrastructure project. The project is proposed to improve aging bridge and road infrastructure, as well as improve pedestrian safety along Rand Road.

Structures proposed to be built on Forest Preserves land. IDOT proposes to relocate the sidewalk along the south side of Rand Road, placing it behind the guardrails, which will be moved immediately adjacent to the curb, to keep a barrier between vehicles and pedestrians. Additionally, IDOT is proposing to shift the alignment of the trail crossing at Rand Road a few feet south of its current location on both sides of the street.

The area for the permanent easement is 0.040 acres and the area for the temporary easement is 0.044 acres. The temporary easement is for a period of five (5) years. IDOT indicates that 0 trees are expected to be removed for this project.

Easement Fee: \$800.00, including \$500.00 for permanent and \$300.00 for temporary easements

Tree Mitigation Fee: N/A
