## **PROPOSED RESOLUTION**

## HONORING THE RETIREMENT OF SECRETARY MATTHEW BENIGNO DELEON

WHEREAS, Matthew Benigno DeLeon will be retiring as Secretary to the Forest Preserves of Cook County Board of Commissioners on July 31, 2021; and

**WHEREAS**, Secretary DeLeon served in local government for over 30 years, nearly three years with the City of Chicago and 28 years with Cook County, of which ten (10) of those later years were shared with service to the Forest Preserves; and

WHEREAS, Secretary DeLeon's family history reflects much of the Asian American contribution and perseverance of the 20th century. His parents were each part of two different waves of Filipino immigration that were essential to the Asian American experience. His father, Pedro DeLeon, landed in Port Angeles, Washington in 1928, finding work in canneries as a bus boy and on the American railroads which brought him to Chicago. He would go on to serve in the U.S. Army's all-Filipino Regiment which participated in the retaking of the Philippines during World War II. After returning to Chicago, he worked at the Old Post Office downtown until his retirement in 1975. Secretary DeLeon's mother, Rosal DeLeon, arrived in Jersey City, New Jersey and made her way to Chicago as part of a wave of Filipino nurses that came to this country from the 1950s to the 1970s. She moved from hospital nursing at Illinois Masonic, Thorek and others to become Director of Nursing at a succession of nursing homes on the north side and in Evanston, retiring in 1999; and

WHEREAS, Secretary DeLeon attended Dawes School, Martin Luther King Jr. Laboratory School and Evanston Township High School, graduating in 1987. Interested in government from a young age, he participated in the YMCA Youth & Government program becoming the Youth Mayor of Evanston in 1985 and Youth Governor of Illinois two years later, and was a United States Congressional Page the summer before his junior year of high school, sponsored by Congressman Sidney R. Yates; and

WHEREAS, Secretary DeLeon later attended and graduated from American University in Washington, DC in 1991 and DePaul University College of Law in 2009. Summers during college saw additional opportunities in government for him as an intern for Illinois State Representative Woods Bowman, an intern in the Illinois House of Representatives, and as an intern for the City of Chicago Commission on Asian American Affairs; and

WHEREAS, in 1991 to 1993, Secretary DeLeon's first full-time job was in Mayor Richard M. Daley's Office in the Mayor's Correspondence Unit. In 1993, as an Assistant to the Chief Administrative Officer, Matt became familiar with the County's Economic and Community Development efforts, Employment and Training Programs and the changes to the unincorporated areas through Zoning Board and Building departments. In 2006, he was appointed to the position of Secretary to the Board of Commissioners of Cook County. With the advent of the Health and Hospitals System Board in 2008, Matt became the first Secretary of that Board; and

**WHEREAS**, in 2010, Matt began service under his fifth County Board President, Toni Preckwinkle and in 2011, President Preckwinkle designated Matt to serve as Secretary to the Forest Preserves Board of Commissioners, becoming the first person to serve in both roles simultaneously for the two governments.

**NOW, THEREFORE, BE IT RESOLVED**, that the Forest Preserves of Cook County Board of Commissioners, on behalf of all the residents of Cook County and users of the Forest Preserves, do hereby congratulate Matthew Benigno DeLeon on a long, rich, and trailblazing career of public service. We thank Mr. DeLeon for his contributions to the Forest Preserves and express gratitude to Jubie and Gillian, his wife and daughter; and

**BE IT FURTHER RESOLVED**, that a suitable copy of this resolution be tendered to Mr. DeLeon in recognition of said contributions and dedication to a life of exemplary public service.

WHEREAS, July has been nationally recognized as Parks and Recreation month since 1985 to highlight the importance green spaces play a vital role in conservation, wellness and social equity efforts in communities; and

**WHEREAS,** green spaces and recreation areas are vitally important to establishing and maintaining the quality of life in our communities, ensuring the mental well-being and health of all residents, and contributing to the economic and environmental well-being of a community and the region; and

**WHEREAS,** the Forest Preserves of Cook County serves over five (5) million diverse residents across the Chicagoland area and local municipalities with an estimated sixty-two (62) million visits a year and surging interest in the last year a half; and

**WHEREAS**, the Forest Preserves of Cook County has served as a valuable resource to Cook County residents amid the COVID-19 pandemic as it provides opportunities for residents to escape and explore nature areas which provide a positive impact on their emotional, physical, and social wellbeing; and

## **PROPOSED RESOLUTION**

RESOLUTION CREATING THE FOREST PRESERVES' EQUITY, CULTURAL SENSITIVITY, AND INCLUSION SITE NAME TASK FORCE

WHEREAS, the Forest Preserves of Cook County Board of Commissioners (the "Board") and Forest

Preserves of Cook County (the "Forest Preserves") recognize that names are an important part of creating a sense of place and belonging and that names may have powerful and positive meaning for people and provide opportunities to promote community harmony; and

WHEREAS, this body approved Resolution 17-0178 on September 11, 2018 to officially recognize and adopt names of Forest Preserves Lands and Amenities after a staff Naming Committee recommended correct and official names of all venues, following an exhaustive review to determine which names had been formally adopted by the Board in the past, were in common use, or had been abandoned; and

WHEREAS, this body approved Resolution 19-0354 on September 24, 2019 to adopt a Permanent Naming Policy to help safeguard the Forest Preserves' prestige and heritage; provide guidance and direction in the naming and renaming of Forest Preserves properties, facilities, natural areas, and other public places; ensure an inclusive, consultative, and transparent naming and renaming process that will engage the public and stand the test of time; and to govern all permanent naming and renaming opportunities; and

WHEREAS, the Forest Preserves has a mission and values committed to being accessible and welcoming to all people and is seeking to ensure that sites do not commemorate an event or an individual whose actions perpetuated inequalities or supported the marginalization of people based on race, color, ethnicity, national origin, ancestry, religion, ability, gender, gender identity, or sexual orientation, or if the commemoration may be considered inappropriate or offensive; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Forest Preserves of Cook County Board of Commissioners does hereby create the Forest Preserves' Equity, Cultural Sensitivity, and Inclusion Site Name Advisory Task Force (the "ECSI Site Name Task Force") that will support the review of Forest Preserves site names and will advance the Forest Preserves' "Moving Towards Racial Equity" position paper adopted in July 2020 by this body; and

**BE IT FURTHER RESOLVED**, the ECSI Site Name Task Force shall meet as needed for one year and, with the assistance of Loyola University Chicago's Public History Program, shall, within one year, provide a report that includes 284 Forest Preserves site names that have been reviewed with a racial equity, cultural sensitivity and inclusion lens; and

**BE IT FURTHER RESOLVED**, the ECSI Site Name Task Force shall consist of the following members:

- a. The chair and vice-chair of the Board Real Estate Committee;
- b. The director and one additional faculty member from the Public History Program at Loyola University Chicago;
- c. One member of the Forest Preserves Conservation and Policy Council to be appointed by the chair of the Conservation and Policy Council;
- d. The two co-chairs of the Forest Preserves Naming Committee;
- e. Two members of the Forest Preserves Racial Equity, Diversity and Inclusion (REDI) Committee to be named by the General Superintendent;

- f. One member that sits on both the Forest Preserves' Naming and REDI Committees to be appointed by the General Superintendent;
- g. One representative from the Friends of the Forest Preserves to be appointed by the executive director of Friends of the Forest Preserves;
- h. One representative from the Illinois Environmental Council to be appointed by the executive director of the Illinois Environmental Council; and
- i. One representative from the Board or staff of the Forest Preserve Foundation to be appointed by the chair of the Forest Preserve Foundation Board of Directors; and,

**BE IT FURTHER RESOLVED,** that the chair of the Real Estate Committee and the appointee by the chair of the Conservation and Policy Council shall serve as co-chairs of the ECSI Site Name Task Force.

# PROPOSED INTERGOVERNMENTAL AGREEMENT

**Summary:** The Forest Preserves operates and maintains the Salt Creek Trail in Western Cook County. Western Springs proposes to construct a trail connection to connect users coming from Ogden Avenue to the trail. Western Springs will be responsible for design, construction and future maintenance costs associated with the project as well as payment of \$44,311.97 in tree mitigation fees. An estimated twenty-two (22) trees are proposed to be removed. The license fee, license application fee, and the YELAR fee will be waived, per the current usual practice for trail connection project requests from municipalities. There is no cost to the Forest Preserves. The IGA constitutes a license for Western Springs to construct and maintain the trail for thirty (30) years, followed by successive one (1) year automatic renewal terms until terminated by either party. Report Title: Independent Analysis of the Forest Preserves of Cook County Police Department

**Report Period:** 10/19/2020 - 4/27/2021

Summary: In 2020, the Forest Preserves of Cook County issued a Request for Proposals and retained Hillard Heintze to analyze the Forest Preserves Police Department and recommend best practices to: (a)

#### FPD Board of Commissioners

maintain and strengthen police and community relations, (b) create a work culture that is inclusive and equitable to all people, and (c) support a diverse police force through recruitment, retention and promotion. The independent analysis found that the Forest Preserves Police Department has a ready, willing and able workforce and that officers understand, appreciate and take pride in their department's mission to make the Forest Preserves a safe place. The consultants also report that permit holders and other stakeholders generally have positive impressions of Forest Preserves police officers. However, a number of actions are needed to improve recruitment and retention, update policies and procedures, and to improve communication across ranks. The final report recommends best practices and includes a work plan, timetable and cost estimates for implementing the best practices, as well as tools to measure progress toward those goals. These recommendations will build upon recent efforts by the Forest Preserves to enhance police and community relations by training members of the department on implicit bias, purchasing body-worn cameras for officers, and adopting the Ten Shared Principles developed by the Illinois Association of Chiefs of Police and the Illinois NAACP to guide the relationship between law enforcement and the community.

### **PROPOSED ORDINANCE**

OUTSIDE COUNSEL AND LEGAL FEES

**BE IT ORDAINED,** by the Forest Preserve District of Cook County Board of Commissioners that Chapter 19 of Title 1 of the Forest Preserve District of Cook County Code of Ordinances is hereby enacted as follows:

# A. <u>District Reports to Litigation Subcommittee</u>.

- 1. Notice of Monetary Counterclaims and Fee Requests. If the Forest Preserve District of Cook County is a party to any civil legal action in state or federal court, the District's Chief Attorney shall provide notice to the Litigation Subcommittee (as defined below) prior to a filing for monetary counterclaim, request for monetary sanctions, request for statutory reimbursement and/or request for fees in excess of \$50,000. If the Chief Attorney is unable to provide notice to the Litigation Subcommittee in advance of filing, the Chief Attorney shall inform the Chair of the Litigation Subcommittee in advance of filing and provide notice to the Litigation Subcommittee at its next scheduled meeting.
- 2. Settlement. The District shall request authority from the Litigation Subcommittee prior to settling any matter in excess of \$30,000. District attorneys shall provide a written settlement analysis and recommendation to the Subcommittee and shall be prepared to present that recommendation at a meeting of the Subcommittee. In addition, District attorneys shall provide the Litigation Subcommittee written information regarding cases anticipated to settle in excess of \$500,000 and shall place that informational item on the Litigation Subcommittee's agenda at least one month in advance of seeking authority to settle.
- 3. **Permission to Try**. The District shall obtain the approval of the Litigation Subcommittee prior to taking a matter to trial in state or federal court. When the District recommends that a civil matter proceed to trial, it shall provide a revised Case Summary (as defined below) and recommendation to the Litigation Subcommittee. The Chief Attorney shall be prepared to present that recommendation at a meeting of the Subcommittee. Prior to seeking the authority to bring a matter to trial, the District must present a revised Case Budget (as defined below) with the estimated cost of the potential trial to the Litigation Subcommittee for approval.
- 4. Appeals. The Chief Attorney must notify the Chair of any final and appealable ruling having a negative financial impact on the District in excess of \$50,000 in civil matters within 72 hours of the ruling. If an appeal may result in the imposition of accrued interest upon the District, the Chief Attorney must obtain authorization from the Litigation Subcommittee before pursuing the appeal. However, the District shall take all steps necessary to protect the interests and preserve the appeal rights of the District pending a decision to appeal, including the filing of appropriate post-trial motions or a notice of appeal when necessary. The decision to appeal must be approved by the Litigation Subcommittee.
- 5. **Exceptions**. The provisions of this Section shall not apply to litigation or settlements subject to the Illinois Workers' Compensation Act. (820 ILCS 305/1 *et seq.*)

# B. <u>State's Attorneys Forest Preserve District of Cook County Representation</u>

The District may engage Assistant State's Attorneys assigned from the Cook County State's Attorney's Office to represent the District in certain civil litigation matters at rates and terms set forth in the then-applicable intergovernmental agreement.

#### C. District Guidelines for Outside Counsel

- 1. **Short title.** This subdivision shall be known and may be cited as the "District Guidelines for Outside Counsel."
- 2. **Purpose.** The Forest Preserve District of Cook County may engage Outside Counsel to operate under the direction of the District's Chief Attorney or Responsible Attorney (see defined terms below).
- 3. **Definitions.** The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this Section, except where the context clearly indicates a different meaning:
  - *a.* Case Budget means the estimate of legal fees and expenses through the time of judgment or other completion including costs associated with the use of third-party vendors.
  - *b. Case Summary* means the report prepared by Outside Counsel and submitted to the Litigation Subcommittee that updates the Litigation Subcommittee on the progress and status of the case assigned to Outside Counsel.
  - *c.* Chair of the Litigation Subcommittee or Chair means the chairperson of the Finance Subcommittee on Litigation of the Forest Preserve District of Cook County Board of Commissioners.
  - *d. Litigation Subcommittee* or *Subcommittee* means the Finance Subcommittee on Litigation of the Forest Preserve District of Cook County Board of Commissioners.
  - e. Non-Contested Matter means any matter that requires legal analysis, but is not adversarial litigation.
  - *f. Outside Counsel* is a law firm or individual attorney engaged by the District to represent it in an assigned legal matter under the direction of a Responsible Attorney.

- g. Quarterly Status Reports means the written reports that update the status of the case, made in writing and submitted to the Chair of the Subcommittee on Litigation at least four times annually.
- *h. Responsible Attorney* is a designated staff attorney employed by the District.
- 4. **Applicability**. This Chapter shall apply to all Outside Counsel engaged by the District. All Outside Counsel who represents the District in multiple litigation matters, must comply fully with the terms of this Chapter for each separate matter of representation. No attorney may file an appearance in a lawsuit on behalf of the District unless they have been authorized by the General Superintendent, Chief Attorney or Responsible Attorney to file an appearance.

# D. <u>Case Management.</u>

- 1. **Case Management**. Each Outside Counsel who has filed an appearance on behalf of the District:
  - a. Shall submit a Case Budget and a Case Summary to the Litigation Subcommittee within thirty (30) days of their engagement or as soon thereafter as the Subcommittee meets, unless there is a conflict of interests in disclosing such information to the Litigation Subcommittee. This information and other communications between Outside Counsel and the Litigation Subcommittee shall constitute privileged and confidential attorney-client communications; and
  - b. Shall include in the Case Summary the major activities anticipated for a successful outcome of the case. The Case Summary shall also include estimates of potential liability, whether the case is appropriate for settlement, and the assessment of the probable outcome of litigation; and
  - c. Shall report any modifications or deviations to the initial Case Summary in Quarterly Status Reports to the Chair.
- 2. **Review of Case Summary and Budget**. The Subcommittee shall review the Case Summary and Budget. The Responsible Attorney is not prohibited from initiating legal activities reasonably necessary to adequately protect the legal interests of the District prior to the Subcommittee's review of the Case Summary and Budget.
- 3. Estimated Case Budget. The Case Budget shall include an estimate of legal fees and expenses through the time of judgment or other completion and shall allocate the fees and expenses associated with each phase.

4. **Workers' Compensation**. For claims subject to the Illinois Workers' Compensation Act, the Case Summary and Budget shall be submitted to the Finance Subcommittee on Workers' Compensation.

# E. Fees, Expenses, and Rates

- 1. Fees and Expenses. Outside Counsel shall be paid reasonable fees and costs based on the type and nature of the case. Such fees and costs shall conform to the fees and costs authorized under this Section. Outside Counsel must pay for all expenses in advance unless otherwise expressly directed by the court or the Chief Attorney or Responsible Attorney. Reimbursement of expenses shall be requested as part of Outside Counsel's invoices. Expenses shall be reimbursed as follows:
  - *a. Photocopying.* Reasonable photocopying at actual cost, not to exceed \$0.10 per page.
  - b. Messenger service. The use of messengers when there is a genuine need for expedited delivery at actual charges of a third-party vendor or, when an in-house firm messenger is used, at actual cost (not at the paralegal or legal assistant billing rate).
  - *c. Computerized research.* Actual costs of reasonably necessary computerized research services.
  - *d. Experts.* The reasonable fees of qualified consulting and testifying experts retained to provide opinions necessary to the defense or prosecution of the litigation, except that all expert fees must be pre-approved by the Chief Attorney if they are anticipated to exceed \$500.
  - e. Travel. Air travel expenses must not exceed the highest fare coach rate for the flight. Mileage expenses shall be at the Internal Revenue Service deductible rates. Hotels, car rental companies and airlines offering moderate prices and discounted corporate rates shall be used. Outside Counsel shall reduce the hourly rate charged by fifty percent (50%) while an attorney or paraprofessional is traveling, unless legal work is being performed and is documented.
- 2. General business costs. Law firm overhead expenses including, but not limited to, rent, electricity, supplies, secretarial and support services, computer system expenses, overtime expenses, local telephone service and other similar expenses, shall be considered part of the Outside Counsel's hourly rate.

- 3. Miscellaneous costs. Outside Counsel shall not seek reimbursement of fees for:
  - a. Preparing an invoice;
  - b. Conducting a conflicts check;
  - c. Entertainment expenses;
  - d. Food and beverages while working and/or hosting meetings;
  - e. Excessive staffing;
  - f. Work resulting from attorney error;
  - g. Purely clerical work;
  - h. Preparing an estimated Case Budget;
  - i. Court filing and appearance fees from which the District is exempt.

Under most circumstances, only one attorney should bill for attending court appearances, depositions, client conferences, and Litigation Subcommittee meetings. Outside Counsel shall seek prior approval from the Chief Attorney if the Outside Counsel seeks to have more than one attorney in appearance.

- 4. Invoices. Unless otherwise expressly directed by the court, Outside Counsel shall submit invoices for work performed on a periodic basis, no more frequently than monthly and no less frequently than quarterly. If the accumulated charges for the period are less than \$500, the charges shall be included in the next periodic invoice. The time spent performing the chargeable services shall be recorded on a daily basis to the nearest 1/10th of an hour and shall be broken down in detail, describing the work performed by each individual during that time period. Invoices shall contain the amount charged for each attorney and paraprofessional, including the time, the hourly rate and summary total for each. Invoices shall itemize expenses according to categories including the following: photocopying, messenger service, computerized research, experts and travel. Invoices shall be paid subject to the approval of the Litigation Subcommittee and the District Board of Commissioners. For Non-Contested Matters, invoices totaling less than \$5,000 per such matter may be approved at the discretion of the Chief Attorney.
- 5. Rate structure. The District expects Outside Counsel to take reasonable steps to minimize the amount of costs and disbursements charged to District matters, consistent with applicable time and responsiveness constraints. Outside Counsel shall bill for their services on an hourly basis in an amount not to exceed rates negotiated with and accepted by the District, but in no event shall rates exceed \$290 per hour per attorney and \$90 per hour per paralegal, without approval of the Litigation Subcommittee. Outside Counsel shall not bill for the use of law clerk(s) without prior authorization from the Chief Attorney. Outside Counsel may propose alternative fee structures such as blended, flat or contingent rate upon approval of the Litigation Subcommittee.
- 6. The provisions of this Ordinance shall supersede Forest Preserve District of Cook County Resolution 08-R-09.

7. To the fullest extent consistent with this Chapter, Outside Counsel shall adhere to any Billing Guidelines for Outside Counsel issued by the District's Legal Department, as published on its website and as may be amended from time to time.

# 8. Conflicts of Interests.

- *a. Modification of Guidelines.* There may be circumstances in which the District Guidelines for Outside Counsel requires modification. The Litigation Subcommittee shall examine these situations on a case-by-case basis and may modify the Guidelines accordingly for the course of that representation.
- b. Conflicts Check. Before rendering any legal services, Outside Counsel must conduct a conflict of interest review and provide the Responsible Attorney with a written list of all actual or potential conflicts of interest and matters that may present the appearance of a conflict.
- *c. Timely Notification.* Outside Counsel must provide the Responsible Attorney a written notice of any actual or potential conflicts or the appearance of a conflict within five (5) days of learning of the conflict.
- *d. Waiver.* Outside Counsel must be free of any conflict of interest under the rules of professional conduct unless the conflict is waived by the District.

# PROPOSED ORDINANCE AMENDMENT

# PARLIAMENTARY RULES

**BE IT ORDAINED**, by the Forest Preserve District of Cook County Board of Commissioners, that Sections 1-5-4, Subsection 4-1 of CHAPTER 5 - FOREST PRESERVE DISTRICT PRESIDENT AND BOARD OF COMMISSIONERS RULES OF ORGANIZATION AND PROCEDURE of Title 1 of the Forest Preserve District of Cook County Code of Ordinances is hereby amended as follows:

# **1-5-4: PARLIAMENTARY RULES.**

# 4-1. *Meeting*.

(a) The Board shall hold regular meetings pursuant to an annual calendar adopted by resolution of the Board.

(b) It shall be the duty of the President to call special meetings of the Board whenever such meetings are necessary in his or her opinion. The President must give no less than forty-eight (48) hours' advance written notice of such special meetings to the Commissioners and to the public.

(c) In the event that the President states that an emergency exists, the President may call a special meeting, providing twenty-four (24) hours' advance written notice to the Commissioners and to the public, unless not reasonable under the circumstances. In such case notice shall be given as soon as practicable. All emergency meetings shall be held at the County Seat, in the County Office Building, unless another place within the County shall be designated by the President or Board.

(d) Special meetings shall also be held whenever requested by at least one-third ( $\frac{1}{3}$ ) of the Commissioners (six (6) Commissioners). At least forty-eight (48) hours' advance written notice of such special meetings shall be given to the remaining Commissioners and the public.

(e) All notices of special meetings must include an agenda for such meeting, and such meeting shall be limited to the subjects and items specified in the call of the meeting. The notice of the call of the meeting shall be read at the beginning of the meeting.

(f) Special meetings shall be held at the hour of 10:00 a.m., unless another hour is specified in the call.

(g) All regular meetings shall be held at the County Seat, in the County Office Building, unless another place within the County shall be designated by the Board.

(h) A regular or special meeting may be cancelled by the President by providing no less than twenty-four (24) hours' advance written notice that said meeting has been cancelled to the Commissioners and to the public.

(i) Remote meetings. All public meetings of the Board and its committees and subcommittees may be conducted by means of electronic, video, audio, or telephonic connection ("remote meeting") for the duration of the Illinois Gubernatorial Disaster Proclamation, including any extensions thereto, related to COVID-19 or a public health crisis. A member who desires to attend and participate in a remote public meeting shall do so by the designated electronic means. For purposes of conducting a remote meeting, the terms "written", "in writing", "document", and "copy" in these rules includes printed or electronic means, and a rule that requires an instrument to be provided to the Board Secretary or a member or the meeting Chair may be satisfied by electronic transmission.

(j) *Remote Participation in Meetings.* At any meeting where a quorum of the body is physically present, a majority of the public body may vote to allow a member to participate and vote remotely (by audio or visual means) if the member is unable to be physically present due to:

1. A personal illness or disability;

2. Employment purposes or the business of the public body; or

- 3. A family or other emergency.
- 4. The member desiring to participate remotely gives notice to the Secretary of the Board no later than 24 hours prior to the meeting in case of personal illness or disability or employment purposes or business of the public body or as soon as practicable in the case of a family or other emergency.

Effective date: This ordinance amendment shall be in effect immediately upon adoption.
