PROPOSED INTERGOVERNMENTAL AGREEMENT

Summary: The Forest Preserves operates and maintains the Deer Grove Trails in Northwestern Cook County. Palatine proposes to construct a trail connection to connect users coming from the Dundee Road and Smith Street intersection to the trail. Palatine will be responsible for design, construction and future maintenance costs associated with the project. Three (3) trees are proposed to be removed during construction at a cost to Palatine of \$5,305.29. The license fee, license application fee, and the YELAR fee will be waived, per the Forest Preserves' practice for trail connection project requests from municipalities. There is no cost to the Forest Preserves. The IGA constitutes a license for Palatine to construct and maintain the trail for thirty (30) years, followed by successive one (1) year automatic renewal terms until terminated by either party. Summary: The County and the Forest Preserves entered into an Intergovernmental Agreement on 8/21/2012 authorizing the parties to perform various services for the other, in accordance with the Intergovernmental Cooperation Act. The parties agreed to provide various services and to provide reimbursement or payment for said services. The Intergovernmental Agreement was further amended on 4/25/2013, 6/18/2014, 9/8/2015, 11/15/2016, 6/6/2017, 4/25/2018, 9/26/2018, 2/21/2019, 10/22/2020 and 1/28/2021 to allow for additional cooperation. The Tenth Amended and Restated Intergovernmental Agreement consolidates the prior agreements into one Intergovernmental Agreement, so the parties can refer to one agreement, and this document also contains additional services and reimbursements for FY2022. This is a one-year agreement covering services and reimbursements from January 1, 2022 to December 31, 2022.

Summary: The IDNR and the Forest Preserves previously collaborated to design a water control and fish passage system connecting the IDNR-owned William Powers-Wolf Lake property to the Forest Preserves' Powderhorn Lake. Funding to complete the engineering design and construction for the project was obtained through a grant from Audubon via the National Oceanic and Atmospheric Administration (Board Item No. 20-0169 and Board Item No. 21-0451).

The proposed IGA will provide access and right of entry to the Forest Preserves and its authorized contractors for the construction, operation and maintenance of the portion of the water conveyance that traverses IDNR property. The IGA is also intended to facilitate: (1) reciprocal access by the IDNR and the Forest Preserves to each property for maintenance activities and invasive species removal, (2) installation of project signage at each property, (3) cooperative monitoring and enforcement of public access areas adjacent to the outfalls, and (4) cooperative biological monitoring of fish and other aquatic resources. This agreement calls for no direct cost to the Forest Preserves. Final agreement is subject to legal review and approval.

Purpose: Authorization is sought for the Forest Preserves to accept additional funding related to a previously-approved grant executed in partnership with Audubon via the National Oceanic and Atmospheric Administration for the purpose of finalizing the design, permitting, and construction of a water control and fish passage system at Powderhorn Lake in Chicago. Costs have exceeded the original grant amount; subsequently, Audubon wishes to contribute additional funding towards completion of the project.

Summary: On 5/1/2020, the Forest Preserves of Cook County Board of Commissioners authorized the Forest Preserves to accept a \$807,290.00 federal grant from Audubon via the National Oceanic and Atmospheric Administration to complete the design, permitting, and construction of a water control and fish passage system at Powderhorn Lake. The scope of the grant includes completion of the engineering design and construction of a water control/fish passage system to connect Powderhorn Lake to Wolf Lake, thereby restoring natural water levels to Powderhorn Lake and adjacent wetlands.

Engineering design and construction services were solicited and approved per Board Item No. 20-0170 and Board Item No. 21-0356, respectively. A majority of the project has already been paid for utilizing grant funding. Audubon is proposing to cover up to \$165,000.00 for additional remaining costs related to construction and final permitting.

Total project costs anticipated to be covered in full by the original grant amount in combination with the proposed supplemental increase are \$972,290.00. Work to-date and moving forward will be conducted at no direct cost to the Forest Preserves, which has provided in-kind staff support for the planning, implementation, and monitoring of the project.

PROPOSED PARTNERSHIP AGREEMENT

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into a Partnership Agreement with Openlands, Chicago, Illinois.

Reason: Openlands has received a \$400,000.00 grant from the Walder Foundation in support of ecological restoration and the build-out of a community-designed gathering space at Beaubien Woods. The project will involve a 20-acre prairie restoration on the west side of the access road to the Beaubien Woods boat launch, removal of 1 acre of invasive brush surrounding a connector path providing access from Carver Military Academy to Flatfoot Lake, and several off-site restorations intended to create access and preserve riverfront open spaces along the Little Calumet River.

The project's community-designed gathering space in Beaubien Woods is being designed by the Field Museum and a team of community curators with funding provided through the Illinois Coastal Management Program. The design is anticipated to be complete by the end of 2021 and is based on a regional model to create meaningful, long-term connections with natural places.

A majority of the work will be conducted on Forest Preserves property, at no direct cost to the Forest Preserves. This project builds on plans developed by the Forest Preserves, local communities, and several

other governmental organizations and nonprofits to create inviting and culturally relevant access to nature and the Little Calumet River in a way that fosters a healthy community.

PROPOSED PARTNERSHIP AGREEMENT

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into a Partnership Agreement with 2110 44th Road, LLC d/b/a Bee All About It, Villa Park, Illinois.

Reason: Bee All About It, located in Cook County, is a local company engaged in many aspects of beekeeping. Since early 2021, Bee All About It has maintained approximately eight (8) beehives at the River Trail Nature Center on a volunteer basis. The hives are primarily occupied by honeybees which cohabitate well in the environment with native bees and other pollinators. The Forest Preserves now seeks to formalize its relationship with Bee All About It. Under the proposed partnership agreement, Bee All About It will continue to manage the hives and will be reimbursed by the Forest Preserves up to \$1,000.00 annually for supplies purchased in connection with the hives and beekeeping, not including the bees. Additionally, Bee All About It will collect, bottle and sell the honey from the hives, paying ten (10) percent of the sales revenue to the Forest Preserves. Bee All About It will also provide classes and workshops related to bees, pollinators and beekeeping to Forest Preserves visitors at the River Trail Nature Center.

Contract Period: 10/5/2021 - 10/31/2024 with two (2) one-year extension options to be exercised at the discretion of the General Superintendent.

PROPOSED AGREEMENT

Vendor: Wireless EDGE Towers II, LLC, Rhinebeck, New York

Request: Requesting authorization for the Forest Preserves of Cook County (the "Forest Preserves") to enter into an agreement

Reason: The Forest Preserves desires to engage a Communication Tower Manager to perform certain marketing, site evaluation and development, sublicensing, revenue collection, and other related site management services related to the use of Forest Preserves property by the commercial wireless telecommunication industry.

To accomplish this goal, the Forest Preserves issued a Request for Proposals for permitting, site development, preparation, erection, installation, and maintenance of a small footprint, self-supporting, stealth communication tower and related cellular telephone communication equipment at multiple sites. Wireless EDGE Towers II, LLC ("Wireless Edge") was deemed to be the most responsive out of two (2) total respondents.

Under the proposed contract, Wireless Edge will market space for wireless carriers to install antennae on

cell towers at locations that have been preapproved by the internal Forest Preserves Land Use Committee. Wireless Edge then intends to subsequently enter separate, twenty-five (25) year license agreements with the Forest Preserves, subject to approval of the Forest Preserves Board of Commissioners, for the construction of the cell towers at preapproved locations. The towers will be owned by Wireless Edge. Wireless Edge will pay revenue to the Forest Preserves under both the proposed agreement and any future licenses for individual sites. Wireless Edge will receive compensation directly from carriers through sublicense agreements to be negotiated between the carriers and Wireless Edge. Wireless Edge will oversee construction and installation by its contractors and sublicensees, and will have access to the designated sites twenty-four (24) hours per day, seven (7) days per week.

The terms, conditions, and procedures of the Forest Preserves' licensing ordinances found at Title 5 (Public Utilities) and any other applicable licensing provisions of the Forest Preserves Code of Ordinances may be waived in whole or in part by the Forest Preserves with respect to the proposed agreement. The Forest Preserves would enter into the proposed agreement not in its regulatory capacity but in its proprietary capacity as a market participant. In the highly regulated arena of wireless communications, however, state and federal law may in some instances supersede contractual provisions with respect to the wireless facilities once installed.

Wireless Edge will indemnify the Forest Preserves for any claims arising from its performance of the agreement and will maintain insurance policies naming the Forest Preserves as an additional insured. The proposed agreement cannot be unilaterally terminated by the Forest Preserves without cause.

Summary: Caldwell Woods is part of the Caldwell Preserves, one (1) of twelve (12) priority gateway sites that are the focus of planning and improvements to welcome visitors and improve access and wayfinding. Planning meetings in 2015 identified the need to activate and repurpose the existing Caldwell Woods Warming Shelter into a year-round facility. A \$1.2 million grant from the Illinois Department of Natural Resources (IDNR) Park and Recreational Facility Construction Grant Program (PARC) will provide 75% of the estimated cost to convert the building to a "Welcome & Wellness Center" and improve access, landscaping and information signage.

WHEREAS, in 2020, the Forest Preserves of Cook County issued a Request for Proposals and retained Hillard Heintze to analyze the Forest Preserves Police Department and recommend best practices to: (a) maintain and strengthen police and community relations, (b) create a work culture that is inclusive and equitable to all people, and (c) support a diverse police force through recruitment, retention and promotion; and

WHEREAS, the final report of the Independent Analysis of the Forest Preserves of Cook County Police Department from Hillard Heintze was presented to the Forest Preserve District Law Enforcement Committee on September 21, 2021, which recommended best practices and includes a work plan, timetable, and cost estimates for implementing the best practices, as well as tools to measure progress toward those goals; and

WHEREAS, the report outlined 21 recommendations needed to improve recruitment and retention, update policies and procedures, improve communication across ranks, and enhance police and community relations; and

WHEREAS, one of the key findings is that the Forest Preserves Police Department has a ready, willing and able workforce capable of helping transform the Department into a model police force; however, although those employees interviewed as part of the report are willing to help improve the Department internally, as well as its external relationships, many are concerned that change will not happen once the assessment concludes, and indicated that they have seen previous efforts to assess the Department or effectuate change, that were curtailed or failed to result in meaningful changes; and

WHEREAS, to ensure that the report recommendations are adhered to, and that the Forest Preserve District recognizes the importance of establishing an aggressive timeline to implement said recommendations and to report back to the Forest Preserve District Board of Commissioners on progress being made towards achieving said recommendations;

NOW, THEREFORE, BE IT RESOLVED, that the Forest Preserve District of Cook County Board of Commissioners does herby request that the Forest Preserve District outline and deliver a detailed timeline for all elements needed to achieve the goal of a Model Forest Preserve Police Department as recommended in the Independent Analysis of the Forest Preserves of Cook County Police Department; and
