Summary: Cook County is a recipient of the Edward Byrne Memorial Justice Assistance Grant ("JAG") Program funding from the United States Department of Justice through the Chicago Police Department. Pursuant to a Memorandum of Understanding with the City of Chicago ("Chicago/Cook MOU") the County has been allocated a portion of the 2018 JAG Grant. The County wishes to subaward a portion of the 2018 JAG Grant to the Forest Preserves for the purchase two (2) specially equipped K-9 squad vehicles to be used to transport two (2) search and rescue canines (bloodhounds). The vehicles are needed to satisfy the primary jurisdiction of the Forest Preserves of Cook County's Police Department which consist of approximately 70,000 acres of undeveloped property. The addition of the K-9 squad vehicles will ensure the safety and comfort of the canines and allow the Forest Preserves Law Enforcement to better assist in counter-terrorism efforts when police canines are required. The final agreement is subject to legal review and approval.

The Forest Preserves Board of Commissioners previously approved the following: (1) the Forest Preserves’ receipt of a sub-award grant from Cook County for the prior purchase of a K-9 vehicle (Agenda No. 18-0409) and, (2) the Forest Preserves’ receipt of a sub-award grant from Cook County for the prior purchase of a canine (Agenda No. 19-0362). The final agreement is subject to legal review and approval.
