PROPOSED RESOLUTION

AMENDING RESOLUTION 17-0021 - FOREST PRESERVE DISTRICT COMMITTEE CHAIR ASSIGNMENTS

WHEREAS, the Board of Commissioners (the "Board") of the Forest Preserve District of Cook County (the "Forest Preserve") adopted resolution 17-0021 establishing the <u>President Pro Tempore</u>, Chairs, Vice-Chairs, and number of members of the Standing Committees and Subcommittees of the Forest Preserve District Board; and

WHEREAS, the Forest Preserve Board now wishes to amend its previous selection of <u>President Pro Tempore, Chairs</u>, <u>and vVice-cChairs</u>
